SUBJECT: SHOW CAUSE NOTICE.

1. Whereas, on being accorded sanction for your appointment under SRO-43 as Follower, in terms of Govt. of J&K Home Department Order No. 292-Home of 2021 dated 15.11.2021 read with PHQ J&K communication No. Pers-A-134/2011/65608 dated 15.11.2021 and subsequent your further adjustment in this unit vide APHQ Order No. 1016 of 2021 dated 22.11.2021, for issuance of your formal appointment order as Follower subject to fulfillment of pre-requisite formalities, after getting verification of credentials/testimonials etc., you were provisionally appointed as Follower vide this office Order No. 28 of 2022 dated 20.01.2022 and you joined the department on the same date i.e. 20.01.2022.

2. Whereas, you are under probation for two years in terms of Jammu and Kashmir Special Recruitment (Amendment Rules 2020) issued vide notification dated 1st of June 2020 read with S.O 194 and yet to be confirmed.

3. Whereas, on your further deployment in F-Coy of this unit, on the pretext of having some urgent work at your home, you succeeded to get (5+2) days casual leave and proceeded to avail the same on 09.04.2022 vide DD report No. 09 of F-Coy daily diary and were due to report back for duties on 17.04.2022 FN after expiry of leave period, which you failed and overstayed further, as a result your absence from leave stand recorded in F-Coy daily diary vide DD report No. 04 dated 17.04.2022 FN.

4. Whereas, on your failure to resume duties after expiry of leave period and thereby overstaying further, you were informed by Coy Commander F-Coy of this unit vide his office signal No. F-Coy/235 dated 02.05.2022, informing therein to resume your duties, which you delayed too and continued your absence at large scale, as such you were again informed vide this office signal No. Estt/IRP-10th/8031 dated 04.05.2022, followed by Coy Commander F-Coy signal No. F-Coy/251 dated 09.05.2022, to resume your duties, but you turned deaf ears towards these communications and overstayed further without any intimation or showing any cause of not resuming your duties.

5. Whereas, pursuant to APHQ J&K Order No. 321 of 2022 dated 19.04.2022 followed by Range Police Headquarters, Anantnag Order issued under No. Estt/Foil-Trade Allowance/7447-55 dated 30.04.2022, you were requisite to attend Trade test at this APC Mattan on 12.05.2022, to this effect vide this office signal No. Estt/Trade/IRF-10th/22/256 dated 11.05.2022, your presence for the said purpose was sought from Coy Commander concerned, but in response of which your Coy Commander vide his signal No. F-Coy/IRP-10th/259 dated 11.05.2022 communicated this headquarters that you are running absent from leave since 17.04.2022.

6. Whereas, vide this office signal No. Estt/IRP-10th/8591 dated 11.05.2022, you were informed through concerned Police Staion to resume your duties and to attend the said Trade test, but you did not responded the said communication to and continued your absence at large scale.

7. Whereas, on your prolonged absence despite of making several correspondence either by your Coy Commander or by this office, you were placed under suspensio vide this office Order No. 232 of 2022 dated 23.05.2022 and a departmental enquiry into your conduct has been ordered to be conducted by the nominated Enquiry officer.

8. Whereas, the nominated enquiry officer inform you through concerned Police station vide his office communication No. F/288 dated 24.05.2022, followed by No. 318 dated 12.06.2022 and latest No. 286 dated 21.06.2022 to resume your duties and to face the departmental enquiry, but you couldn't pay any heed/attention towards these communication, as neither you resumed your duties nor anything has been heard from your end, regarding your whereabouts and well being regarding.

9. Whereas, as per communication of I/C PP Sherbagh vide No. Nil dated 21.06.2022 you have been properly informed from time to time on the aforesaid communication. To resume your duties by the said Police Station, but you still failed to resume your duties.

10. Whereas, on your total failure either to resume your duties or to showing the cause of non-resumption of duties despite of having been informed by a chain of communications, it reveals that you are not interested to serve the department anymore.
