CRIME REPORT**3 arrested with 50 Kg Trillium Govanianum****STATE TIMES NEWS**

HANDWARA: Police on Monday arrested 3 persons along with an endangered trillium govanianum medicinal herb in Qalamabad, Handwara. As per details, a party from Police Station Qalamabad at a checkpoint established at Lach Qalamabad, intercepted a vehicle (JK09-2155) with 3 persons onboard, who were identified as Shafiq Ahmad Khan, son of Ali Mohd & Reyaz Ahmad Khan, son of Aziz Rehman Khan, both residents of Mankal and Jameel Ahmad Mir, son of Gh Mohd, resident of Chak Sanzpora.

During search, police recovered endangered medicinal herb Trillium Govanianum (local name Tri Patri) weighing around 50 Kg from their possession. They were arrested and shifted to police station where they remained in custody. The vehicle used in the commission of crime was also seized. Accordingly, FIR No. 39/2022 under relevant sections of law was registered at Police Station Qalamabad and investigation started.

JAMMU: Three persons got killed in separate mishaps on Monday.



JAMMU: Two persons died under mysterious circumstances on Monday.




