RAMBAN: Police on Tuesday rescued 28 bovines at Navyuga Tunnel and arrested a smuggler.

As per the details, acting on the specific inputs regarding the transportation of the bovines to the valley, a party of Police Post Jawahar Tunnel intercepted one Truck (JK03D-7802) driven by a person namely Juguan Shah, son of Mohd Iqbal Shah, resident of Sherbibi, Chamalwas, Banihal loaded with 28 bovines, all the rescued bovines were found loaded with utmost cruelty and without any arrangements of food and water. These bovines were being transported to the valley without permission of competent authority. On this a case, FIR No 134/2022 under section 188 IPC, 11 PCA Act was registered and investigation set into motion.


