found to be in contact with terrorist commanders based in Pakistan, the officials said.

They said some of the terrorist commanders these individuals were in contact with, and who are based in Pakistan, include Sajad Gul, Ashiq Nengroo, Arjumand Gulzar and others. They all have been notified and designated as terrorists by the Ministry of Home Affairs under the Unlawful Activities Prevention Act.

These terrorist handlers who are based in Pakistan are involved in serious terror crimes and as well motivating and inciting the young gullible boys to join terror ranks to commit terror crimes, the officials said.

J-K Police -- both in Kashmir and Jammu division -- have raided the residences and work places of such people and investigations with regard to the level of their involvement are underway, they said.

Raids have been carried out at several places across the union territory including in Srinagar, Baramulla, Anantnag, Kulgam -- in the valley, and in Jammu, Ramban, Udhampur, Kathua - in Jammu region, they added.

Many target killings and other terrorist crimes have been instigated from across using local hybrid terrorists. As on today, dozens of suspected have been picked up across J-K, the officials said.

They said Director General of Police (DGP), J-K, Dilbag Singh has passed unambiguous and very strong directions to all formations that anyone found in touch with any such entity in Pakistan or in any other country should be taken to task.

The policy of zero tolerance of such anti-national activity has to be more strictly imposed, the J-K police chief has directed.

Director SKPA Udhampur is declared equivalent in the rank and status to that of Additional Director General of Police , till it is held by the aforesaid officer," reads an order issued by R.K. Goyal, Financial Commissioner/Additional Chief Secretary, Home Department.

"Further, in terms of Rule 3 of the Lieutenant Governor of the Union territory of Jammu and Kashmir's Special Security Force Rules, 2020, the post of Director, Special Security Force (SSF), J&K, is temporarily upgraded and declared equivalent in the rank and status to that of Deputy Inspector General of Police from June 4, 2022," it stated and added, "Consequent to this, Shakti Kumar Pathak, IPS, shall be deemed to be working as Director, SSF (I/C DIG) with effect from June 4, 2022, till further orders."

### Plea in SC...

August 15, 1947.

The plea, filed by a retired Army officer, has challenged the constitutional validity of sections 2, 3, and 4 of the 1991 Act claiming that they violate the principles of secularism.

While section 3 of the Act deals with the bar of conversion of places of worship, section 4 pertains to the declaration as to the religious character of certain places of worship and the bar of jurisdiction of courts.

By making the impugned Act, Centre has arbitrarily created an irrational retrospective cut-off date, declared that character of places of worship shall be maintained as it was on August 15, 1947, and no suit or proceeding shall lie in court in respect of disputes against encroachment done by barbaric invaders and lawbreakers and such proceeding shall stand abated, said the plea, filed through advocate Ashwani Kumar Dubey.

In his plea, petitioner Anil Kabotra has claimed that the Centre has transgressed its legislative power by barring remedy of judicial review which is the basic feature of the Constitution.

The petition alleged that the injury caused to the Hindus, Jains, Buddhists, and Sikhs is extremely large because sections 2, 3, and 4 of the 1991 Act have taken away the right to approach the court and thus, the right to judicial remedy has been closed.

It said the Centre neither can close the doors of courts of the first instance, appellate courts, constitutional courts for aggrieved Hindus, Jains, Buddhists, and Sikhs, nor take away the power of High courts and Supreme Court, conferred under Article 226 and 32.

It claimed that the Act has barred the right and remedy against encroachment made on religious places of Hindus, Jains, Buddhists, and Sikhs.

The plea has sought to declare that sections 2, 3, and 4 of the 1991 Act are void and unconstitutional for allegedly being violative of Articles, including 14 (equality before law), 26 (freedom to manage religious affairs), and 29 (protection of interests of minorities) of the Constitution, in so far as it legalises the ancient and historical places of worship and pilgrimage, illegally occupied by the barbaric foreign invaders .

It said while enacting the Act, the Centre has excluded the birthplace of Lord Ram at Ayodhya but not the birthplace of Lord Krishna in Mathura, though both are the incarnations of Lord Vishnu.

Several other pleas, including the one filed by BJP leader and advocate Ashwini Upadhyay, challenging the validity of certain provisions of the 1991 Act has already been filed in the apex court.

Recently, the Muslim body Jamiat Ulama-i-Hind has filed a plea in the top court seeking intervention in a pending petition which has challenged the constitutional validity of sections 2, 3, and 4 of the 1991 Act.

Jamiat Ulama-i-Hind has said that petitioner Ashwini Upadhyay has raised grounds that have already been considered and decided by the constitution bench of the top court.

Even if all the allegations of the petitioner are assumed to be true, it is nothing but seeking a correction of historical wrongs, the Muslim body has said.

The top court in March last year had sought the Centre's response to a plea challenging the validity of certain provisions of the 1991 law, which prohibit the filing of a lawsuit to reclaim a place of worship or seek a change in its character from what prevailed on August 15, 1947.

The petition has alleged that the 1991 law creates an "arbitrary and irrational retrospective cut-off date" of August 15, 1947, for maintaining the character of the places of worship or pilgrimage against encroachment done by "fundamentalist-barbaric invaders and law-breakers".

officer who has retired in the rank of Air Marshal or Air Chief Marshal but has not attained the age of 62 years on the date of his appointment," the notification issued under the Air Force Act 1950 said.

It further said that the government may extend the service of the Chief of Defence Staff for such a period as it may deem necessary subject to a maximum age of 65 years.

Identical notifications were issued under the Army Act 1950 and the Navy Act 1957.

The tenure of three service chiefs is three years of service or when they turn 62, whichever is earlier.

In effect, the retired Chiefs of the Army, the Navy and the Air Force are unlikely to be considered for the post of the CDS as the age to become eligible for the post has been put at 62 years.

On January 1 2020, Gen Rawat took charge as India's first CDS with a mandate to bring convergence in the functioning of the Army, the Navy and the Indian Air Force and bolster the country's overall military prowess.

Another key mandate of the CDS was to facilitate the restructuring of military commands for optimal utilisation of resources by bringing about jointness in operations, including through the establishment of theatre commands.

A high-level committee set up to examine the gaps in India's security system in the wake of the Kargil war in 1999 had recommended the appointment of the CDS as a single-point military adviser to the defence minister.

To cater to the needs of litigating employees of the newly created UTs, the 19th bench of the CAT at Srinagar was inaugurated on November 23, 2021 by Minister of State for Personnel Jitendra Singh.

The bench at Srinagar presided over by D S Mahra, judicial member, started functioning physically from the very same day -- November 23, 2021.

"The bench has since disposed of a sizeable number of cases received on transfer from the J&K High Court, as also fresh cases instituted by the employees, the statement said.

security forces. It exceeds the performance of the current tactical UAS platforms in most services in difficult terrains and urban environments all over the world, representatives of the company that has manufactured the drone said on Tuesday.

"Between Russia and Ukraine, they (some countries) are flying theses drones in that area (the battle zone). It will undergo a test trial on the LaC in Ladakh in July," Kushagra Agrawal, vice-president, Roter Precision Instruments Private Limited, the firm that has manufactured the drone, told PTI.

Giving further details, he said the "Vector and Scorpion" drone was introduced last year and was recently showcased at the North Tech Symposium 2022 at the Army's Northern Command headquarters in Jammu and Kashmir's Udhampur, drawing a huge response from the officers of various formations of the armed forces.

"It is the first drone that has a telemetric range of 65 kilometres. For example, if I am sitting in Udhampur, the drone can give me live feed from Jammu," Agrawal said.

"No other Indian company can give you a 65-kilometre range," he added.

Officials said it is an IP 66-rated drone. "That means it can fly during a drizzle. It can fly when it is snowing. It has already been tested 5,000 metres above the ground level. That makes it a fool-proof drone," Agrawal said.

The drone is being used by the US Marine Corps, the French police and the

German police.

The officials said the mathematical definition of a vector fits very well for the latest UAV from Quantum-Systems. "It can face any direction -- upward, forward or down. That is exactly what the Vector from Quantum-Systems is capable of doing. A vertical take-off, energy efficient, long-range, fixed-wing flight and back to a vertical landing. All automatic, no pilot or operator input needed, just fly," an official said.

The Vector 2-in-1 vertical take-off reconnaissance UAV is flexible and enduring, provides flight and surveillance characteristics that exceed the performance of the current UAV platforms in service all over the world.

The officials said the ability to operate in the most difficult terrain (VTOL), combined with extremely low noise emission (motor off, silent mode) makes the Vector the perfect UAV for a wide range of non-invasive aerial operations.

"An encrypted mesh IP link sends video streams up to a range of 15-plus kilometres. A flight time of up to 120 minutes speaks for itself. All combined in a compact and robust electric VTOL UAV," the official said.

The two-in-one system design opens up further applications with the "Scorpion" configuration -- by removing the wings and attaching a separate set of copter arms, a dedicated multi-copter platform becomes available for an even wider variety of mission applications -- the officials said.

"Either use a VTOL fixed-wing or a conventional copter, in both cases you only need one system to train on and to deploy it on site," an official said.

The officials said the drone gets "mission ready" in less than two minutes.

"The payload and all the general parts have the quick-lock mechanism without the need of any tools. It is a fibre-reinforced airframe with a shock-absorbing landing gear," an official said.

have reached 4,49,483, officials said.

The COVID-19 death toll stands at 4,752. No Covid-related fatality was reported in the last 24 hours, they said. There were 51 confirmed cases of mucormycosis (black fungus), officials added.

Meanwhile, Ladakh has reported one fresh COVID-19 case that pushed its tally to 28,272, officials said. The latest case was detected in Leh, they said.

The death toll remained unchanged at 228 -- 168 deaths from Leh and 60 from Kargil. There are seven active COVID-19 cases in Ladakh. So far, 28,038 patients have recovered from the viral disease in the union territory, the officials said.

The Food Safety and Standards Authority of India began the State Food Safety Index evaluation process for 2021-2022 by undertaking correspondence with Food Safety Commissioners of all UTs and states and setting a deadline of May 10, 2022 to furnish the data for statistical evaluation. The critical indicators are Human Resource, Compliance Levels, Food Testing Infrastructure and Surveillance, Training and Capacity Building and Consumer Empowerment. The award has been conferred after examining the necessary facts sought from Food Authorities.

The initiatives of J&K department towards implementing Eat Right Campus have been acknowledged at the apex level with appreciation. The enforcement staff of UT certified 143 Food Business Operators including restaurants, hotels, bakery shops and others under Hygiene Rating Scheme initiated by FSSAI by engaging independent auditors duly approved by the said Authority. Besides, 02 Eat Right Campus, 03 BHOG (Blissful Hygienic Offering to God) were among the Institutions which were covered during the said initiative.

In order to sensitize the Food Business Operators, 87 training programs were organized under FoSTaC. About 21,000 Education Institutions were brought under the ambit of Eat Right School Initiative to inculcate the concept of Food Safety among future generations. Besides, 1250 teachers and students have been certified as Health and Wellness Coordinators by FSSAI to help spread the message among students regarding importance and relevance of Eat Right, Eat Healthy and Sustainable Food towards building a healthy nation. In order to promote the concept of Food Fortification, 127 awareness cum educative workshops were organized at District Head Quarters across the UT with active support and participation from FSSAI. Commissioner has attributed the award to selfless and committed efforts put in by the functionaries of the department who have been empowered to perform statutory duties under FSS Act, 2006 Rules and Regulations 2011, in the UT. ## Man kills father in Ramnagar

JAMMU: A 28-year-old man murdered his father Tuesday following an argument over some issue in Udhampur district, police said.

As per the details, one Gopichand, son of Dhunichand, resident of Kaghote, Ramnagar was attacked with hammer by his son namely Joginder Kumar at his home in the wee hours of 7th June after some altercation, the body was kept at home and the accused fled away from the spot after committing the crime.

After receiving an information police rushed at the Scene of Crime and took body in their custody, collected all the evidences from scene of crime, dead body was shifted to Hospital Ramnagar for postmortem. After completing all legal formalities, body was handed over to his family for last rites.

During investigation Police team of Police Station Ramnagar led by SHO Ramnagar under the supervision of SDPO Ramnagar Dr. Bhishm Dubey acting swiftly carried out rigorous searches in Ramnagar and adjoining areas , arrested the accused involved in this crime. On the disclosure of the accused, the weapon of offence was also recovered.

Citing preliminary investigation, the official said Kumar was said to be a drug addict and was involved in frequent quarrels with his family.

BARAMULLA: Acting tough against the anti-social elements, Police on Tuesday busted a gang of burglars/car lifters by arresting five persons involved in various cases in Baramulla.

As per the details, during the course of investigation of cases FIR Nos 267/2021, 72/2022, 85/2022, 86/2022, 88/2022, 90/2022 and 93/2022 of PS Baramulla, Police arrested five persons involved in the commission of crime. They have been identified as Baber Bashir Bala son of Bashir Ahmad resident of Krankshun Sopore, Sahil Ahmad Kaloo son of Farooq Ahmad resident of Takyabal Sopore, Waseem Ahmad Chatbali son of Bashir Ahmad resident of Sheer Colony Sopore, Irfan Ashraf Bhat son of Mohd Ashraf Bhat resident of Fatehpura Baramulla and Mohd Iqbal Bandy son of Gh Mohammed Bandy resident of Sangri Baramulla.

On their disclosure several stolen vehicles and other stolen items have been recovered from their possession. Preliminary investigation reveals that the said gang of car lifters are committing crimes in an organized way by assigning duties to each of its member viz, Baber Bashir Bala was assigned task of lifting/stealing vehicles from different parts of valley, Sahil Ahmad Kaloo disassembled these vehicles into parts and further dispatching to Waseem Ahmad Chatbali who was assigned of sending these parts to outside UT of J&K.

Moreover, burglar Irfan Ashraf Bhat was involved in theft of power cord (Electric wire) in newly constructed residential houses at Gulnar Park & Kralhar. Stolen property electric wire has been also recovered.
