
SHRADHANJALI



CRIMEREPORT

Narco smuggler nabbed with heroin

JAMMU: Continuing its drive against drug trafficking and substance abuse, police on Sunday nabbed a narco smuggler and recovered 5 grams of heroin from his possession.

As per details, a team of Police Post GMC led by SDPO West Vikram Singh assisted by SHO Bakshi Nagar Inspr Rakesh Sharma and In-Charge Police Post GMC PSI Vijay Thakur while on patrolling duty when reached near new Emergency gas plant of GMC rounded up a suspected person. During search, 05 grams of heroin was recovered from the accused later identified as Mudasir Hussain, son of Jaffer Hussain, resident of Bhadrawah, Doda. The accused was arrested and FIR No.85/2023 under sections 8/21/22 NDPS Act was registered against him at Police Station Bakshi Nagar.

5 vehicles involved in illegal mining seized
