The Lt Governor passed explicit directions for the Camp in-charge and concerned officials for operationalization of Sheshnag and Panjtarni camp by 20th June.

It must be ensured that the Track is through for ponies, Pithoos from Chandanwari to holy cave well before the commencement of the Yatra, he said.

The Lt Governor set the deadline of 20th June for the completion of various works including snow clearance at MG Top, Panjtarni and other such areas; completion of emergency landing platform at holy cave; boundary walls, safety railing on vulnerable stretches; water supply and installation of RO in every camp.

Power supply and illumination in every camp should be done by June 17th. Health facilities and availability of health equipment should be ensured. SoP by the Health Department to be made operational at each camp, the Lt Governor told the officials. The Lt Governor directed the KPDCL and Jal Shakti department for engaging skilled manpower and day-to-day monitoring of water and power logistics.

The Lt Governor emphasized on involvement of members of the PRIs and Civil society in successful conduct of Shri Amarnathji Yatra.

We must learn from the challenges of last year and take comprehensive measures accordingly. All the concerned departments, CAPFs, J&K Police, Army and other stakeholders should work in close coordination for making best arrangements to ensure smooth pilgrimage. A feedback on tracks from civil administration, Security forces should also be taken, he added.

Work on the Steel girder bridges will be completed well before the commencement of the Yatra, it was informed.

The Lt Governor directed the officials to lay special focus on Sanitation, Quality of tents, fire extinguishers and ensure adequate gaps during installation of tents. No unauthorised tent should be installed. Strict enforcement of SOPs and guidelines must be ensured near holy cave, he added.

The Lt Governor directed the Irrigation and Flood Control department to complete the Nallah works by June 25th

Instructions were also passed pertaining to installation of LED at various locations with pre-recorded messages and information dissemination, upgradation of Signages and information boards, besides ensuring strong telecom and mobile connectivity.

### CUET 2023: Students...

has taken strenuous efforts for implementation of Common University Entrance Test (CUET) for the academic session 2023, following the guidelines outlined in the National Education Policy (NEP) 2020, and Government's commitment to inclusivity. A total of 87309 (Eighty-seven thousand three hundred nine) unique candidates have been registered from the UT of Jammu and Kashmir for the CUET (UG) 2023. The examination centres were randomly allocated based on availability of requisite infrastructure within the geographical boundaries of J&K and the exam dates were announced by the National Testing Agency. However, some students were allotted centres outside the UT of J&K.

Taking cognizance of the peculiar situation and resentment against the same at the time of scheduled G-20 event in Kashmir after the intervention of Lieutenant Governor, Manoj Sinha, NTA deferred the CUET (UG) examination for the students of J&K and implemented a centre reallocation process exclusively for J&K students and issued new dates for conducting the examination. Further, in order to save the travel and logistical challenges faced by students while appearing for CUET (UG) 2023 in the examination centres located outside the UT of J&K, the department augmented the requisite infrastructure in the shortest possible time. After a thorough examination, it has come to the notice of the department that some students from Jammu division, after reallocation of centres were still allotted centres outside the UT of J&K and had discrepancies in the examination dates in cer-

tain subject combinations. Allaying the fears of the students community in this regard, Principal Secretary HED assured that sufficient opportunity would be given to such candidates for admission in the undergraduate programmes in various Degree Colleges of the UT based on their merit in the 12th class examination.

Dr Mehta said that the time has come to assess overall preparations vis-à-vis future readiness of J&K. He observed that the technology holds the key to create J&K happier and progressive in the times ahead.

Providing the details the Commissioner Secretary, IT, Prerna Puri informed the meeting that out of 303 services guaranteed under PSGA, J&K has already integrated 103 services with the Auto-appeal system. She also gave out that the additional 122 services would be integrated with this auto-escalation mechanism in the days to come. She further said that the remaining services would be taken on-board over this platform before end of the month.

She also apprised the meeting that besides the RAS the Department is soon going to offer people to give their valuable feedback through IVRS. She also revealed that the auto-appeal system would be having a dedicated dashboard to give insight about the status of timely delivery of services.

It was given out that the 'Mobile Dost' App, a reliable mobile friendly version of all the online services with additional features like services related to Tourism, travel, jobs, weather news updates etc would be launched by the end of this month so that people of J&K are able to carry government offices in their pockets in real sense.

It is also important to look at the entire UN ecosystem and what can be done to improve it, he said.

"One important reform that stares us in our faces is to make UN decision-making bodies, including the United Nations Security Council (UNSC), more reflective of demographic realities of the world," the defence minister said.

The UNSC currently has five permanent members -- China, France, Russia, the UK, and the US -- and 10 elected non-permanent members who serve two-year terms. India completed its tenure as a non-permanent member of the Council in December last year. Only a permanent member has the power to veto any substan-

"When India, the most populous nation of the world, does not find a seat as a permanent member of the UNSC, it tends to undermine the moral legitimacy of the UN. Therefore, the time has come for making the UN bodies more democratic and representative of the current realities of our age," Singh added.

Later, the Defence Ministry issued a statement saying India has a rich legacy of contribution to UN Peacekeeping operations.

"Time has come to expand the UN Security Council with India as a permanent member," the defence minister was quoted as saying in the statement.

India's Permanent Representative to the UN Ruchira Kamboi in April had said that India is right in demanding a "major course correction" of the UNSC when the world's largest democracy is kept out of the global decision making.

India has been at the forefront of the years-long efforts to reform the Security Council, saying it rightly deserved a place as a permanent member of the United

In his address, Singh expressed gratitude to all Indians who have served or are currently serving as UN peacekeepers under the blue flag.

India is one of the largest contributors of troops in UN Peacekeeping. It has contributed approximately 2.75 lakh troops to peacekeeping missions so far, with around 5,900 troops currently deployed in 12 UN missions, the statement said.

Singh commended the role of UN peacekeeping operations and explained the enthusiastic global support for such missions through the economic concept of "externalities"

When there is a conflict, it is harmful to the directly involved actors. Moreover, it has negative externalities for those involved indirectly. There is a plethora of negative externalities that have emanated out of the recent Russia-Ukraine conflict. It has led to food crisis in various African and Asian countries and has fuelled an energy crisis in the world," he said.

A conflict at a particular place or region creates "ripple effects" which adversely impact the whole world. So, the rest of the world becomes a stakeholder in resolving the conflict and to restore peace, Singh added.

"This is because peace has positive externality. When conflicting parties restore peace, they benefit in terms of human lives saved, higher economic growth achieved, etc. The rest of the world also benefits as peace fosters stability and encourages economic growth," the defence minister said.

Singh added that "positive externality of peace and negative externality of war drives the UN, along with the responsible nations, to act towards resolving any conflict" and this action is manifested in terms of deployment of UN peacekeeping missions in conflict zones.

"Our courageous soldiers, police personnel and civilian experts have demonstrated exceptional dedication and unwavering commitment to the cause of peace," he said.

"They have selflessly served in some of the most challenging and dangerous environments, embodying the spirit of peacekeeping and upholding the principles enshrined in the UN Charter. Their unwavering commitment, professionalism and sacrifices inspire us all," he said.

Singh extended his condolences to the families who have lost their loved ones in the line of duty. He called for honouring the sacrifices of the peacekeepers by building a more just, peaceful and inclusive world.

"Let us renew our commitment to promoting dialogue, understanding and cooperation among and within the nations. Together, we can build a future where every individual can live in peace, harmony and with dignity," he added.

Chief of Defence Staff Gen Anil Chauhan, Army Chief Gen Manoj Pande, several senior officials of the Army, and defence attaches from various embassies here were also present on the occasion.

In his opening remarks, Gen Pande highlighted India's contribution to the cause of UN Peacekeeping.

#### HC rejects bail of wife in murder case STATE TIMES NEWS

JAMMU: The Jammu & Kashmir and Ladakh High Court rejected the bail of Nano Devi who killed her husband Sohan Lal.

The case set up by the prosecution is that on 16.06.2021 Police Station Bani eceived an information/written complaint from one Sanjay Kumar S/O Gian Chand R/O Bani with regard to the missing of his brother Sohan Lal since 01.06.2021 and that he had specific information from one Radha Krishna with one Kewal Kumar one of the accused) killed his brother. During the course of investigation, police arrested the said Kewal Kumar and upon his confession before police arrested other accused namely, Ramesh Chander, Nano Devi (applicant) and Kamlesh Singh alleged to have hatched a conspiracy for killing deceased Sohan Lal, husband of the applicant. It was further alleged in the prosecution story that applicant Nano Devi was having illicit relationship with accused Ramesh Chander, which came to the notice of the deceased Sohan Lal. As such, applicant Nano Devi and accused Ramesh Chander planned the murder of deceased Sohan Lal in connivance with other accused Kamlesh Singh and Kewal Kumar. It is the case of the prosecution that applicant Nano Devi and Ramesh Chander, due to their illicit relationship, exeuted their plan by providing poison to accused Kamlesh Singh and Kewal Kumar who administered the same to the deceased by mixing in alcohol and when deceased became unconscious, they tied his body and threw into a gorge.

Justice MA Chowdhary after hearing Adv Tarun Sharma for the applicant whereas Deputy AG Dewakar Sharma for the UT, observed that It is not a case where the murder would have been committed at the spur of the moment, rather the applicant/accused has been alleged to have planned the execution of murder with three other persons to eliminate her husband, just to keep her relations with her paramour who is also one of the accused. The story as projected by the prosecution is that on having a plan for murder of the deceased, the accused administered him poison through alcohol and then threw him into a gorge to ensure that he is killed. Therefore, it seems to be a cold blooded murder under a well thought plan and the kingpin of this plan is the wife of the deceased i.e. applicant herein. Since the case is based on circumstantial evidence, it will not be safe to admit the application to bail as she may tamper with the prosecution evidence and it would be difficult for the prosecution to get the links of the circumstantial evidence to prove the case against any of the accused, if the prosecution witnesses, are either way get influenced by any means. Since many of the witnesses of the prosecution are witnesses to the circumstances and until they are examined, it will not be safe to admit the applicant to bail. The prosecution witnesses who are shown as circumstantial evidence, in the considered opinion of this court, are required to be examined before the plea of the applicant is considered again by the Trial Court. Having regard to the aforesaid discussion and reasons, this application is found without merit and substance and is liable to be rejected at this stage. The application is, therefore, dismissed.

#### Religious, political leaders in Kashmir object to '72 Hoorain' ■ STATE TIMÉS NEWS

SRINAGAR: Decrying the negative portrayal of Muslims in the upcoming film "72 Hoorain", slated to be released next month, prominent religious and political leaders

in Kashmir on Tuesday said the movie "hurts the sentiments" of the community. Directed by Sanjay Puran Singh Chauhan and co-produced by Ashoke Pandit, the ilm will be released in Indian theatres on July 7. It features Pavan Malhotra and

Aamir Bashir in the lead. "It is totally controversial and hurts the sentiments of the people, especially Muslims. We are not going to accept this title. Even this film needs to be banned and those who are producing these types of films should understand that such movies are against amity and brotherhood between the communities," Grand Mufti of Jammu and Kashmir Nasir ul Islam told PTI.

Islam said he will convene a meeting on this "very sensitive issue".

"We don't want this controversy to spread and we are going to take up this matter with the government of India. All Muslim organisations will be taken in confidence

Chairperson of Jammu and Kashmir Waqf Board Darakshan Andrabi, a BJP eader, said the movies are works of fiction aimed at minting money. "Life is not about films and writers, it is their way of doing their work and making

noney out of it.... In order to make things viral, the filmmakers make things in such way," Andrabi said. She said such films "would not affect our lives or our country. In order to under-

stand the context of the film completely first we need to watch the film. Ashok Kaul, BJP general secretary, said naming the film as '72 Hoorain' should not hurt the sentiments of people.

"I believe whatever is happening should not happen and exaggerating this thing

should not be encouraged as well," he added
