WALNUT WEEVIL

Symptoms

The symptoms appear as emergence of large holes in the trunks and branches of the infected plants. The adult weevils feed on petioles, floral buds, tender shoots and even on young fruits.

Leaves and fruits are damaged by weevils during June-July. Fall of nuts to the extent of 50-60 per cent observed. Branch and tree dieback is indicated by wilting and drying of leaves.

Management:

Cultural:

- Proper sanitation should be maintained.
- Collection and destruction of fallen nuts during the month of June prevent build-up the pest populations.

Chemical:

- Clean the holes with iron nails and insert the cotton dipped with kerosene/petrol and plug it with mud.
- Plants can be sprayed with chlorpyrifos 20 EC @ 2ml in 1 liter of water to get effective result.
