1. That, you were deployed in C-Coy of this unit stationed at PHQ/APHQ Complex Jammu and was performing PSO duties with Inspector Sarabjeet Singh No ARP986538 (Coy 21/C) and found unauthorised absent in the evening roll call on 03.11.2021 along with your service Rifle/Ammunition (AK-47 & 30 rounds) Accordingly, you were marked absent in the Daily Diary of C-Coy yide DDR No 11 dated 03.11.2021 at 1830 hours.

2. That, on 06.11.2021, SHO Police Station Arnia vide his Signal No. 1599/5-1/PSA dated 06.11.2021 has intimated that you were involved in case FIR No. 77/2021 U/S 302/307 IPC 3/25, 4/25 Arms Act of P/S Amia. Subsequently, you were placed under suspension vide this office order No. 548 of 2021 dated 06.11.2021 for your involvement in heinous crime.

That, as intimated by Superintendent District Jail Jammu you were lodged in the District Jail Jammu on 24.11.2021 in above said case and facing trial before the Hon'ble court of 1 Additional Session Judge Jammu. During the course of trial you were released on interim bail on 13.10.2023 by the omers of the Hon'ble

Court which was extended till 27.10.2023. 4. That, you projected another application for extension of bail which was dismissed on 30.10.2023 by the Hon'ble Court. According to interim bail order you were
