CAT further directed that this action shall be completed within a period of two months from the date of receipt of a copy of this order.

The Applicant joined J&K Police as Sub-Inspector on November 12, 1990 in armed wing of J&K Police and in-situ Promotion was granted in favour of applicant in the rank of Sub-inspector after completing nine years service.

The applicant was promoted as inspector on March 31, 2000 vide PHQ J&K letter no 972 of 2000 dated March 31,2000. The applicant again got 2nd Insitu promotion in rank of inspector w.e.f April 1, 2009 vide PHQ J&K order 2107 dated June 26, 2010. On July 20, 2012, the applicant was promoted as In-charge Dy. SP in his own pay and grade vide Govt order No. Home 625 (P) of 2012 dated July 20, 2012 and was not confirmed as the matter remained hanging imbalance and on the request of home department vide Dy Secretary letter dated November 4, 2020, Director General of Police, PHQ J&K fur nished vigilance clearance and integrity certificate, in his Favour with a recommendation of regularisation of the applicant as Dy. SP to the home department which is evident from letter dated December 22, 2020 along with Govt order dated July 20, 2012.

CAT after hearing both the sides observed that the undisputed facts of the case are that the applicant was promoted as In-charge Deputy Superintendent, Jammu & Kashmir Police vide order dated July 20, 2012. While working in the Jammu & Kashmir Police the applicant had joined the honorary post of Joint Secretary in the Jammu & Kashmir Cricket Association for which he was paid 12,000/- per month on account of conveyance The applicant retired after attaining the age of superannuation on May 31, 2021. After his retirement, an inquiry was conducted in pursuance of a complaint made by one Desl Rattan Dubey that the applicant had accepted full-time assignment of Joint Secretary Jammu & Kashmir Cricket Association in different spells between 2003 to 2016. During the inquiry, the allegations levelled against the applicant was found to be correct and sub sequently, vide order dated November 16, 2022, it was ordered by the respondents that the amount which the applicant has drawn as remuneration from Jammu & Kashmin Cricket Association shall be deducted from his pension, in terms of Article 168-A of Jammu & Kashmir Civil Services Regulations, 1956. As per the applicant, he has been punished twice for the same offence in as much as the respondents intend to recover the amount that was paid to him when he was holding the honorary post of Joint Secretary Jammu & Kashmir Cricket Association, from his pension and on the other hand, the respondents have also not taken any action for confirming his promotion as Deputy Superintendent of Police, for which he was completely eligible. CAT further said that we do not find any infirmity with the order dated November 16, 2022 whereby the remuner ation paid to the applicant from Jammu & Kashmir Cricket Association has been ordered to be deducted from his pension. However, since the applicant has already been punished by ordering recovery from his pension, now the applicant cannot be put to double jeopardy by not considering his case for regularization of his promotion as Deputy Superintendent of Police. In view of the above discussions and the fact that the applicant has joined and worked in Jammu and Kashmir Cricket Association without having permission of the competent authority and this action of the applicant is contrary to the rules and regulations. Therefore, CAT dismissed this Original Application and uphold the action of the respondents of recovering the remuneration received by the applicant from Jammu and Kashmir Cricket Association, from his pension. The action of the applicant is irregular but not illegal, therefore it is not appropriate to penalize him twice, therefore, the respon dents are directed to consider the case of the applicant for regularization of his promotion as Deputy Superintendent of Police w.e.f. the date he was entitled to be promoted on this post along with his other counterparts, along with a grant of Selection Grade Deput Superintendent of Police with all consequential benefits. This action shall be completed within a period of two months from the date of receipt of a copy of this order.

Theft case solved, accused arrested

STATE TIMES NEWS GANDERBAL: Ganderbal Police on Friday solved a theft case by arresting the accused person involved in the commission of crime. "On June 15, 2024, Police Station Kangan received a written complaint from Sub-Divisional Manager BSNL Ganderbal mentioning therein that some unknown persons have stolen 24 batteries from BSNL Tower at Mamar

during the intervening night of June 14/15, 2024. In this regard, a case FIR No. 49/2024 under relevant sections of law was revistered at Police Station Kancan & further investi gation was taken up," police spokesperson said. During the course of investigation spokesperson added, a special team led SHO Police Station Kangan under the supervision of SDPO Kangan was constituted. While checking the technical evidences & CCTV footage, a suspicious vehicle (Tata Mobile) was spotted near the scene of crime, spokesperson said adding that while verifying the details of the aforesaid vehicle, the investigating team apprehended one person namely Nazir Ahmad Dar, son of Sonaullah Dar, resident of Rakh-e-Highgam Sopore A/P Pushwari Naidkhai along with the aforesaid Tata Mobile vehicle bearing registration number JK05M-0894. During questioning, spokesperson said, the accused person confessed his involvement in the commission of the crime & disclosed that he along with his associates have jointly committed the crime. He also confessed that they later sold the stolen batteries to one scrap dealer at Sopore. Accordingly, all the 24 stolen batteries were recovered and seized two vehicles viz Mahindra Mobile bearing registration No. JK05M-0894 and Maruti car bearing registration No. JK05B 5388, which were used in the commission of crime, spokesperson said adding that further investigation is going on & more arrests are expected.

Cyber Cell Samba refunds defrauded amount of Rs 74,196

SAMBA: Cybercrime Investigation Unit of Police in district Samba on Friday refunded defrauded amount of Rs 74,196 in an online financial fraud reported by the complainant. "A complainant namely Hari Om, son of Nattho Singh, resident of District Bharatpur, Rajasthan at present 122 CISF Company, DPL Samba submitted a writ ten application regarding online financial fraud of Rs 74,196 in which fraudster cheated him by installing third-party mobile app. i.e Flipkart via phishing link," police spokesperson said. The team of Cybercrime Investigation Unit under DySP Hqrs Samba headed by Inspector rank officer displayed relentless efforts and advanced technical skills, leading to the successful refunding all the defrauded amount of Rs 74,196 to the complainant, spokesperson said adding that further investigation is going on. It is pertinent to mention here that a total defrauded amount of Rs 4,84,106 has been

SAMBA: Samba Police on Friday apprehend three individuals for offense against religious sentiments. "On June 27, 2024 around 1820 hrs, it was learnt through reliable sources that some person informing desecration of a cattle carcass lying in the general area of Ward 08, Triloke Di Chapri, Samba," police spokesperson said. Immediately, a case FIR no.176/24 got registered at PS Samba under relevant sections, spokesperson said adding that a special team headed by DySP Hqrs Samba was constituted along with SHO PS Samba and investigation was taken up. Police team reached on spot and took the same into custody. Using technical and physical aid, several suspects were zeroed in and were questioned. Meanwhile, two persons namely Rohit and Ajay, resident of Samba were apprehended and were put to sustained questioning. Upon this, they disclosed that they were hired by Rajan Sambyal, son of Jagdev Singh, resident of Garh Mandi, Samba to dispose off the body of his deceased cow. As a result, few body parts of cow carcass came

into the notice of public thus hurting the religious sentiments of a particular community. Further, all three persons have been detained and legal proceedings have been initiated under law, spokesperson said. Moreover general public is appealed not to fall prey to any kind of rumour mongering and desist from spreading any such content which can hurt the sentiments of public at large and has the potential of causing disturbance
