Asked about the JD(U)'s demand for a review of the 'Agnipath' scheme, Paswan quoted Modi as saying in the NDA meeting on Wednesday that he was open to suggestions from allies on different issues. "He, in fact, encouraged us to speak," the young parliamentarian said, without commenting directly on the issue

"There is anger among voters on the (short-term army recruitment) Agnipath scheme. Our party wants those shortcomings to be removed," JD(U) spokesperson K C Tyagi told reporters earlier.

Senior BJP leaders met at the party's national president J P Nadda's residence in what was seen as part of the party's exercise to reach out to allies over issues like their share of ministerial berths and pick the probables from within their party for the coalition government.

Preparing to take oath for a third straight term as the head of a coalition government, Modi on Wednesday chaired a meeting of the ruling alliance's members who manimously elected him as its leader.

Leaders of the BJP's ally Janata Dal (United) also held deliberations with party president and Bihar Chief Minister Nitish Kumar.

The regional party is looking to get some key ministerial berths to reclaim the lost ground in Bihar where it has performed well after being seen to have fallen way behind the BJP and the RJD over the last few years in political strength.

With 12 MPs, the JD(U) is the second biggest BJP ally after the Telugu Desam Party which has 16 parliamentarians. The new BJP-led government will depend critically on these two parties for survival.

BJP leaders are in touch with allies over ministerial berths and other issues.

Naidu is keen for the Centre to provide Andhra Pradesh financial assistance in ouilding its capital in Amravati. He also wants the new government to take steps to fulfil the Centre's commitment to the state when Telangana was carved out of it, sources said.

on March 16 till the counting of votes on June 4, was 82. Polling in the world's piggest election exercise was held in seven phases beginning on April 19.

The model code of conduct is a set of conventions agreed upon by all stakeholders and imposed during elections. Its objective is to keep the campaigning, polling and counting process orderly, clean and peaceful and check any abuse of state machinry and finances by the party in power.

While poll code does not enjoy any statutory backing, the Supreme Court has apheld its sanctity on several occasions. The Election Commission is fully authorised to investigate any violation of the code and pronounce punishment.

The poll code finds its origin during the 1960 assembly elections in Kerala when the administration tried to evolve a code of conduct for the political parties. The code has evolved over the last 60 years to assume its present form.

According to the Election Commission of India, the model code of conduct states that the parties in power at the Centre and in the states should ensure that they do not use their official position for campaigning.

Ministers and other government authorities cannot announce financial grants in any form. No project or scheme that may have the effect of influencing the voter in favour of the party in power can be announced, and ministers cannot use official machinery for campaign purposes when the poll code is in effect.

Increase in cut off, toppers reflect NEET's competitive nature; its integrity not compromised: NTA

NEW DELHI: The National Testing Agency (NTA) on Thursday clarified that the increase in cut off and number of toppers in the NEET-UG reflect the competitive nature of the exam and maintained that the test's integrity has not been compro-

The clarification came amid allegations of irregularities in medical entrance exam NEET (National Eligibility-cum-Entrance Test) -- conducted on May 5 at 4,750 centres in 571 cities, including 14 abroad -- and inflation of marks. "The increase in cutoff reflects the competitive nature of the examination and the

higher performance standards achieved by the candidates this year," a senior NTA "The number of candidates who appeared in 2023 was 20,38,596 while the num-

ber of candidates who appeared in 2024 increased to 23,33,297. The increase in candidates naturally led to an increase in high scorers due to a larger pool of candidates," the official added. On the grace marks awarded to some students, the NTA said a few petitions were filed by the NEET-UG before the high courts of Punjab and Haryana, Delhi and

Chhattisgarh raising concerns of loss of exam time during the conduct of the test at some exam centres "The concerns raised by the candidates through the writ petitions and representa tions about loss of examination time was ascertained and 1.563 candidates were compensated for the loss of time, and the revised marks of such candidates vary from -20 to 720 marks. Amongst these, the score of two candidates also happens to

be 718 and 719 respectively due to compensatory marks," the official added. On analysing CCTV camera footage, it was ascertained that the integrity of the

examination was not compromised, the official asserted.
