Implementation of PMAY-Urban scheme reviewed in Srinagar Dist

SRINAGAR: In order to review the implementation of PMAY(Pradhan Mantri Awas Yojana)-Urban scheme in District, a meeting was held under the Chairmanship of the Deputy Commissioner(DC) Srinagar, Dr. Bilal Mohi-Ud Din Bhat on Thursday here at Meeting Hall of the DC Office Complex.

Besides, Additional Deputy Commissioner, Syed Ahmad Kataria and Chief Planning Officer, Fayaz Ahmad Dar, the meeting was attended by Chief Executive Officer, UDAK Srinagar, Assistant Commissioner Revenue, Deputy General Manager, Housing Board, Tehsildars, SLT/CLT Experts and other concerned. At the outset, the Deputy Commissioner took a detailed review of the physical and financial status of the PMAY- Urban cases identified and approved in District Srinagar.

On the occasion, the Deputy Commissioner was informed



that as many as 3245 PMAY-Urban cases were sanctioned in District Srinagar out of which 3100 have been Geo-tagged. Besides, 1728 cases are at the construction stage, while 1517 cases are completed.

He was further informed that payments in favour of 852 cases have been disbursed as on date.

Speaking on the meeting, the DC directed concerned to put up the list of 463 re-verified eligible cases with concerned higher authorities for the approval in time bound manner.

He directed them to expedite the processing of existing cases while verifying individual cases as per the checklist by Revenue authorities,

Housing Board Officers and Ward Officers on ground.

While reviewing the financial status of PMAY-Urban scheme in District, the DC directed Officers to ascertain the status of pending bills submitted for disbursement of installments to beneficiaries.

He maintained that if the status is not available then the bills should be submitted afresh for approval through District level committee subjected to condition of verification.

Meanwhile, the DC directed the concerned to delist those cases which fall under the Revenue authority of District Budgam but are somehow enlisted within Srinagar Municipal area.

The instant notice is being issued for the convenience of prospective bidders who shall be participating in the e-auction notified for allotment of 14 retail liquor vendes (off-premises) for sale of liquor for the year 2024-25 in the Union Territory of Jammu and Kashmir. The details of these 14 locations of liquor vendes alongwith Minimum Guaranteed Quota (MGQ) and Minimum Guaranteed Revenue (MGR) per vend and Minimum Reserve Bid price is given in Annexure-A to the J&K Excise Policy for the year 2024-25 notified vide S.O 85 Dated 1st of February, 2024 under Endorsement No. FD-ET/122/2021-03 Dated 01-02-2024 by the Finance Department Government of Jammu & Kashmir (GoJK) and bid document issued vide No. 58-EC of 2024 Dated 01-02-2024 under Endorsement No. EC/Exc/e-auction/2024-25/7181 Dated 01-02-2024 and approved by Finance Department vide Letter No. FD-ET/7/2023-03 Dated 01-02-2024.

2.

These 14 vendes shall be allotted during the Policy year 2024-25, subject to fulfillment of eligibility conditions as per Bid Document and J&K Excise Policy 2024-25. These vendes shall sell, in retail, to the public under one roof JK-special Whisky/JK Country Liquor and Indian made foreign liquor including imported foreign liquor/beer/wine/cider/RTD which are permitted to be sold by the Excise Department, J&K

Re-auction for allotment of vendes shall be done through the J&K Bank Ltd. on e-auction portal i.e. <https://jkexcisedept.auctiontiger.net> in a completely secure and transparent manner. The detailed procedure for re-auction/instructions to the bidders shall be available on the e-auction portal and on the official website of the department i.e. www.jkexcise.nic.in. The schedule of starting and closing of online bids for each location is given in the Annexure to this notice. All licenses issued through re-Auction shall determine on 31-03-2025 irrespective of date of issuance.

The Minimum Reserve Price bid for each of these 14 liquor vendes shall be as per Annexure-A given in the Excise Policy 2024-25. The bidders can bid in increments of Rs. 50000/- (Max 10 lacs) beyond the Reserve Price. In case afresh Highest H1 bid is received within 5 minutes before the scheduled closing time of bidding, the time for re-auction shall be automatically extended by another 5 minutes beyond the scheduled closing of the particular bid. A maximum of five such extensions shall be allowed, during which the bid increment shall be Rs.1,00,000/- (Max Rs.20 lacs).
