It is notified for the information of all concerned that:

- The candidates shown in Annexure-A (Jammu Division) and Annexure-B (Kashmir Division) in this Notification have been shortlisted for interview based on their merit in the OMR-based written exam held on 16.03.2025 (Kashmir Division) & 17.03.2025 (Jammu Division) for the posts of Junior Assistant in the District Judiciary of J&K, pursuant to Advertisement Notification No. 06 of 2024/Pay dated 28.08.2024.
- The interviews for shortlisted candidates will commence from 23rd June 2025 (Monday) at the High Court Complex, Jammu, Jammu Division, and at the High Court Complex, Srinagar, Kashmir Division. The exact date and venue for the interviews are provided in Annexure-A and Annexure-B, respectively.
- The reporting time for the interview shall be 9:00 AM.
- The candidates shall have to bring proof of identity with them at the time of the interview, like Aadhar Card, PAN card, Driving License, Passport, etc.
- The candidates shall have to produce an original certificate/Duressment certificate (if applicable) in the form of filling before the interview committee at the time of their interview, along with photographs of the same. Any candidate who fails to produce his/her original certificate/document may forfeit his/her candidature.
- Only shortlisted candidates shall be allowed to appear in the interview who fulfil all the notified eligibility requirements.
- None of the names in the shortlist shall not appear in the interview.
- No individual interview call letters shall be issued to the candidates whose names are appearing in Annexure-A & Annexure-B in this Notification.
- In the event of any deficiency found at the time of the interview concerning the eligibility of any candidate, such candidate may not be allowed to appear in the interview.

- Guidelines for Ex-Servicemen:**
 - Ex-servicemen must strictly adhere to the provisions contained in S.C. 361 dated 20.10.2021, known as the *Jammu and Kashmir Ex-Servicemen (Re-employment in Public Services and Posts) Rules, 2021*.
 - An Army Certificate of Education - which includes individuals who possess the Indian Certificate of Education on an equivalent certificate from the Navy or Air Force and who are completely fit in all respects as mentioned in the Armed Forces may be considered eligible for appointment to the advertised posts.
 - Candidates seeking consideration under the Ex-Servicemen (J&K) category must produce a certificate issued by the respective State/Union Territory Office (ZSWO). In addition, they must submit an affidavit (duly attested by a Magistrate of First Class) stating that they have not previously availed the benefit under the ESM category for any post. If it is found at any stage of the selection process that a candidate has availed the benefit under a benefit, his/her candidature will not be considered with immediate effect without any prior notice. Such candidates will have no claim to the post, and legal proceedings will be initiated for submitting a false affidavit.
- No TA/DA shall be paid to the candidates for appearing in the interview.
- Any candidate who is listed among the shortlisted on the same date candidates for interviews in both Jammu and Kashmir Divisions simultaneously should contact the Secretariat at 9111111111 or 9111111111@gmail.com to request for rescheduling of his/her interview at one place.
