The investigation remains ongoing to identify and apprehend other individuals involved in the scam.

**4 drug peddlers arrested, contraband substance recovered**

ANANTNAG: As part of its ongoing drive against drug trafficking, Police in Anantnag have arrests 04 drug peddlers in two separate operations and recovered substantial quantity of narcotic substances.

A police party from Police Post Sangam at a checkpoint established at Gund Baba Khalil, intercepted a vehicle (Santro) bearing registration number JK13A-5700 with two persons on board. During search of the vehicle, approximately 21 kilograms of raw narcotic material, including cannabis seeds were recovered. The accused have been identified as Mohd Ayoub Kumar, son of Habibullah Kumar, and Javid Ahmad Kumar, son of Gh Hassan Kumar, both residents of Waghama. Both have been arrested and vehicle used in the commission of crime has also been seized.

Moreover, a police party from Police Station Bijbehara intercepted a motorcycle at Zirpara near GDC Bijbehara ridden by two persons. During search, Charas-like narcotic substance weighing approximately 128 grams was recovered from their possession. The accused have been identified as Sahil Ahmad Khanday, son of Abdul Hameed Khanday, resident of Zirpara, and Amir Sohail, son of Mohd Ashraf Teli, resident of Karewa Colony, Bijbehara. In this regard, a case under the NDPS Act has been registered and investigation is going on.

**Bovine smuggler detained under PSA in Samba**

JAMMU: A habitual bovine smuggler was detained under the stringent Public Safety Act (PSA) in Samba district on Saturday, police said.

Shabir Shah, a resident of Chamalvas-Banihal, has been booked under the PSA after obtaining a formal detention order from the district magistrate, Samba, a police spokesman said.

Shah has been subsequently lodged in Central Jail Kot Bhalwal, Jammu, he added. The spokesman said that "he is involved in multiple FIRs registered against him during 2021, 2022, 2024 and 2025 at Police Stations Ghagwal and Samba for indulging in bovine smuggling".

"The repeated criminal activities of the hardcore smuggler have posed a serious threat to public peace and tranquility," he added.



**Two youths die in Chandak road mishap**

POONCH: Two scooty borne youth died after being collided with a bus in Poonch District. as per details, at around 3:20 PM two young boys lost their lives after a scooty collided with a passenger bus near Chandak. The injured were immediately rushed to District Hospital Poonch by locals and police. However, doctors declared both of them brought dead.

The deceased have been identified as Zahid Choudhary (18), son of Safia Begum, resident of Bandichachian and Bilal Ahmed, son of Abdul (19) Jamal, resident of Chamberkanari Tehsil Mandi.

The sudden and unfortunate demise of the two young boys has left their families and the local community in deep shock and grief. Police have registered a case and further investigation is underway.

**Reasi Police apprehends unauthorized pithu operator**

REASI: Continuing its commitment to ensuring the safety and regulation of services on the Shri Mata Vaishno Devi (SMVD) track, District Police Reasi apprehended an unauthorized pithu operator during routine checking and patrolling near Bathing Ghat-2 in the jurisdiction of Police Post Banganga.

At around 2030 hrs, a police party on patrol stopped an individual who was approaching from Sameer Point towards Banganga along with a pithu buggy. Upon questioning, the individual disclosed his identity as Hoshyar Singh S/O Sunak Singh R/O Meer, Tehsil Panchari, District Udhampur.

During the verification process, he was asked to produce his registered service card authorizing him to operate as a pithu. However, he failed to provide any valid authorization or registration card, thereby violating the provisions laid down for service operators on the holy track.

Accordingly, a case FIR No. 158/2025 U/S 223(a) BNS has been registered at Police Station Katra, and further investigation is underway.
