Nominations are sought for selection of a new Vice-Chairman of the University Grants Commission (UGC). The UGC is a statutory body with the Ministry of Education, Government of India, entrusted with the task of determination, coordination and maintenance of standards in the University education. Under the provisions of section 5 of the UGC Act, 1956, Vice-Chairman is appointed by the Central Government.

Eminent persons with substantial experience in academics, governance and/or professional management commensurate with the prestige of the position and preferably less than 62 years, may be nominated by the peers. No self-nominations will be accepted.

Clause (b) of sub-section (1) of section 6 of the UGC Act, 1956 provides that the Vice-Chairman shall hold office for a term of three years or until he/she attains the age of 65 years, whichever is earlier. The Vice-Chairman, in addition to being a member of the Commission, also officiates as Chairman, UGC in the absence of the Chairman.

Hard copy of the curriculum vitae will not be accepted. The Search cum Selection Committee reserves the right to consider persons of eminence outside the list of such nominations. **NOTICE**

I Shaheen Wahid-JKPS, Sr. Superintendent of Police, Telecommunication, Jammu Zone Jammu, hereby issue this notice to you, SgCt.Opr. Raghbir Singh No. TEL-025895 (VHF Station Hatli, Kathua), on the following grounds of serious misconduct, prolonged unauthorized absence from duty, and involvement in a criminal case: -

- As per the official records of DTHQ Kathua, you have been marked absent from duty from 18-11-2024 to 31-12-2024. In light of this, a departmental enquiry was initiated against you, vide ZPTHQ Jammu Order No. 28 of 2025 dated 31-01-2025, which remains pending due to your consistent non-compliance and failure to appear before the Enquiry Officer, despite repeated official directives.
- On 05-02-2025, you were formally directed by the Dy. S.P Telecom Kathua to report to the office of Dy. S.P Telecom Samba to face the departmental enquiry regarding your prolonged absence of 43 days. However, you failed to report at DTHQ Samba and absented yourself again. Accordingly, you were again marked absent in the Daily Diary of PP Hatlivi DDR No. 05 dated 09-02-2025 w.e.f 06.02.2025.
- You were once again instructed to resume your duty vide ZPTHQ Jammu Signal No. Estt/PF-2960/2025/1825-26 dated 11-02-2025, but you wilfully ignored the directive and did not report back to your assigned duty.
- On 15-02-2025, this office received a communication (Signal No. 104/PSL) from the Station House Officer, Lakanpur, informing that a case FIR No. 20 of 2025 under Sections 69/351(3) BNS has been registered against you, based on a complaint filed by Ms. Neha D/O Surjeet Kumar, R/O Marooli, Tehsil & District Kathua. Consequently, you were placed under suspension vide this office's Order No. 37 of 2025 dated 17-02-2025, and a departmental enquiry was initiated against you.
- As per the latest report received from SHO P/S Lakanpur vide Signal No. 338/PSL dated 10-05-2025, you are still absconding and have not appeared before the police authorities for investigation.
- Prior to your involvement in the aforementioned FIR, you have remained unauthorizedly absent from duty on 27 separate occasions. Despite being repeatedly warned and penalized with the hope of corrective behaviour, you have failed to improve. Your continued misconduct and defiance have compelled the department to consider strict disciplinary action.

Before a recommendation is made for your dismissal from service, you are hereby given a final opportunity through the medium of this Notice to surrender yourself before PS Lakanpur and cooperate with the ongoing investigation. You are directed to report within 02 days after publication/receipt of this notice whichever is earlier. Failure to comply with this directive will result in the department proceeding with a formal recommendation for your dismissal from service, taking into account your adverse service record and involvement in a criminal offence.
