and mess. Modi later visited the city civil hospital, where he spoke to Vishwas Kumar Ramesh, the lone plane survivor of the tragedy and also met other persons injured in the accident.

The PM visited the C7 ward of the hospital, where 25 injured people are undergoing treatment, and interacted with the doctors.

Modi met state and civil aviation officers at the GujSail office near the Ahmedabad airport and was briefed on the tragedy.

The London-bound aircraft with 242 people on board, including former Gujarat Chief Minister Vijay Rupani, crashed moments after taking off.

Of the 265 bodies brought to the Ahmedabad Civil Hospital for post-mortem on Thursday, six victims were identified so far as their faces were intact, police nspector Chirag Gosai said.

He said DNA profiling is underway to ascertain the identities of others as their oodies are charred beyond recognition.

"We have handed over the six bodies to the relatives. We have started the process of collecting DNA samples of relatives for profiling to identify bodies that are charred beyond recognition," Gosai said.

"Relatives of 215 deceased persons have approached us to give their samples," he said. The details are gathered from relatives arriving at the post-mortem room, and the kin are then sent to BJ Medical College to provide their DNA samples, he added.

"It will take nearly 72 hours to complete the exercise of matching the DNA samoles. Once there is a match, bodies will be handed over to relatives from the postmortem room," Gosai said.

A Boeing 787 Dreamliner (AI 171), with 242 people on board, including forner Gujarat Chief Minister Vijay Rupani, crashed into a medical college complex in the Meghaninagar area moments after taking off from the Ahmedabad air-

Bhumi Chauhan, a UK-based woman visiting India, thanked God and her stars for missing the ill-fated Air India plane as she got stuck in heavy traffic and

Chauhan said she missed boarding the plane by just 10 minutes.

"I am shivering after I learnt about the crash. I left the airport at 1.30 pm as I missed the flight due to traffic. I thank God," said Chauhan, who was in India

At least nine crew members on board, including both the pilots, hailed from Maharashtra, an official said.

He said the aircraft's pilot, Captain Sumeet Pushkaraj Sabharwal (56), was a resident of Jal Vayu Vihar in the Powai area of Mumbai and lived with his elderly parents.

The co-pilot of the flight, Clive Kunder, was a resident of the western suburbs of Mumbai, as per his social media account.

Cabin crew member Deepak Pathak lived in Badlapur in neighbouring Thane

Pathak's sister had earlier said he spoke to his mother before leaving for London. He had been working with Air India for 11 years, she said.

Another crew member, Maithili Patil (23), was a resident of Nhava village in Navi Mumbai. Patil joined Air India two years ago, and her father, Moreshwar Patil, is a labour contractor with ONGC.

Patil had spoken to her father before her flight to London and promised to call him once she reached the city, a former sarpanch of Nhava said.

Aparna Mahadik (43), another crew member, was a resident of Goregaon in the western suburbs, and her husband also works with Air India as a crew member.

She was a relative of NCP leader Sunil Tatkare. Roshni Rajendra Songhare and Saineeta Chakravarti, both crew members,

hailed from Dombivli and Juhu Koliwada, respectively. Songhare was also a travel influencer with more than 54,000 followers on Instagram.

The victims also included Mahadev Pawar (68) and his wife Asha (60), who

nailed from Hatid village in Sangola of Maharashtra's Solapur district. The Pawars had left Sangola and settled in Gujarat 15 years ago, and they were

neading to London to visit their son.

One of the passengers, Yasha Kamdar Modha (32), was the daughter of Nagpur businessman Manish Kamdar. She was travelling to London with her son Rudra and mother-in-law Rakshaben, and all three perished in the crash.

also granted liberty to the employer to initiate fresh disciplinary proceedings in accordance with law.

Subsequently, both the employee and employer filed separate Letters Patent Appeals.

LPA No. 97/2024 filed by Suresh Kumar Rekhi through counsel Ayushman Kotwal, challenging the denial of monetary benefits during the period of termination while LPA No. 195/2024, filed by the UT of Jammu & Kashmir and JKPCCL, represented by Ravinder Gupta, Additional Advocate General, challenging the quashing of the termination on the ground that the appointment itself was void ab initio due to alleged forgery.

After hearing both sides and perusing the records, the Division Bench delivered a nuanced verdict on May 29, 2025.

The Bench unequivocally held that termination without affording an opportunity of hearing violated fundamental legal principles, especially when the termination was stigmatic in nature and ended a career spanning nearly three

The Court observed that the employer acted solely on departmental communication without providing Rekhi a chance to respond to the allegation regarding the PRC. This, the Court said, rendered the action legally untenable.

The Bench also noted that while there were credible allegations about Rekhi using a subsequently cancelled PRC, there was no finding that he had personally forged or misrepresented documents. The PRC may have been valid when issued and only later cancelled. Recognizing both the employer's position and the employee's hardship, the

Court struck a balance. It ruled that Suresh Kumar Rekhi shall be entitled to 50 per cent of the back wages for the period from July 29, 2021 to December 18, 2023-partially allowing LPA No. 97/2024. LPA No. 195/2024 filed by the employer was dismissed, affirming the Single

Judge's order to reinstate the employee with liberty to initiate de novo proceedings. The matter has now been disposed of by the Court.

### Israel strikes Iran's...

"Israel will come to deeply regret this reckless aggression and the grave strategic miscalculation it has made," he said.

Israel's military said about 200 aircraft were involved in the initial attack on about 100 targets. Its Mossad spy agency positioned explosive drones and precision weapons inside Iran ahead of time, and used them to target Iranian air defences and missile launchers near Tehran, according to two security officials who spoke on condition of anonymity.

It was not possible to independently confirm the officials' claims.

Among the key sites Israel attacked was Iran's main nuclear enrichment facility in Natanz, where black smoke could be seen rising into the air. It also appeared to strike a second, smaller nuclear enrichment facility in Fordo, about 100 km southest of Tehran, according to an Iranian news outlet close to the government that reported hearing explosions nearby.

Israel said it destroyed dozens of radar installations and surface-to-air missile launchers in western Iran.

Israel military spokesman Brig Gen Effie Defrin said the Natanz facility was "significantly damaged" and that the operation was "still in the beginning".

The first wave of strikes had given Israel "significant freedom of movement" in Iran's skies, clearing the way for further attacks, according to an Israeli military official who spoke on condition of anonymity because he was not authorised to discuss details of the attack with the media.

The official said Israel is prepared for an operation that could last up to two weeks, but that there was no firm timeline and it would depend largely on how Iran responds.

Among those killed were three of Iran's top military leaders: one who oversaw the entire armed forces, Gen Mohammad Bagheri; one who led the paramilitary Revolutionary Guard, Gen Hossein Salami; and the head of the Guard's ballistic missile programme, Gen Amir Ali Hajizadeh.

Iran confirmed all three deaths, significant blows its governing theocracy that will complicate efforts to retaliate. Khamenei said other top military officials and scientists were also killed.

Israeli Prime Minister Benjamin Netanyahu said the attack had been months

In a video statement sent to journalists Friday, Netanyahu said he ordered plans for the attack last November, soon after the killing of Hassan Nasrallah, the leader of Hezbollah in Lebanon, one of Iran's strongest proxies. Netanyahu said the attack was planned for April but was postponed.

In its first response Friday, Iran fired more than 100 drones at Israel. Israel said the drones were being intercepted outside its airspace, and it was not immediately clear whether any got through. Israel's military said it called up reservists and began stationing troops in "all

combat arenas" throughout the country as it braced for further retaliation from Iran or Iranian proxy groups on its border. Trump urged Iran on Friday to reach a deal with the US on its nuclear pro-

gram, warning on his Truth Social platform that Israel's attacks "will only get

"Iran must make a deal, before there is nothing left, and save what was once known as the Iranian Empire," he wrote.

Earlier in the week, officials in Washington had cautioned Israel against an ttack so as not to disrupt US negotiations with Iran over its nucl ment programme. On Friday, they stressed the US had not been involved in the attack, and warned against any retaliation targeting US interests or personnel. Israel calls attacks preemptive strikes on Iran's nuclear programme

Israeli leaders cast the attack as necessary to head off an imminent threat that Iran would build nuclear bombs, though it remains unclear how close the country is to achieving that or whether Iran had actually been planning a strike. Iran maintains its nuclear programme is for civilian purposes only.

"This is a clear and present danger to Israel's very survival," Israeli Prime Minister Benjamin Netanyahu claimed as he vowed to pursue the attack for as long as necessary to "remove this threat."

Israel is widely believed to be the only nuclear-armed state in the Middle East but has never acknowledged having such weapons.

Over the past year, Israel has been targeting Iran's air defences, hitting a radar system for a Russian-made air defence battery in April 2024 and surfaceto-air missile sites and missile manufacturing facilities in October.

On Friday, Israelis rushed to supermarkets in Tel Aviv, Jerusalem and elsewhere to buy bottled water and other supplies. But, otherwise, streets and parks were mostly deserted.

Iran says Israel targeted residential areas

For Netanyahu, the operation distracts attention from Israel's ongoing and increasingly devastating war in Gaza, which is now over 20 months old

There is a broad consensus in the Israeli public that Iran is a major threat, and Israel's opposition leader, Yair Lapid, a staunch critic of Netanyahu, offered his "full support" for the mission against Iran. But if Iranian reprisals cause heavy Israeli casualties or major disruptions to daily life, public opinion could shift quickly. The Iran-backed Lebanese militant group Hezbollah issued a statement that offered condolences and condemned the attack, but did not threaten to join Iran in its retaliation. Hezbollah's latest war with Israel - which killed much of the group's senior leadership - ended with a US-brokered ceasefire in November.

Khamenei, the Iranian Supreme Leader, said in a statement that Israel "opened its wicked and blood-stained hand to a crime in our beloved country, revealing its malicious nature more than ever by striking residential centres."
