The appointment of Gulnaz Akhter has been made by Lieutenant Governor in exercise of the discretionary powers conferred under Clause-2A of Jammu and Kashmir Rehabilitation Assistance Scheme, 2022 in relaxation of her educational

As per clause 2A of J&K Rehabilitation Assistance Scheme-2022, the Lieutenant Governor in exceptional circumstances may appoint the dependent family member of a civilian, who has died as a result of militancy/terrorist related action or due to law and order situation or due to enemy action and who is not involved in militancy related activity, in Government Service.

The conferment of relaxation of age/qualification for appointment under J&K Rehabilitation Assistance Scheme-2022 solely lies with the Lieutenant Governor.

The appointment of Gulnaz Akhter has been made by Lieutenant Governor under exceptional circumstances as her husband was a civilian and not a Government employee. Further, appointment has been made in relaxation of her educational qualification. There is no role of Fisheries Department in granting relaxation as well as appointment in the instant case.

Acknowledging the supreme sacrifice of Adil Hussain Shah during the terrorist attack at Baisaran Pahalgam, the Lieutenant Governor in exercise of the discretionary powers has considered the appointment of wife of the slain civilian in relaxation of her educational qualification, so that it can bring a succour to the family.

This decision is a heartfelt gesture to support the bereaved family and ensure their lignity and well-being, reflecting the administration's unwavering commitment to justice and compassion.

Corruption Bureau for taking legal action against the accused public servant

On receipt of the complaint, official said, a discreet verification was conducted, which confirms the demand of bribe by the public servant concerned and accordingly, a case FIR No. 12/2025 under Section 7 of Prevention of Corruption Act, 1988 was registered in Police Station ACB Jammu and investigation taken up.

During the course of investigation, official said, a trap team headed by Gazetted rank officer was constituted.

"The team laid a successful trap and accused public servant after accepting bribe amount of Rs 15000 from the complainant, sensing the presence of ACB on spot, fled away from the spot and threw the tainted bribe money in the bushes on the NHW near Palli," the official said adding that the tainted bribe money was recoved from the bushes by independent witnesses and seized in the instant case

The search was also conducted in the residential house of the accused in presence of magistrate and independent witnesses, official said adding that however, the accused person is still at large and investigation of the case is in progress.

Civil Aviation Secretary Samir Kumar Sinha said the investigation is going on smoothly into the Air India plane crash.

The Aircraft Accident Investigation Bureau (AAIB) is probing the crash.

Before the press conference, a one-minute silence was observed to pay homage to the victims of the Air India plane crash.

He said that DNA testing is happening to identify victims and hand them over to their families

"The Gujarat government is coordinating with that. They have been there on the ground since the time of the crash and they have been facilitating all the efforts and measures that are required from their side, so once the DNA testing is confirmed, the bodies will be given to the respective families," the minister said.

"We are hoping that the process also gets (completed) as soon as possible," Naidu

"We have very strict safety standards in the country also, and many, including the ICAO, international organisations have also time and again established that we do have a very strict protocol, robust protocol which we follow every time.

But even after that, when the incident happened, we also felt that there is a need to do an extended surveillance into the Boeing 787 series, Naidu said, adding, "So, through the DGCA, we have also given the order to do the extended surveillance for the 787 planes"

There are 34 (before the crash) Boeing 787-8 in the Indian aircraft fleet today and "I believe that eight have already been inspected," the minister said.

He said that whatever necessary steps are needed will be taken to improve the (aviation) safety

On the formation of the high-level committee, the minister said its composition involves three persons from various backgrounds, and people, who the government feels, can bring a lot of expertise and value to it, will investigate in a holistic way into the incident. "We have put a time limit of three months for them to sit down, talk to various stakeholders, and involve and discuss with any other important expert that is necessary as part of their investigation," he noted.

He said the AAIB team believes that "the decoding of the black box is going to give in-depth insight into what would have actually happened during the process of the crash or moments before the crash itself". LMD imposes Rs 1.25 lakh fine on leading Paint Manufacturer for Breach of norms

SAMBA: The Legal Metrology Unit Samba has imposed a penalty of Rs 1,25,000 (Rupees One Lakh Twenty-Five Thousand) on a leading Jalandhar based paint manufacturing company for gross violations of labelling norms under the Legal Metrology framework The action was taken by the Assistant Controller Legal Metrology Samba, follow

ng a detailed inspection of the company's products. The investigation revealed clear violations of the Legal Metrology Act 2009 and the Legal Metrology (Packaged Commodities) Rules 2011, where pre-packaged paint containers were found noncompliant with mandatory declarations essential for transparency, consumer pro tection and fair trade.

On detection of the violations and subsequent admission of non-compliance by the company, a compounding application was filed and penalty proceedings were initiated. The company and its responsible Directors were held accountable and enalised accordingly.

This bold and swift action reaffirms the Department's zero-tolerance policy owards violations of legal metrology norms.
