AIMCCC stages protest, seeks justice and relief for migrant community

JAMMU: The All India Migrant Camps Coordination Committee (AIMCCC) today held a press protest at the Press Club Jammu, drawing attention to the pressing issues faced by the migrant community. Led by AIMCCC Chief Shri Desh Rattan Pandita, the protest focused on long-standing demands for relief, justice, and basic amenities for displaced families. Addressing the gathering, Desh Rattan Pandita highlighted the decades-long struggles of the migrant population and urged the authorities to acknowledge and act upon their grievances.

He demanded a substantial hike in relief assistance to help families cope with rising costs of living and maintain a life of dignity.

Among the major demands raised during the protest were enhanced relief package in line with current market standards; Reclamation of encroached land and cancellation of property mutations made under duress or deception; One government job per migrant family to ensure economic stability; Installation of borewells in Jagti Township to tackle the ongoing water crisis; Uninterrupted power supply for migrant colonies to provide relief from harsh summer conditions.

Supporting the Chief's demands, Vice Presidents P N Jalali and R L Sharma, along with General Secretary Jawahar Lal Raina, called for urgent intervention from the administration to restore justice and dignity to the community.

PROCLAMATION U/S 82 Cr.PC

Whereas final report has been made before me that 1. Mohd Azad SO Mohd Azam R/O Gira District Arira Bihar and 2) Taki Ahmed S/O Mohd R/O Swaidha Majhuma Bihar have committed (or are suspected to have committed) the offence punishable under sections 376,363/IPC 3/4 POCSO ACT and it has been stated that the arrest warrants in respect of the above-named accused persons could not be executed as the accused persons are absconding and their whereabouts are not known.

Whereas this Court is satisfied that these accused persons have gone underground and hiding to evade the process of law.
