successful service in just a few days; we would want more people to benefit from it." Asked about the Iran-Israel conflict, the National Conference leader said the war should stop and the issue resolved through dialogue.

"This bombing should not have started. Before this, when the American intelligence in-charge was asked if Iran had the nuclear bomb, he had said he did not think Iran could make a bomb for a long time. But Israel attacked Iran within a few nonths. This attack should stop and the issues resolved through talks," he said. On the local students studying in Iran, he said they will return gradually.

"We cannot bring them back overnight, as airports and ports are closed. We are bringing them via road first to those cities where there is no bombing, then they are being brought back through Armenia.

"We are hopeful that today, 300-400 students are returning, a majority of whom are from J-K. We will bring them home safely," he added.

Asked about power sharing with the Lieutenant Governor, Abdullah said the LG should approve the business rules that have been approved by the cabinet to end the confusion.

"I have never said LG has all the powers. You check the J-K Reservation Act. The LG has himself said that his responsibility is limited to only the security and law and

"That is why I am saying that the business rules approved by the cabinet should

be signed and returned by the LG so that there is no confusion," he said. "The LG has one responsibility: He should protect the people of J-K and improve the security scenario here ... Rest of the responsibilities are ours," the CM added.

non-compliance with the essential audit and security parameters. He maintained that the prolonged shutdown of these critical digital platforms, even for security reasons, could not be taken for granted and directed for immediate measures for the earliest restoration. He enjoined upon the IT Department to submit the compliance reports from all departments every three days, specifically on Mondays and

Conducting a department-wise assessment of currently offline websites and applications, Dulloo directed the National Informatics Centre (NIC) and IT Department to take immediate action to restore these vital services online.

In a strong push for enhanced data safety and security, the Chief Secretary impressed upon all the concerned authorities to restrict the official communications exclusively to authorized government email addresses, imposing a strict ban on the use of private email IDs for official business. He reiterated that the security of government data and cyber assets is non-negotiable and brooks no compromise.

Furthermore, he directed the swift migration of mini data centers, currently used by offices such as JPDCL, KPDCL and SICOP, to more secure and centralized facilities for enhanced safety and security management.

Dulloo also assessed the proactive measures being undertaken by the IT Department and NIC to ensure overall safety of the Union Territory's digital assets

The meeting also emphasized continuous capacity building for the officers and officials to promote a culture of cyber hygiene

The Chief Secretary stressed that this process must be ongoing, with creation of dedicated 'master trainers' within each department to disseminate the best practices. He directed for implementation of long-term strategic measures to ensure the government's digital systems remain secure for the foreseeable future.

Providing an update on the department's initiatives, Secretary IT, Piyush Singla, informed the Chief Secretary that a two-day workshop on cyber security had recently been organized in J&K, attended by approximately 250 officers.

Singla highlighted that numerous additional steps are underway to enhance the capacity of government officers. He added that Chief Information Security Officers (CISOs) or Information Security Officers (ISOs) have been nominated within each department to safeguard the IT assets.

During the course of investigation, several suspects were summoned for question ing. Through sustained investigation and comprehensive forensic analysis, particu larly DNA profiling, an individual from Gulgam, Kupwara, was conclusively identified. The DNA report confirmed his involvement by establishing him as the biolog ical father of the foetus. The accused has been arrested and taken into custody, and further legal proceedings are underway.


#### Notorious criminal nabbed with illegal firearm STATE TIMES NEWS
