Parvaiz and Bashir had knowingly harboured the three armed terrorists at a seasonal dhok (hut) at Hill Park before the attack, the NIA investigation revealed.

They had provided food, shelter and logistical support to the terrorists, who had, on the fateful afternoon, selectively killed the tourists on the basis of their religious identity, making it one of the most gruesome terrorist attacks ever, the agency said.

Iran launches missile...

US launched a surprise attack Sunday morning on three of Iran's nuclear sites. Just before the explosions, Iranian President Masoud Pezeshkian wrote on the social platform X: "We neither initiated the war nor seeking it. But we will not leave nvasion to the great Iran without answer.

Earlier in the day, Israel expanded its war against Iran to include targets associated with the country's struggling theocracy, striking the gate of a Tehran prison notorious for holding political activists and hitting the headquarters of the military force that suppressed recent protests

As plumes of thick smoke rose over Tehran, Israel was attacked with yet another parrage of Iranian missiles and drones. The persistent fire has become a reality for civilians in both countries since Israel started the war to target Tehran's rapidly advancing nuclear programme.

On the 11th day of the conflict, Israel said it attacked "regime targets and government repression bodies in the heart of Tehran," but Israeli officials insisted they did not seek the overthrow of Iran's government, their archenemy since the country's 979 Islamic Revolution

The Israeli military warned Iranians that it would continue to attack military sites around Tehran over "the coming days" as its focuses has shifted to symbolic targets as well. The military issued the warning on the social platform X, though Iranians are struggling to access the outside world as an internet shutdown has crippled the

The latest strikes unfolded only hours after President Donald Trump openly raised the possibility himself after just a day earlier inserting America into the war with its unprecedented stealth-bomber strike on three Iranian nuclear sites.

PIL regarding encroachment in Jammu DB orders removal of encroachments in city, directs security cover during anti-encroachment drives

JAMMU: A Division Bench Jammu & Kashmir and Ladakh High Court Comprising Chief Justice Arun Palli and Justice Rajnesh Oswal, while taking serious note on the encroachments on Path and roads, directed to remove encroachments.

This order has been passed in an order aiming at restoring public spaces and ensuring smooth flow of pedestrian and vehicular traffic the Jammu & Kashmir High Court has issued comprehensive directions to curb illegal encroachments by shopkeepers, vendors, and food joints.

While disposing of the PIL, DB observed that as the Divisional Commissioner, Jammu has already been nominated as Nodal Officer for enforcement of the directions issued by this Court from time to time, accordingly we dispose of this Public Interest Litigation with the following direc-

DB directed the Jammu Municipal Corporation to ensure that no public pathway/road/street/nullah is encroached by any one and shall conduct anti encroachment fortnight and during drive, the encroachments temporary of permanent made by the shopkeepers or any commercial establishment on the pathways/streets/roads/nullahs be removed. No commercial establishment be permitted to place their gadgets on the street/pathway/road/nullah. The Jammu Municipal Corporation shall educate the shopkeepers or owners of commercial establishments against encroaching any street/road/pathway/nul lah for the purpose of displaying/selling their goods/ keeping their gadgets and consequences of the violations thereof.

DB further said that the errant shopkeepers/owners of commercial estab lishments, who despite being challaned and fined, repeat their actions again and display their merchandise by extending their shops or placing their gadg ets on the public road/street/pathways, the Jammu Municipal Corporation in addition to penal provisions, shall also proceed against the encroachers in terms of section 232 of the Municipal Corporation Act. The Jammu Municipal Corporation shall also proceed against such violators in terms of section 371 of the Municipal Corporation Act. If despite repeated fines and action unde section 232 of the Municipal Corporation Act, the violator(s) still continue(s with his/their illegal activities, the Jammu Municipal Corporation, shall seal the shop/commercial establishment after the failure on the part of violator to remove the violation within 10 days of the notice to remove the violation(s).

DB further directed the Jammu Development Authority shall ensure that the shopkeepers in the JDA Complex situated at City Chowk, Jammu do not encroach the pathways in front of their shops and in case of repeated violations may issue notice for cancellation of their lease deeds and thereafter proceed in

DB further ordered that the Jammu Municipal Corporation shall ensure that no food joint is operated on the roadside/pathway/street without permission from the Jammu Municipal Corporation and competent authority under Food Safety and Standards Act, 2006. The Jammu Municipal Corporation shall also ensure that rehries operate only at the designated places and no obstruction is caused in smooth flow of traffic due to illegal operation of rehries. The authority concerned shall ensure the implementation of Stree Vendors (Protection of Livelihood and Regulation Street Vending) Act, 2014 and Rules of 2021 framed there-under, in its letter and spirit.

DB also directed the Senior Superintendent of Police, Jammu is directed to provide the necessary protection to the officers of Jammu Municipal Corporation and Jammu Development Authority whenever required. As the Divisional Commissioner, Jammu has already been nominated as Nodal Officer, he shall hold the meeting with the Commissioner, Jammu Municipal Corporation and Vice Chancellor, Jammu Development Authority regularly, se that the directions issued as mentioned above, are complied with in its letter and spirit. While removing the encroachments, the officials concerned shall use minimal force, so that no unnecessary harassment is caused to anyone.

DB also appreciate the sincere efforts made by Adv Ajay Sharma, the learned Amicus curiae, DB close the proceedings in this PIL with liberty to Mr Ajay Sharma, the Amicus and any other public-spirited person to bring to the notice of this Court non-compliance of the directions of this court by the offi cers/authorities as mentioned above.

Er. Wali sustained severe injuries while on duty at the Receiving Station Budgam The incident occurred when an adjacent auxiliary transformer exploded, splashing hot oil and causing critical injuries. Despite efforts, he succumbed to his injuries aving his family colleagues, and the engineering community in shock and grief In a statement, JKEEGA shared, "All engineers of JKPDD extend heartfelt sym

pathy to the family of the deceased during this difficult time. Words cannot ease the pain, but we stand united with them in their loss." The association highlighted the dedication of frontline engineers and staff who work tirelessly under high-risk conditions to ensure uninterrupted power supply for the public and essential services like hospitals. JKEEGA also noted that such inci-

dents, though rare, remind everyone of the dangers faced by power department workers daily. JKEEGA urged the government to introduce insurance schemes for all JKPDD engineers and staff, emphasizing their need for financial security given the risks they face while maintaining and repairing the power network.
