optional. Students will be allowed to improve their performance in any three subjects out of science, mathematics, social science and languages," he added.

Explaining the rationale behind making the first phase mandatory for the students, CBSE Chairman Rahul Singh said it is being done to ensure that students take the exams seriously and the sanctity of the board exams is maintained.

"If a student does not appeared for three or more subjects in the first examination, he or she will not be allowed to appear for the second exam. Such students will be placed in the 'Essential Repeat' category and can take the examination only next year in the main exam in February," he said. "Students whose result in the first examination is compartment will be allowed to appear in the second examination under the compartment category. Additional subjects will not be permitted after passing Class-10, students will not be allowed in stand-alone subjects," he added. It was established during investigations that the accused public servants in connivance with each other under a well-knit conspiracy, by brazen abuse of their official positions and authority, have misappropriated the Govt. funds to the tune of Rs. 26,87,307 through fraudulent and dishonest means, thereby conferring undue pecuniary benefits upon themselves & causing corresponding loss to state exchequer.

The investigations conducted has also revealed that the accused public servants have acted in brazen violation of financial regulations, created fictitious bills ,indulged in misappropriation of funds by showing fake vouchers, bills expenditure statements and fail to maintain proper record of expenditures incurred.

of India's human space programme and it is my desire that all the countrymen become a part of this journey," Shukla said.

"Your chest, too, should swell with pride... Together, let's embark on this journey of India's Human Space Programme. Jai Hind! Jai Bharat," Shukla said.

Shukla scripted history by embarking on a space odyssey along with three others to the International Space Station as part of a commercial mission by Axiom Space on Wednesday, 41 years after astronaut Rakesh Sharma's spaceflight onboard a Russian spacecraft.

The footage beamed by cameras from inside the crew capsule showed the four astronauts strapped into their cabin, seated side-by-side in helmeted white-and-black flight suits.

The 39-year-old, Lucknow-born Shukla became only the second Indian astronaut to undertake a space flight, 41 years after his icon Rakesh Sharma's eight-day space odyssey on board the then Soviet Union's Salyut-7 space station in 1984.

"We are orbiting the earth at a speed of 7.5 km per second... This is not just the beginning of my journey to the International Space Station, but the beginning of India's human space programme and it is my desire that all the countrymen become a part of this journey," Shukla said in Hindi.

Congratulations poured in from all quarters as the Ax-4 mission astronauts entered the earth's orbit. President Droupadi Murmu, Prime Minister Narendra Modi, Science and Technology Minister Jitendra Singh and cricket legend Sachin Tendulkar among others hailed the space mission.

The astronauts will spend 14 days at the ISS and conduct 60 scientific experiments during their mission.

The commercial mission by Axiom Space, a US-based startup, is expected to contribute to microgravity research in areas including human physiology, nutrition, and seed germination in space.

In addition to the planned experiments, the astronauts are flying food that celebrates their heritage: Indian curry and rice with mango nectar; spicy Hungarian paprika paste; and freeze-fried Polish pierogies(dumplings).

Once in orbit, the astronauts revealed the name they gave to their brand-new capsule Grace.

"Good things come to those who wait. Godspeed to the maiden crew of Grace," SpaceX told the crew.

Before the flight, Shukla, who has over 2,000 hours of flying experience on elite fighter aircraft, said he hopes "to ignite the curiosity of an entire generation in my country" and drive innovation. "I truly believe that even though I, as an individual, am travelling to space, this is the journey of 1.4 billion people," he said.

Shukla is expected to participate in several outreach events during his stay at the ISS and also likely to interact with Prime Minister Modi.

Chants of "Hip Hip Hurray", spontaneous bhangra and quiet tears marked the watch party at Shukla's alma mater City Montessori School in Lucknow.

"It's a great moment not just for us but for our country. What can we say at this moment, I am struggling for words now. My blessings are always there with my son," his father Shambhu Shukla told PTI.

"My parents started the day with prayers. We also spoke to Shubhanshu in the morning - he sounded confident, calm, and happy that the moment he had prepared for so long had finally arrived. He must have been nervous, but he didn't show it. That's just how he is," Suchi Shukla, the astronaut's sister, said.

Group of advocates lodges complaint with NHRC over public shaming of accused by police in Jammu

JAMMU: A group of prominent advocates has lodged a complaint with the National Human Rights Commission (NHRC) alleging public shaming and unlawful parade of accused persons by the police in Jammu. The complaint was lodged by 11 lawyers led by Nikhil Padha, an advocate in the Jammu and Kashmir and Ladakh High Court and founder of Human Rights and Harmony. It came a day after a man accused of stealing was paraded on the streets Jammu after being garlanded with shoes. Supreme Court lawyers Sonal Gupta and Reetik Jasrotia, advocates Namita Chhabra and Padamja Sharma of Delhi High Court, advocate Rameez Rena of Patna High Court, advocates Akarshan Magotra and Abrar Hussain of J-K and Ladakh high Court and lawyers Lavanya Bhatt, Rishika Chaurasia and Jiya Gupta were the other signatories in the com plaint, which flagged the public shaming of alleged criminals after their arrest in Gangyal on June 11 and in Bakshi Nagar on June 24. "We, the advocates enrolled with various courts across India, write to you with grave concern and utmost urgency regarding recent events in the Union Territory of Jammu and Kashmir wherein police personnel engaged in unconstitutional acts of public shaming and parade-like punishments of accused persons. "These actions, widely circulated through media and social platforms, constitute a gross violation of human rights, the right to dignity, and established jurisprudence on cusodial rights under Indian law" said the complaint addressed to NHRC Chairperso Justice V Ramasubramanian. The advocates said they have observed with collective anguish, and professional obligation, that law enforcement authorities are bypassing constitutional safeguards and replacing lawful investigation procedures with performative public punishment, leading to irreversible damage to the dignity and fundamental rights of the accused persons.

According to the approved norms, Class-10 students from winter-bound schools will get an option to appear for the board exams in any of the two phases.

The internal assessment will be conducted only once during the academic session.

The CBSE announced the draft norms in February, which were put in the public domain for stakeholders' feedback, including from schools, teachers, parents, students and the public.

The draft norms said the two phases will be optional and students will get the choice to either appear for both, or any of the two.

The new NEP recommended that to eliminate the "high-stakes" aspect of the board exams, all students will be allowed to take the exams on up to two occasions during any given school year.

Both the examinations will be conducted on the full syllabus meant for the year and the scheme of studies and scheme of examinations will remain the same.

The Board has clarified that no separate supplementary exams will be conducted under this system. Instead, the second session of the Board exam will serve as the supplementary exam for those who wish to improve their scores.

At present also, students have an opportunity to improve their scores in supplementary exams.

"Presently, students can improve scores in two subjects and the improvement exams are conducted in July, the results of which are announced in August.

"So, in the new setup, the second phase of exams will be conducted in May and the results will be declared in June. Also, students can attempt to improve their scores in three subjects instead of two," Bhardwaj said.

He recalled how Rajiv Gandhi shamelessly defended it as a "necessary decision," exposing the party's deep-rooted disdain for democratic values. "Today, the very party that once trampled the Constitution pretends to be its guardian. Worse still, those who were victims of that tyranny now sit shoulder-toshoulder with its perpetrators, raising hollow concerns about democracy. This isn't just hypocrisy - it's a betrayal of their own struggle and sacrifice." Chugh said that during the Emergency, the Constitution was amended so drastically that it became a "mini version" of itself. Students were labelled anarchists, journalists were branded as anti-nationals, and ordinary citizens were reduced to the status of slaves under a dynastic regime. "Whenever the dictatorial mindset within an individual gets emboldened by absolute power, democracy is the first casualty. Our youth must know what really happened in 1975-not from textbooks, but from the truth," he said.
