DO's

1. Before starting/setting langar premises, obtain a valid FSSAI Food Registration by applying online at foscos.fssai.gov.in alongwith Annual fee of Rs 100/, Photo ID, Adhar Card of the responsible person of the langer.

2. All Food handlers should maintain personnel hygiene and wear clean clothes/uniform & head gear while manufacturing/ processing/ handling of the food items.

3. Get all the food handlers medically examined by the Registered Medical Practitioners..

4. Use potable water only for food preparation and maintain cleanliness of vending area and food preparation premises.

5. Store Cooked and Raw Foods separately under temperature control to avoid cross contamination.

6. Use separate chopping boards, knives etc for Raw & Cooked food items to avoid cross contamination.

7. Keep the refrigerators, freezers, chillers in a good working condition. Clean and defrost them regularly to prevent frost accumulation.

8. Cook food thoroughly at or above 72⁰C; keep hot food above 60⁰C and cold food below 5⁰C and frozen products at below -18⁰C.

9. Practice First in First Out (FIFO), First Expiry First out (FEFO) while using raw material for preparation of food.

10. Langers should be put in place at the place authorized by the Competent Authority.

11. Please check the date of manufacturing/ Expiry /Use by Date on the label of the food package before use.

12. Prepare food items for the pilgrims strictly as per the Menu Prescribed by the Shri Amarnath Ji Shrine Board (SASB).

DONT's

1. Do not operate the langar/premises without a valid FSSAI Registration.

2. Do not procure raw material from unauthorized vendors and always procure the food items under proper Bill/Invoice.

3. Do not waste food, but use separate waste bins or recycle bins for proper disposal of leftover food/waste.

4. Do not use unpermitted additives/colours for preparation of food.

5. Do not use Newspaper or non-food grade packaging material for storage and packaging of food.

6. Display Notice Board mentioning nature of oil/ghee/vanaspati used in the preparation of prepared foods.

7. Do not allow the Pets/Animals inside the langar premises.

8. Do not keep the raw material directly on the floor.

9. Do not allow Smoking /chewing Tobacco while preparing/serving food to the pilgrimage.

10. Do not allow the person suffering from infectious disease to work in kitchen.
