According to reports several vehicles were also damaged after coming under the mpact of mudslide and landslide near Graveyard Pranoo area of Doda. However, following concerted efforts, the highway has been partially restored for traffic.

STATE TIMES team led by Raja Rehber Jamal visited the area to know the ground situation after the disaster.

Ex Sarpanch Pranoo Farooq Ahmed mentioned that a loud noise was heard in the nearby Nallah early morning as it was raining, after which I came out of my house and raised an alarm about the situation that arose due to the flash flood.

The Beacon (GREF) authorities were repeatedly requested to construct a culvert on this Nallah near Pranoo market, but unfortunately, no action was taken over the past decade, ultimately leading to today's disaster," he added.

Local residents have appealed to the District Administration and Beacon authorties to construct a necessary culvert on Nallah, in order to mitigate the risk of similar situations occurring in the future.

Meanwhile, partial restoration of the Doda-Bhaderwah highway has allowed traffic to resume, and all stranded vehicles have been cleared. JCB work is ongoing to fully restore the highway.

Baldev Raj (35) and Sushil Kumar (25) were rescued by the SDRF from a swollen Ujh river, near Jarmal village in Nagri block of Kathua, the officials said.

They said the men had gone fishing and got trapped due to a sudden rise in the vater level following heavy rains in its catchment areas.

The officials said the SDRF also rescued a person from a stream in Poonch. Flash floods due to cloudbursts were also reported from Qazi Mora in Poonch and

different high-altitude areas of Doda, Udhampur and Ramban districts, but there vas no report of any casualty. Meanwhile, the administration in various districts, including Rajouri and Doda,

have imposed a complete ban on swimming, bathing, fishing and roaming near rivers, nallahs, waterfalls, and also prohibited school picnics. Advisories have been issued asking citizens to stay alert and follow precautionary

measures amid likely flood situations this rainy season, the officials said.

Police personnel were also seen using a public address system fitted in their vehieles asking people to stay away from swollen water bodies due to incessant rains.

The weatherman has forecast intermittent spells of light to moderate rain and thundershowers at many places, with the possibility of heavy rain at a few places of Jammu division till Friday.

In New Delhi, External Affairs Ministry spokesperson Randhir Jaiswal said the SCO member nations could not reach a consensus on certain issues and hence the

document could not be finalised. "India wanted concerns on terrorism reflected in the document which was not acceptable to one particular country. As such the joint statement was not adopted,"

ne said at his weekly media briefing. In his remarks at the conclave in the Chinese port city of Qingdao, the defence minister laid down the broad contours of India's "transitional shift" in its policy against terrorism and urged the SCO member nations to unite in combating and shun "double standards"

"Peace and prosperity cannot co-exist with terrorism and proliferation of Weapons of Mass Destruction in the hands of non-state actors and terror groups," Singh said.

"Dealing with these challenges requires decisive action. It is imperative that those who sponsor, nurture and utilise terrorism for their narrow and selfish ends must bear the consequences," he said.

Singh also said that the pattern of the Pahalgam terror attack matched with Lashkar-e-Taiba's previous terror attacks in India.

The defence minister said India launched Operation Sindoor in response to the neinous terror attack in Pahalgam, and exercised its right to defend against terror-

"During the Pahalgam terror attack, victims were shot after they were profiled on eligious identity. The Resistance Front, a proxy of UN-designated terror group

Lashkar-e-Taiba (LeT) claimed responsibility for the attack," he said.

"The pattern of Pahalgam attack matches with LeT's previous terror attacks in India. India's zero tolerance for terrorism was demonstrated through its actions," he

"It includes our right to defend ourselves against terrorism. We have shown that epicentres of terrorism are no longer safe and we will not hesitate to target them,

Singh said SCO members must condemn terrorism unequivocally as he reaffirmed India's resolve to fight the menace in all its forms.

The defence minister also called for proactive steps to prevent the spread of radicalisation among the youth.

"The joint statement of the Council of SCO Heads of State on 'Countering Radicalisation leading to Terrorism, Separatism and Extremism' issued during India's chairmanship symbolises our shared commitment," he stated.

Singh stressed that the world faces an intricate web of challenges that range from transnational terrorism and cyber-attacks to hybrid warfare. These threats, he said, do not respect national boundaries, and demand a unified

response rooted in transparency, mutual trust, and collaboration. Singh underscored the importance of countering the technology used by terrorists including drones for cross-border smuggling of weapons and drugs, pointing out that traditional borders are no longer the sole barriers against threats in this inter-

connected world. The defence minister also noted that India has been consistent and steadfast in its policy in support of peace, security and stability in Afghanistan.

On SCO's crucial role in the current uncertain geopolitical scenario, Singh said the member countries contribute around 30 per cent of the global GDP and about 40 per cent of the world's population resides in them.

He described the creation of a safe, secure and stable region as a collective stake, which can contribute towards progress and improvement of peoples' lives.

The defence minister voiced India's commitment to increasing its connectivity with Central Asia. "Better connectivity not only enhances mutual trade but also fosters mutual trust.

"However, in these efforts, it is essential to uphold the basic principles of the SCO charter, particularly respecting the sovereignty and territorial integrity of member

submitted by the Branch Manager of Punjab National Bank (PNB), Canal Road Branch, Jammu. The complainant alleged that in 2016, the accused had opened a savings account at the branch, introduced by his real sister who was already maintaining an account there. Subsequently, the accused applied for a term loan of Rs 9 lakh to establish a business unit under the name M/S Three Brackets IT Tech, located at 720 Bemina, Srinagar, claiming to deal in the installation of RFID machines in educational institutions," official said adding that accordingly, a Preliminary Verification (PV) was conducted.

"During the process of PV, the accused was found to have submitted a set of documents including a PAN card and a driving license as identity proof, and duly executed the loan agreement. The loan was sanctioned with a repayment schedule of 84 equal monthly instalments of ?11,069. However, the account soon turned into a Non-Performing Asset (NPA) due to persistent non-repayment. On the basis of the findings of the PV, above mentioned case was registered," the official said.

During investigation, official added, it was conclusively established that the driving license submitted by the accused was forged, and that the loan was obtained through fraudulent means

This resulted in a wrongful financial loss to the bank and a corresponding illega gain to the accused, official said.

After completing the investigation, the offences under Sections 420 (cheating) 465 (forgery), 468 (forgery for purpose of cheating), 471 (use of forged documents) and 120-B RPC (criminal conspiracy) were fully substantiated. A team from the Special Crime Wing headed by Insp Nissar and under the close supervision of SSF Parihar today produced the accused before the Court, and the charge-sheet has been formally submitted for judicial proceedings, official said adding that SCW Jammu remains committed to play it's role of professional investigation in the process of jus tice delivery system.

DODA: District Police Doda on Thursday filled charge-sheet against the administrators of the controversial Instagram account of "Bhaderwah Confession" for allegedly defaming many individuals especially youth by sharing their false, fabricated and malicious content about their personal affairs.

Official said that following the receipt of a written complaint at PS Bhaderwah the case was registered against unknown administrators of the above named Instagram page for spreading false stories, causing defamation and significant damage to personal lives.

Reports were indicating that the page has adversely affected the reputation and relationships of many individuals especially youth of Bhaderwah.

Accordingly on the directions of SSP Doda Sandeep Mehta, an FIR under No 03/2025 under Section 351(2), 351(3), 351(4) 352, 353 BNS, and 66 (D) of IT ct was registered at PS Bhaderwah and investigation of the case was entrusted to SDPO Bhaderwah.

During the course of investigation it has been found that the accused persons Name withheld) who are minors have created an Instagram page "Bhaderwahconfessions" by using fake ID ais00234@gmail.comand and shared the false and defamatory contents of various boys and girls and by spreading false and defamatory contents caused widespread distress and harm which resulted in the disruption of peaceful environment of Bhaderwah town as well as whole District Doda

After completing the investigation of the case, Challan was prepared and produced before the court of Juvenile Justice Board Doda for Judicial determination
