

Consequent upon declaration of result by the National Board of Examinations (NBE), for MDS courses –2025 and subsequently notified by the Board vide Notification No. 052-BOPEE of 2025 dated 30-05-2025 and Notice No. 029-BOPEE of 2025 dated 04-06-2025, the candidates belonging to the UT of J&K / Ladakh who have qualified the NEET MDS-2025 having scored the cut off marks prescribed by the NBEMS, and whose names figure in the Annexure "A" of Notification No. 052-BOPEE of 2025 dated 30-05-2025 are hereby informed that for preparation of the Provisional Merit List (PML), they are required to register themselves online for 50% quota of UT of J&K/Ladakh within the prescribed dates given below:-

Important dates & Instructions:

- The online registration shall commence w.e.f. 27-06-2025.
- The last date of submission of online registration shall be 29-06-2025.
- The registration shall be made online through the BOPEE website www.jkbopee.gov.in.

The candidates should upload the following documents:

- BDS degree certificate;
- Registration with the State/ UT Dental Council/ DCI;
- Internship Completion Certificate (up to 30-06-2025);
- Domicile Certificate of UT of J&K or Ladakh, as the case may be;
- Valid Reserved Category Certificate, wherever applicable, in terms of SRO 294 of 2005 dated 21-10-2005 read with SRO 518 dated 02-09-2019, S.O. 176 dated 15-03-2024, and S.O. 305 dated 21-05-2024;
- Difficult Area Certificate in pursuance of SRO 48 of 2018 dated 30-01-2018;
- NEET-MDS Score Card 2025;
- Valid EWS certificate as per SRO 518 dated 02-09-2019;
- *NOC from Government/Competent Authority for in-service candidates to pursue MDS Courses- 2025;
- (For candidates belonging to the UT of Ladakh), an undertaking in the form of a compulsory Service Board (available on BOPEE Website) that he/she shall serve in the UT of Ladakh for a prescribed period immediately after completing the MDS Degree;
- For candidates belonging to the UT of Ladakh, their ST certificate issued by the competent authority shall be treated as a Domicile Certificate;

- The cut-off date for validity of the category certificates shall be the last date for Registration fixed by the BOPEE, viz, 29-06-2025;
