# Don't whitewash 'Emergency' stigma, lest we forget it: Dr Jitendra

NEW DELHI: Union Minister Dr. Jitendra Singh, in a searing address at a symposium held at Delhi Vidhan Sabha to mark 50 years of the imposition of Emergency, issued a clarion call to the nation "Don't whitewash the "Emergency" stigma, lest we forget it".

The authoritarian mindset with scant regard for democratic values is still around,

Dr. Jitendra Singh delivered a blistering critique of the Congress party, urging the people of India to "Never forget, never forgive." He warned "We must remember every stain - not to glorify it, but to remind future generations who betraved democracy. If we erase Emergency's memory, we risk reliving its

The Minister exposed the hypocrisy of the Congress, accusing the party of condemning true revolutionaries like Madan Lal Dhingra as early as in 1901, even as Veer Savarkar stood by him during his final moments.

"Unfortunately, Gandhi also condemned Dhingra. Congress disowned the martyrs, and history must never forget that betrayal," he declared.

In a powerful takedown of the Congress's post-1930s jail narratives, Dr. Jitendra Singh asked "Where were

their sacrifices before 1930? Discovery of India was written in a jail library - not in the solitary cell of Kala Pani, that was reserved for hard core patriots like Savarkar."

"Emergency was a cumulaoutcome of the Congress's dubious legacy, rooted in its DNA since its birth in 1885," said Dr. Jitendra Singh as he rejected the notion that Emergency was a sudden deviation, instead pointing to the Congress's undemocratic and authoritarian tendencies right from the very begin-

"This dictatorial mindset was rooted in 1885. It became obvious in 1946, Congress Committees chose Sardar Patel to head the Party- but Nehru was imposed by Gandhiji," he stated.

The Minister invoked Dr. Rajendra Prasad, who had lamented "Gandhiji has once again sacrificed his trusted lieutenant in favor of glam-

Calling for an honest reevaluation of history, Dr. Jitendra Singh said "It's time we come out of the 'Old Boys Club' of Emergency victims and plan the road ahead."

Dr. Jitendra Singh exposed how Indira Gandhi, installed as PM in 1966 by K. Kamaraj, quickly dismantled democracy inner-party "Within three years, she split the Congress, centralized power, and enabled Sanjay

Gandhi to run a parallel shadow government.

The Minister quoted PN Haksar, PM Indira Gandhi's Principal Secretary, "She was blind as far as that boy (Sanjay) was concerned."

Recalling the 1974 student uprisings in Gujarat and Bihar, Dr. Jitendra Singh lauded the youth who ignited a democratic firestorm that led to the Allahabad High Court judgment convicting Indira Gandhi of electoral malpractice.

"Instead of resigning, she imposed Emergency, jailed opponents, silenced the press, and suspended the Constitution," he thundered.

Dr. Jitendra Singh lambasted

Constitutional Amendment as the ultimate betraval of founding spirit: India's opportunistically extended Parliament and Legislative Assembly terms, and muffled dissent all to cling to power."

The also exposed how the Emergency was used to manipulate Jammu & Kashmir's democracy, with the misuse of Article 370 to extend the J&K Assembly's term to six years. That legacy, he noted, was corrected only in 2019 under the leadership of Prime Minister Modi.

During the event, Dr. Jitendra Singh released a special booklet and unveiled new book titled "Emergency Diaries", chronicling the voices silenced during those 21 months of constitutional breakdown.

Closing on a hopeful note, Dr. Jitendra Singh hailed the entry of Shubhanshu Shukla into space research, calling it a symbolic step toward India's ascent to the Viksit Bharat of 2047.

Among the distinguished guests were Vijender Gupta, Speaker of the Delhi Legislative Assembly Satyanarayan Former Union Minister; Rajat Sharma, Chairman & Editor-in-Chief of India TV; and Mohan Singh Bisht, Deputy Speaker of the Delhi Assembly.

"Bharatiya Nagarik Suraksha Sanhita", laid emphasis on the powers and working of Executive Magistrate with police at the time of attachment of property of absconding accused, also with regard to the dispute of immovable property in case of breach of peace.

He also highlighted the law relating to public nuisance and the remedies available under BNSS, procedure relating to apprehended danger and imposing of curfew by competent authority, powers in inquest proceeding and laws relating to test identification parade.

SRINAGAR: In a significant stride towards transparent land records management system, Chief Secretary Atal Dulloo on Saturday chaired a meeting to review the ongoing digitization and modernization of land records across Jammu & Kashmir.

The meeting saw the participation of key officials including Secretary, Revenue; Secretary, IT; Secretary, Law; CEO, JaKeGA; Director, Land Records; a representative of BISAG-N; and other concerned officers.

Commissioners Deputy joined the meeting virtually from their respective offices.

The Chief Secretary while emphasized the paramount importance of quality assurance in the digitization process. He stressed the need for a robust system of checkers and approvers for data entries made by the field staff. This will ensure that every entry is meticulously cross-checked with corresponding physical records by the experienced revenue officers. He observed that the correctness of records ensures fewer grievances and fewer court cases, thereby saving the time and energy of both people and public servants.

Dulloo highlighted the far-

and real-time, transparent sea-

sonal crop monitoring. He also underscored the critical need for capacity building for the additional staff deputed for this technical work. He directed for repeated hands-on training sessions to ensure a full understanding of the assignment's nuances for these

To facilitate seamless data entry, the Chief Secretary instructed the Deputy Commissioners to establish a dedicated, fully equipped data entry centers in their districts, complete with sufficient computers, reliable internet connectivity and power backup.

He also directed for exploring the possibility of deputing another team of Survey of India to Srinagar so that field staff from Kashmir Division do not have to shuttle between Jammu and their places of posting for carrying out rectifications or other updations while doing geo-referencing of cadastral maps of their revenue villages.

Secretary Revenue, Kumar Rajeev Ranjan, presented a detailed overview of various components driving this modernization, including the Digital  $\,$ Land Records Modernization Programme (DILRMP), Survey Of Villages And Mapping With Improvised Technology In Village Areas (SVAMITVA), geospatial Knowledge-based land Survey of urban Habitations (NAKSHA) and generation of Unique Land Parcel Identification Numbers (ULPIN).

He gave out that for digitization of RoRs the necessary software customizations for local adoption have been completed and the User Acceptance Testing (UAT) committee is currently evaluating the software. The portal is slated to enter the production stage after July 1st, 2025, and will be live for data entry by July 10th, 2025, he informed.

The Secretary further added that in order to support this mammoth exercise across the 6,850 revenue villages, the department has already trained 244 Master Trainers, 1.253 Patwaris and 1.053 MTS/other staff. Furthermore, 7,000 User IDs for Patwaris/MTS for data entry had been created and a monitoring dashboard is under development, expected to be ready by July 10th, 2025.

Under the SVAMITVA pro-

gram, the meeting was apprised, that 4,368 out of 4,395 villages have been surveyed by the Survey of India. Ground truthing is ongoing, leading to the eventual generation of property cards by respective Tehsildars for occupants. Additionally it was given out that the one-vear pilot NAKSHA program is going to be implemented in over 100 cities nationwide, with the Survey of India as the technical partner under DILRMP. In J&K, Bishnah and Katra in Jammu Division and Awantipora and Pattan in Kashmir Division have been selected for this project. Rovers will be purchased/hired for ground surveys, leveraging the CORS network of the Survey of India. ULPINs, a 14-digit unique alpha-numeric identifiers, are being generated for land parcels surveyed under SVAMITVA prior to property generation. These ULPINs provide the exact location, area and other land record credentials of each parcel. The meeting was apprised

that 5,23,998 ULPINs have been generated across the UT in 1.718 villages, so far, marking a significant step towards creating a truly unique and verifiable land records system in J&K.
