SPECIAL CONDITIONS:-

- (i) Security deposit shall be deposited by the contractor within 07 days of issuance of LOI failing which the concerned tender issuing authority shall forfeit the EMD and recommend contractor for blacklisting and issue a fresh tender forthwith.
- (ii) The contractor shall initiate the work within a 07 days of entering into the agreement, failing which the concerned Executive Engineer shall terminate the contract and issue a fresh tender after imposing penalties viz. forfeit security /LD as per T&S of the BID document and recommended contractor for blacklisting.
- (iii) The work shall be completed by the concerned contractor as per the timeline stipulated in BID document/agreement, failing which action shall be initiated against contractor by forfeiting EMD and shall be recommended for blacklisting.
- (iv) For macadamisation works under City & Towns / Pot Holes Free Roads, all contractors having class A/B/C/ Hot Mix Plant Holder registration cards other than Hot Mix Plant (HMP) Owners have to upload an undertaking stating therein the e NIT No. Name of the work and source of procurement of macadamisation material (within 40 kms from the work site), failing which the bid of such contractors shall be considered as non-responsive as per the Circular issued by the Development Commissioner Works Civil Sectt. Jammu/Srinagar vide No.PW/DCW/DB/505-510/22 dated 10-05-2022.
- (v) If the contractor / firms fails to complete the work within the time mentioned in the NIT / Contract, then the allotted contract will automatically treated as cancelled after forfeiting the performance security of the contractor / firm and work put to fresh tender without serving any notice from this office.

Bids must be accompanied with cost of Tender document in shape of e-challan through Treasury indicating Treasury Voucher No. name of work e-NIT No. & dt: duly crediting to 0059 (Revenue) favoring Executive Engineer PWD (R&B) Division Billawar and upload the same i.e treasury challan Earnest money/Bid security in shape of CDR/FDR/BG pledged to Executive Engineer PWD (R&B) Division Billawar. The CDR/FDR/BG shall be valid for 45 Days beyond the bid validity period. The original instruments in respect of cost of documents, EMD and relevant documents of L1 be submitted to the Executive Engineer PWD (R&B) Division Billawar within 07 (Seven) days after the date of receipt of the Letter of Acceptance.
2. The electronic bidding system would not allow any late submission of bids after due date and time as per server time. Bidders may modify their bids by uploading their request for modification before the deadline for submission of bids. For this, the bidder needs not to make any additional payment towards the cost of tender document. For bid modification and consequential re-submission, the bidder is not required to withdraw his bid submitted earlier. The last modified bid submitted by the bidder within the bid submission time shall be considered as the bid. For this purpose, modification/withdrawal by other means will not be accepted. In online system of bid submission, the modification and consequential- submission of bids is allowed any number of times. The bidders may withdraw his bid by uploading their request before the deadline for submission of bids; however, if the bid is withdrawn, the re-submission of the bid is not allowed. No bid shall be modified or withdrawn after the deadline of submission of bids.
3. The date and time of opening of Financial-Bids shall be notified on Web Site www.jktenders.gov.in and conveyed to the bidders automatically through an e-mail message on their e-mail address.
