This is to inform all stakeholders, business owners, and private establishments in District Samba that significant reforms have been introduced by the Administrative Secretary, Labour and Employment Department, J&K, through Circular No. 02 of JK (L&E) of 2025 dated 28.04.2025, aimed at streamlining processes and enhancing ease of doing business.

Key Highlights of the Circular:

1. Simplified Registration & Renewal Process:
Effective immediately, the registration and renewal of Form-C under the J&K Shops and Establishment Act, 1966 shall be granted without any prior inspection.
 2. One-Day Registration: The final registration certificate will be issued within one day from the date of application submission.
 3. No Document Upload Required: There is no statutory requirement to upload any document for registration. Instead, a uniform Undertaking format (mentioned below) will be accepted for processing the registration.
 4. Post-Registration Inspection: While no inspection is required prior to registration, inspections may be conducted after registration as per departmental guidelines.
- These measures have been introduced to facilitate ease of business operations, ensure transparency, and improve public service delivery in Jammu & Kashmir.

- 1) The appointee shall report to Additional District Development Commissioner, Poonch within a period of 21 days from date of issuance of this order failing which his appointment shall be deemed to have been cancelled without any notice in terms of Circular No: 08-JK (GAD) of 2019 Dated 04.12.2019 issued by General Administration Department, J&K.
 - 2) The appointee at the time of joining shall produce following testimonials in original which shall subsequently be got verified by the concerned DDO from respective issuing authorities:
 - a. Domicile Certificate.
 - b. Date of Birth Certificate.
 - c. Qualification Certificate(s).
 - d. Relevant Category Certificate (if any).
 - e. Physical fitness certificate.
 - f. Any other certificate required under rule.
 - 3) That if the appointee has taken loan for self-employment from DIC/Employment Department, to be ascertained from the District Industries Centre (DIC) and District Employment & Counselling Centre of the Domicile District, he shall relinquish the proprietorship of unit/enterprise and also stakes, if any, in such self-employment unit/enterprise before joining the Government service. He shall be required to repay the entire loan liability in suitable EMIs to be worked out by the DDO concerned from his salary. DDO concerned shall obtain an affidavit from the concerned appointee regarding both relinquishment of proprietorship and stakes, if any, in such a self-employment unit/enterprise and recovery to be made and also personally monitor its recovery.
 - 4) That appointee shall give an undertaking in the shape of an affidavit to the effect that if on verification, his Qualification/Date of Birth/Category Certificates, if any, from the concerned issuing authority are found to be fake/forged, the claim of the appointee for appointment as Junior Assistant, shall be deemed to have been cancelled ab-initio and legal action as warranted under rules shall be initiated against him.

In reference to Enit's issued under No:-01,02,03,04,05,06 & 07 Dt:-24-05-2025 the following special conditions are included as under:-

a. Additional performance security for successful bids:-

The successful bidder shall have to deposit as Additional Performance security in the shape of CDR/FDR only before award of contract (within 05 days after opening of financial bid), in case bid of the successful bidders is found to be un-balanced and the following scale shall apply thereto:-
