Census 2021 was also proposed to be conducted in two phases with phase I durng April-September 2020 and the second phase in February 2021.

All preparations for the first phase of the Census to be conducted in 2021 were completed and the fieldwork was scheduled to begin in some States/UTs from April 1, 2020. However, due to the outbreak of the COVID-19 pandemic across the country, the census work was postponed.

The government recently decided that it will carry our caste enumeration along with the census. It will also be the first digital census giving the citizens an opportunity to self-enumerate.

The entire Census exercise is likely to cost the government over Rs 13,000 crore. A meeting of the Union cabinet on December 24, 2019, approved the proposal for conducting the Census of India 2021 at a cost of Rs 8,754.23 crore and updating the NPR at a cost of Rs 3,941.35 crore.

However, the Budget 2025-26 allocated just Rs 574.80 crore for census surveys and statistics/the Registrar General of India (RGI).

A government functionary said the budget was a minor issue and could be sorted out without any impediment.

On April 30, the Cabinet Committee on Political Affairs chaired by Prime Minister Narendra Modi decided to include caste enumeration in the upcoming

The decision demonstrated that the Modi government is committed to the holistic interests and values of the nation and society, an official statement issued by the

government on April 30 said. According to Article 246 of the Constitution, the Census is a subject listed at 69

n the Union List in the Seventh Schedule. While some states have conducted surveys to enumerate castes, these surveys have varied in transparency and intent, with some conducted purely from a "polit-

cal angle, creating doubts in society", the government had said. "Considering all these circumstances, and to ensure that our social fabric does not come under political pressure, it has been decided that caste enumeration should be included in the main census instead of being conducted as a separate survey,

the statement said. This will ensure that society becomes stronger economically and socially, and the country's progress continues without hindrance. It is noteworthy that when a provision of 10 per cent reservation was made for the economically weaker sections of

society, it did not create tension in any section of society, it said. Caste was excluded from all census operations conducted since independence.

Train to Kashmir...

According to special documents from the Jammu and Kashmir archives department, the idea of a rail link to Kashmir was first proposed on March 1, 1892 by the Maharaja. Subsequently, in June 1898, British engineering firm S R Scott Stratten and Co was engaged to conduct surveys and execute the project

The first report, submitted by D A Adam, recommended an electric railway between Jammu and Kashmir regions, featuring steam locomotives on a narrow two-feet-six-inch gauge line. This proposal was rejected due to the challenging ele-

Another proposal, submitted in 1902 by W J Weightman, suggested a railway line connecting Kashmir from Abbottabad (now in Pakistan) along the Jhelum river. This, too, was turned down.

The third proposal, by Wild Blood, recommended a railway alignment along the Chenab river through the Reasi area. This report was approved.

Later, plans for powering electric trains and establishing power stations near Udhampur, Ramsu, and Banihal were also examined but ultimately rejected.

Following this, British engineer Col D E Bourel was tasked with submitting a detailed report on local coal reserves. Additionally, a report was commissioned from T D La Touche, the then deputy superintendent of the Geological Survey of India, on the Sangarmarg and Mehowgala coal mines.

In December 1923, S R Scott Stratten and Co was re-engaged to implement the coal extraction project. However, the death of Maharaja Pratap Singh in 1925 and the growing Indian independence movement led to the project being shelved permanently, the documents said.

The idea was revived nearly six decades later, when the then prime minister Indira Gandhi laid the foundation stone for the Jammu-Udhampur-Srinagar railway line in 1983. At the time, the project was estimated to cost Rs 50 errore and vas expected to be completed in five years, officials said.

However, in 13 years, only 11 km of the line could be constructed, which comorised 19 tunnels and 11 bridges - at a cost of Rs 300 crore, they said.

It was followed by the broader Udhampur-Katra-Baramulla railway project, estimated at Rs 2,500 crore, which saw its foundation stones laid by prime ministers H D Deve Gowda and I K Gujral in 1996 and 1997 at Udhampur, Qazigund, and Baramulla.

Construction began in 1997 but faced repeated delays due to challenging geologcal, topographical, and weather conditions, significantly inflating the cost to over

Recognising the strategic importance of the Udhampur-Srinagar-Baramulla Railway Line (USBRL), it was declared a national project in 2002, the officials

Out of the 272 km stretch, 209 km has already been commissioned in phases including Qazigund-Baramulla in 2009, Banihal-Qazigund in 2013, Udhampur-Katra in 2014, and Banihal-Sangaldan in 2023. The final stretch connecting Katra to Sangaldan has completed the link in February 2024, they said.

The engineering marvel includes 38 tunnels and 927 bridges along the Kashmir rail project. The highlight is the Chenab bridge, standing 359 metres above the riverbed which is 35 metres taller than the Eiffel Tower making it the world's highest railway arch bridge, they said.

"The Kashmir train project, once just a royal vision, now stands as a symbol of national integration and engineering excellence", an official said.

To support construction in the rugged, militancy-affected terrain, more than 215 km of approach roads were built, many in areas previously accessible only by foot

This improved infrastructure has transformed the lives of approximately 1.5 lakh people in 70 remote villages such as Dugga, Surukot, Sawalkot, Khari, and Hingni. These areas have seen the emergence of marketplaces, eateries, and repair shops, significantly boosting local livelihoods, the officials said.

Srinagar man dies...

The source said, "The man had sustained a head injury, which led to his death. Investigation revealed that he had inflicted the injury on himself, and died due to a deep wound and excessive bleeding.

The person claimed that the man was not mentally stable. However, an FIR will be filed if anything foul is found, he said.

Meanwhile, the J&K Students' Association in a press statement demanded a probe into the death.

"We demand a swift, transparent, and time-bound investigation into the mysterious and tragic death of 30-year-old Kashmiri youth, Zubair Ahmed Bhat, in New Delhi. He was a resident of Sehyar Ali Kadal in Srinagar, reportedly died under suspicious circumstances in a public park in the national capital on Monday," the outfit said in its statement.

Its national convenor, Nasir Khuehami, said, "The incident raises serious concerns and demands answers. We urge the Delhi Police to investigate all possible angles, including the possibility of foul play. The findings must be made public."

He also appealed to Delhi Chief Minister Rekha Gupta to personally oversee the investigation and ensure accountability.

"The silence and delay from authorities only deepen the sense of fear and mistrust. The circumstances of Zubair's death are unclear, and the lack of clarity is deeply disturbing. A fair and honest investigation is the bare minimum owed to the deceased and his grieving family," Khuehami said.

Ummar Jamal, the outfit's president, said, according to his family, Zubair was assaulted by the locals where he was staying, and there are screenshots of chats proving there was an attack.

He claimed Zubair had come to Delhi to receive a guest and lost contact with them around 4 pm on Monday.

"He used to travel frequently to Delhi for work-related matters," Jamal said, quoting a member of Zubair's family.

Teacher arrested for...

Perusal of the material on record reveals that the accused is involved in a wellorchestrated criminal conspiracy whereby he impersonated himself as a person with high-level connections in the Civil Secretariat and Education Department.

He deceitfully induced the complainant and his family into paying huge amounts of money on the false assurance of providing government jobs. Forged appointment letters and other fabricated documents were supplied to bolster the deceit the material collected during investigation prima facie indicates that the accused is not only a repeated offender but has made crime a profession, having more than ten FIRs registered against him on similar allegations.

Furthermore, the investigation is at a crucial stage, where recovery of forged documents, identification of co-accused, and seizure of electronic gadgets used for fabrication of fake appointment letters is still underway.

Granting bail at this juncture may result in tampering with evidence and influencing the witnesses. In view of the serious nature of allegations, the habitual conduct of the accused, and in light of the bar under Section 437(1) CrPC, this Court is of the considered opinion that no case is made out by applicant/accused for grant of bail at this stage. This application therefore has no merit and is dismissed as

India wins presidency...

Following the hearings, the candidacy of India, South Africa and Austria was forwarded to the General Body of IIAS for the next round by the Council of Administration, according to the statement issued by the Personnel Ministry. South Africa withdrew its candidacy in May 2025.

The election was held between India and Austria on June 3, in which 141 votes were polled, of which India registered 87 votes (61.7 per cent of the vote), and Austria registered 54 votes (38.3 per cent of the vote), it said, adding that "India's candidacy received widespread support from across the membership".

This is the first time in the 100 years history of IIAS that the election to the post of president was held by ballot process and it is the first time that India has secured the historic mandate for the presidency of the IIAS, the statement

In his acceptance speech delivered via video conferencing on Tuesday, Srinivas said the country's presidency will be an inclusive one which will seek to bridge the north-south divide. 11 dead, 33 injured in stampede near Bengaluru cricket stadium

BENGALURU: Eleven people died and 33 injured following a stampede near the Chinnaswamy Cricket Stadium here, where a large number of people gathered to participate in the RCB team's IPL victory celebrations, Karnataka Chief Minister Siddaramaiah said on Wednesday.

Expressing grief over the incident, calling it an "unexpected tragedy", he announced Rs 10 lakh as compensation to the kin of all those deceased, while also ordering a magisterial inquiry into the incident.

The Karnataka state cricket association had organised a programme for the vic tory celebration (at the stadium), there was also a programme from the government (at Vidhana Soudha). At the Chinnaswamy Stadium, a big tragedy happened. Due to the stampede, 11 people have died and 33 have suffered injuries," Siddaramaiah

Speaking to reporters after visiting the Bowring and Lady Curzon Hospital and Vydehi Super Speciality Hospital here, he said such a tragedy shouldn't have hap pened. The government expresses grief over the incident.

Stating that most of the deceased are youth, including men and women, with sev eral of them being students, the CM said the government has announced Rs 10 lakk compensation to the kin of each deceased. Instructions have been given to provide free treatment for the injured, he said, adding that the total number of injured including those who have been treated as outpatients and discharged, is 47.
