**Circular No. 06-JK(RD&PR) of 2025**

**Dated: 29.05.2025**

Whereas, in the year 2015. Final Seniority List of Block Development Officers as it stood on 01.10.2015 was issued vide Government Order No. 296-RD&PR of 2015 dated 28.10.2015; and

Whereas, in the year 2022. DPC/PSC cleared the regularization proposal in respect of 71 Panchayat Inspectors & equivalent/Headquarter Assistants ( I/c Block Development Officers) against the post of Block Development Officers. Out of which the regularization/promotion order in respect of 27 (viz. 20 Panchayat Inspector-I and 07 Headquarter Assistants) was issued vide Govt. Order No. 284-JK (RD&PR) of 2022 dated 17.10.2022; and

Whereas, the Commission also approved the regularization of 44 I/c Block Development Officers (viz. 37 Panchayat Inspectors-I & 07 HQA) on recommendation of the department vide (their communication No. PSC/DPC/RDD/37/2017 dated 09.09.2022, subject to the condition that the Department shall obtain the concurrence approval of the Competent Authority with regard their mode of acquisition of prescribed qualification, on case to case basis, as per the facts and circumstances associated with each case, before issuance of formal orders of regularization in their favour; and

Whereas, on the advise of the J&K Public Service Commission/Departmental Promotion Committee, the cases of all 44 recommended officials were examined in the Department on case to case basis and after obtaining verification/genuineness of the degree certificates (Graduation), along-with mode of acquisition of degree certificates. as acquired by these incumbents during the service without obtaining prior permission of the Competent Authority, have been received from the concerned Universities/Institution and it has emerged that:-

- 28 Officials require post facto permission as they have acquired their graduation qualification through distance/online mode without obtaining prior permission of the competent authority.
- 06 officials were found as borne graduate.
- one (01) official namely Mr. Gh Mohd Rather was expired on 10.03.2011 i.e. date prior to his retirement 31.05.2011, however, he inadvertently cleared by the PSC w.e.f. 01.05.2011 Accordingly, his regularization cannot be considered.
- 01 official also reverted back to his original post i.e. Panchayat Inspector vide Government Order No.162JK(RD&PR) of 2023 dated 13.03.2023 as his degree found fake.
- 01 official did her graduation through regular mode during in-service, as such her promotion as BDO could be considered.
- The genuineness/mode of acquisition in respect of 03 Officials namely Mohd. Ibrahim, Whead Iqbal and Sonam Narboo have not been furnished by the concerned Universities/Institutions.
- The degree certificate of 01 official on verification has been found that he was not enrolled under number 92461, as reported by the concerned University.
- Vigilance clearance in respect of 01 official namely Mr. Wali Mohd Bhat (Rtd) has been received, adverse against him.
- 02 Officials already got permission for acquiring higher studies (Graduation) from the administrative department.

Whereas, in the meanwhile. Department has received the verification-cum-bonafide degree certificates in favour of Mr. Whead Iqbal (Rtd) and Mohd Ibrahim from the concerned University and it has been intimated that the degree obtained by these incumbents are genuine on examination chart of the University and confirmed that the mode of Education is private, but their post facto permission is required to be sought from the competent authority before issuance of the regularization order.; and

Whereas, post facto permission/sanction as one time exemption w.r.t. acquiring higher qualification as graduation in respect of eligible 28 Panchayat Inspectors/Headquarter Assistants after seeking concurrence of the Finance Department. Department of Law, Justice & Parliamentary Affairs and General Administration Department has been issued vide Government Order No. 134-JK(RD&PR) of 2025 dated: 15.04.2025; and

Whereas, thereafter, the regularization/promotion order in respect of eligible 36 Panchayat Inspectors/Headquarter Assistants (I/c BDOs) has been issued vide Government Order No.157-JK(RD&PR) of 2025 dated: 01.05.2025.

Whereas. Tentative Seniority List of these 63 regularized Block Development Officers as on date is required to be prepared on the basis of the combined updated seniority list of Panchayat Inspector Grade-I & equivalent/ Headquarter Assistants of the Department of Rural Development and Panchayat Raj issued vide Government Order No. 321-RD&PR of 2021 18.11.2021, also taking into consideration, the date of promotional effect from which they have been cleared by the DPC/PSC and notified in terms of J&K Civil Service Rules (Classification. Control and Appeal) Rules, 1956.

Now. therefore, a tentative Seniority List of Block Development Officer(s) as on date is hereby notified/circulated forming Annexure to this Circular for information of the concerned members (retired/in-service) of the J&K Rural Development (Gazetted) services. The concerned members having any objection(s) with regard to the position assigned to them in the said list shall submit his/her representation along-with the documentary proof to this Department within a period 10 days positively from the date of issuance of this circular. No objection(s), if any shall be entertained after the expiry of prescribed period of time.
