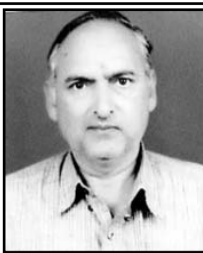

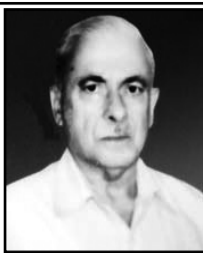

Engagement of ineligible ReT teacher: ACB presents chargesheet against beneficiary, officials of Edu Dept

SRINAGAR: The Anti-Corruption Bureau (ACB) on Monday presented chargesheet against officials of Education Department for engagement and regularisation of ineligible Rehbar-e-Taleem (ReT) teacher and the beneficiary namely Abdul Latif Khan, resident of Khanpora, Budgam.

The ACB presented chargesheet in case registered vide FIR No 16/2017 at the Police Station ACB under Section 5(1)(c)(d) read with 5(2) PC Act Svt 2006 of J&K Amendment Act 2014 and 120-B, 201, 420, 467, 471/RPC before the Court of Special Judge Anti-Corruption Court Srinagar against Abdul Latief Khan, resident of Khanpora, Budgam (beneficiary) and Gh Hassan Hakeem resident of Dangerpora Wadwan Budgam, Abdul Aziz Malla resident of Dooru Sobdan Budgam, Gh Nabi Shah resident of Palpora Budgam, Ravindar Kumar Raina resident of Kathwar Budgam, Noor Mohammad resident of Bathakh Pora, Nowshara Srinagar and Gh Qadir Misger resident of Haji Bagh Buchpora Soura Srinagar, all officials of Education Department. The instant case was registered by ACB on allegations that engagement and regularisation

of an ineligible Rehbar-e-Taleem (ReT) teacher was made on basis of fake and forged 10+2 marks certificates in Education Zone Hardapuznu, Budgam. The investigation found that one Abdul Latif Khan, resident of Khanpora, Tehsil Beerwa, District Budgam was engaged as Rehbar-e-Taleem (ReT) teacher in year 2000 at Primary School Batapora in pursuance to a conspiracy of then ZEO along with other concerned officers/ officials and accused beneficiary. After a gap of three years of accused beneficiary's engagement as ReT, his 10+2 marks certificate was confirmed fake by J&K BOSE, proving him ineligible for his initial engagement as ReT. In furtherance to conspiracy by then ZEO Hardapanzoo, the CEO Budgam processed and recommended regularisation of services of accused beneficiary as a General line teacher to DSEIK, from where a regularisation order was issued in favour of beneficiary, based on recommendations of the then CEO. All the accused, except two deceased persons, were presented before the Court of Special Judge Anti-Corruption Srinagar by the ACB for further legal action. Further trial of the case will proceed in due course.

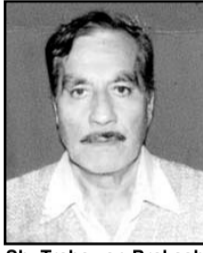

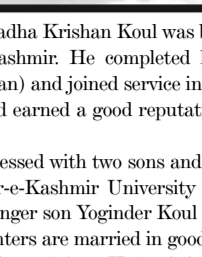

Pt Bansri Lal Koul, son of late Pt Radha Krishan Koul was born in August 1929 at Shala Kadal, 2nd Bridge, Srinagar, Kashmir. He completed his graduation from Punjab University Lahore (Now in Pakistan) and joined service in GAD. He served in different departments and at different stations and earned a good reputation in the department as well as in public.

He got married to Chuni Koul. He was blessed with two sons and two daughters. His elder son Dalip Koul, who was a Scientist in Sher-e-Kashmir University of Agricultural Sciences and Technology, Jammu, has expired. His younger son Yoginder Koul is a retired Inspector General of Jammu and Kashmir Police. His daughters are married in good families and are well settled. During turmoil in the Valley, the family migrated from Kashmir in 1990 and suffered heavy loss of property. The family reached Jammu and after staying in rented accommodation for some time, they settled in Bhawani Nagar, Talab Tillo, Jammu. He was a self-made person, very intelligent, efficient and honest officer. He was very gentle, kind hearted and positive person. He was very helpful to the poor and needy people. He retired from service in 1984 as a KAS officer. After his retirement he concentrated towards social activities for the welfare of Kashmiri Pandits. He wrote two books describing the exile and return of Kashmiri Pandits. His wife expired in 1993. He breathed his last on July 5, 2020 after a prolonged ailment. He is survived by his one son, two daughters and grand children. May God give eternal peace to the departed soul and courage to the family members to bear this irreparable loss.

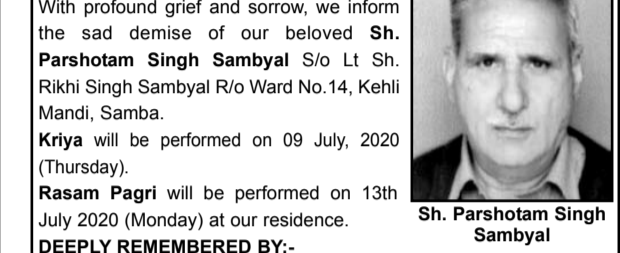
