CRIME REPORT

Man held for illicit distillation, 10 lts illicit liquor, 350 lts Lahan destroyed

JAMMU: In an act of alertness and prompt action, police on Wednesday nabbed a man for illicit distillation at village Kalyana and recovered 10 lts illicit liquor along with 350 lts Lahan, which was destroyed.

As per details, a team of Police Station Arnia constituted under the supervision of SDPO R S Pura Surinder Singh and led by SHO Arnia Inspr Devinder Singh assisted by Incharge Border Police Post Trewa PSI Pankaj Katoch while on patrolling duty at village Kalyana, Arnia received information regarding sale of illicit liquor. On this, police team reached the spot and recovered 10 lts illicit liquor and 350 lts Lahan from possession of accused namely Jarnail Singh, son of Manjeet Singh. He was arrested and FIR No. 65/2022 under relevant sections was registered against him at Police Station Arnia.

Missing man traced, reunited with family

JAMMU: Police on Wednesday traced a missing man and reunited him with his family.

As per details, a complaint was lodged at Police Post Bathindi by legal heirs of a person namely Ahmed Sheikh, son of Abdul Majeed Sheikh, resident of Bijbehara, Anantnag presently staying at Bathindi Morh, Jammu, stating that he went missing from his home. In this regard, a missing report was registered and investigation started.

On this, a team was formed under the supervision of SDPO East Syed Zaheer Abbas Jafari led by SHO Bahu Fort Inspr Nayat Ali assisted by Incharge Police Post Bathindi PSI Mohd Younis Khanday, which after putting in hectic efforts, traced the missing person. Subsequently, his family was informed and he was handed over to family members after completing all legal formalities.

Kidnapped minor girl rescued, accused arrested

JAMMU: Police on Wednesday rescued a kidnapped minor girl within 24 hours and arrested an accused.

As per details, a complaint was lodged at Police Station Domana by mother of a minor girl stating that her daughter has been kidnapped by some unknown person. On this, FIR No 247/2022 under sections 363 of IPC was registered and investigation started.

A team of Police Station Domana under the supervision of SDPO Domana Sunil Singh led by SHO Domana Inspr Tilak Raj, after putting in strenuous efforts, recovered the girl from possession of one Rohit Sharma, son of Satpaul, resident of Rahsaylote, Tehsil Chowki Choura, Jammu within 24 hours. The overall operation was done under supervision of SP Rural Sanjay Sharma.

3 gamblers arrested; stake money seized

Woman arrested under two FIRs in single day

She was brought to Police Station and booked under another case. She was arrested and sent to judicial custody of ten days.

Man electrocuted
