CRIME REPORT

Two thieves arrested, stolen cash recovered

POONCH: Police on Friday solved a theft case by arresting two thieves and recovered stolen cash amounting to Rs 26,000.

As per details, on May, 25, 2022 one Sanjay Kumar, son of Baldev Raj, resident of Ward-3, Poonch lodged a written complaint at Police Station Poonch stating that on May 24, two thieves namely Mukhtar Ahmed, son of Late Mohd Rafiq, resident of Ward-1, Poonch and Kouser Khan, son of Yousuf Khan, resident of Ward-2, Poonch entered his shop as customers and when his father went to bring some goods from another room, they took advantage of situation and decamped with cash bag from shop containing Rs 53,000.

Accordingly, FIR No. 101/2022 under sections 454/380 of IPC was registered and investigation of case was entrusted to PSI Rahul Angral. The Police team, after putting in hectic efforts, arrested accused as they were absconding after the incident. On their disclosure stolen cash amounting to Rs 26000 was also recovered. The arrest and recovery has been made by Insp Sureshwar Dev Singh SHO Police Station City Poonch assisted by PSI Rahul Angral under the close supervision of Nawaz Ahmed DySP Hqrs Poonch and Mushim Ahmed Adtl SP Poonch under overall supervision of SSP Rohit Baskotra.

31 bovines rescued, two smugglers arrested

JAMMU: In a massive drive against bovine smuggling, Police on Friday rescued 31 bovines during Naka checking at Domana Morh.

As per details, a special Naka was laid near Doana Morh by a team of Police Post Phallain Mandal constituted under supervision of SDPO South Sachit Sharma. The team led by SHO Police Station Satwari Insp Sameer Jeelani assisted by Incharge Police Post Phallain Mandal PSI Ajesh Singh Jamwal, during Naka duty apprehended a vehicle carrying 31 bovines. In this regard cognizance was taken by Police Post Phallain Mandal and two accused, identified as Hussain Ali, son of Mohd Sharief and Gafoor Ali, son of Hussain Ali, both residents of Sidhra were arrested.
