



Man arrested with 100 intoxicating capsules, 160 bottles of banned syrup

Police on Monday nabbed a man and recovered 100 intoxicating capsules and 160 bottles of banned syrup from his possession.

As per details, a team of Police Station Bahu Fort led by SHO Insp. Nayat Ali while on Naka duty rounded up a suspect. On search, 14 gm heroin was recovered from his possession. The accused, later identified as Faryad Ali, son of Ab Hamid, resident of Palperd Raghoda, was arrested and FIR No. 191/2022 under sections 8/21/22 of NDPS Act was registered at Police Station Bahu Fort. The whole operation was done under the supervision of SDPO East Syed Zaheer Abbas Jafari.



8 vehicles seized for illegal mining

JAMMU: In a quest to stern menace of illegal mining, a multi-pronged strategy was devised by Jammu Police in which police teams from Police Stations Akhnoor, Jhajjar Kotli, Arnia, Police Posts Phallain Mandal, Sainik Colony, Pounichak and

Chatha acted stringently on the specific inputs and raided at different locations in their respective areas and seized 8 different vehicles involved in illegal mining. The seized vehicles included a tractor trolley without registration number seized by Akhnoor police; a Tipper (JK11A-3851) seized by Jhajjar Kotli police; a tractor-trolley without registration number seized by Arnia police; 2 tractors without registration numbers seized by Phallain Mandal police; a Dumper (JK02CAV9503) seized by Sainik Colony police; a tractor trolley bearing Chassis no. MBNAALXBK-TF03932 seized by Pounichak police and a dumper (JK01AN- 5414) seized by Chatha police. The recoveries were made by SHO Akhnoor Insp. Hilal Azar, SHO Jhajjar Kotli Insp. Vikram Sharma, SHO Arnia Insp. Devinder Singh, Incharge Police Posts Phallain Mandal PSI Ajesh Singh Jamwal, Sainik Colony-PSI Bawani Singh, Pounichak-PSI Nitish Khajuria and Chatha-PSI Ranjit Singh in their respective jurisdictions.

JAMMU: In an act of alertness and prompt action, police on Monday nabbed two bootleggers and recovered of 58 bottles of illicit liquor from their possession.
