ORDER

It is to inform the following arms licenses that the provisions of the Arms (Amendment) Act, 2019 notified on 13th December, 2019 came into force on 14th December, 2019. As per the amended provision under section 3(2) of the Arms Act, 1959, a licensee in possession of more than two firearms is permitted to retain with him/her any two of such firearms and must deposit his remaining firearms with the Officer In-Charge of the nearest Police Station or with a licensed dealer or in a unit armoury if he is a member of the armed forces of the Union.

Whereas, an order was issued vide No. 902/DMJ/22 dated 28-06-2022 and also individual notice was issued to all the license holders under Jammu District with more than 2 (two) firearms to deposit the excess firearms in the nearest police Station within 1 (One) week.

Now, since holding of 3 (three) firearms is not permitted as per the law, the following licensees under District Magistrate, Jammu who are holding 3 (three) firearms, are hereby directed to deposit the third firearm with the Officer In-Charge of the nearest Police Station and get endorsement of the same on their licenses within One (1) weeks failing which the licenses shall be cancelled and necessary actions will be initiated as per provisions of Arms Act:-
