The, J&K Public Service Commission vide its Notification No: 08-PSC (DR-P) of 2021 dated 23.08.2021 invited online applications from the eligible candidates, domiciled in J&K, for 52 posts of **Physical Training Instructor**, in Higher Education Department;

During the scrutiny of the application forms, it has been found that some of the applicants have obtained higher qualification (Ph.D.) during active service.

Rule 73 of J&K Civil Service (Leave) Rules provides as under:-

Rule-73: Authority Competent to sanction study leave shall be as under:-

(1) *The concerned Administrative Department shall be competent to sanction the study leave under these rules within the State.*

(2) *The General Administration Department on the recommendations of the Administrative Department concerned and with the consent of the Finance Department may grant study leave under these rules for purpose of study outside the State within India.*

(3) *Cases for study leave outside India will be sanctioned by the Government on the recommendations of the committee prescribed for the purpose and with the concurrence of the Finance Department.*

In terms of the supra rule position a Government Servant has to seek prior permission from the prescribed competent authority for obtaining higher qualification.

Therefore, all such candidates who have obtained M.Phil. or Ph.D. during government service, irrespective of the fact whether they have applied as in-service candidate or not, shall furnish proof of the permission provided to them by the competent authority for pursuing higher studies. The permission shall be produced before the Commission within a period of 10 days failing which the qualification shall not be entertained.

"Issue notice. Petitioner is also permitted to serve notice on the respondents by service of summons on the respondents in SLP (C) Nos.20781-20789/2021. Tag with SLP (C) Nos.20781-20789/2021. Mr. Taruna A. Prasad, learned counsel accepts notice on behalf of the State of Jammu and Kashmir."

AND WHEREAS, the matters above-mentioned with Main Matter SLP(C) No. 20781-20789/2021 were listed before Hon'ble Court on 28th April, 2022, When the following order was passed inter-alia :-

"SLP(C) No. 3930-3932/2022 SLP(C) No. 4359-4364/2022

Learned counsel for the petitioner in both these cases prays that it may be permitted to effect service on the respondents by carrying out the substituted service by publication of notice in newspapers. When we asked the learned counsel for the petitioner as to whether in terms of the order issuing notice in this case, steps have been taken for effecting service in the normal and ordinary method, learned counsel does not dispute that no steps have been taken. We do not think that this is acceptable. When Court orders notice, it was incumbent upon the petitioner to take out notice in the normal and ordinary method. However, in the facts of this case, we order as follows:

The petitioner (J&K Subordinate Services Selection Recruitment Board and Chairman, J&K Services Selection Board) will take out notice as provided under the Rules. The petitioner is also permitted, in addition, to take out the notice by substituted service by publication in (a) Daily Excelsior (English daily) and Punjab Kesari (Hindi daily) having wide circulation across the Jammu region,

(b) The Greater Kashmir (English daily) and the Greater Kashmir (Urdu Daily) having wide circulation across the Kashmir region."

NOW, THEREFORE, TAKE NOTICE that the above petition with prayer for interim relief along with application for EXEMPTION FROM FILING C/C OF THE IMPUGNED JUDGMENT will be posted for hearing before this Court in due course and you may enter appearance before this Court either in person or through an advocate on record of this Court duly appointed by you in that behalf within 30 days from the date of service of notice. You may thereafter show cause to the Court on the day that may subsequently be specified as to why Special Leave Petition and Interim relief as prayed be not granted and the resultant appeal be not allowed.

Take Further Notice that the prayer for interim relief after notice will also be listed before the Court in due course.
