3. The Complete bidding process will be online.
4. The Technical bids & Financial bids uploaded on the website upto due date and same will be opened on 26-07-2022 (11.00 AM) in the office of the Executive Engineer Irrigation Division Udhampur in the presence of the bidders who wish to attend. If the office happens to be closed on account of holiday the date of opening of the bids as specified, the bids will be opened on the next working day at the same time and venue, or any other day convenient to opening authority.

6. Bids must be accompanied by bid security and cost of documents as mentioned in the above table in the form as specified in the bidding documents. The Cost of Tender amounting to Rs. 3000/- (Three Thousand) should be paid through Challan simply remitting into Treasury under MH: 0702 and uploading treasury Challan receipt along with Tender shall be pledged to Executive Engineer Irrigation Division Udhampur payable at Udhampur & earnest money in the shape of CDR/FDR shall be pledged to Executive Engineer Irrigation Division Udhampur & Shall be valid at least for 360 days from the date of opening of bids. Bids must be accompanied with cost of Tender document in shape of e-challan through Treasury indicating Treasury Voucher No. & date, e-NIT No. and name of work duly crediting to 0059 (Revenue) favoring Executive Engineer PWD (R&B) Const. Divn. No. II Jammu and upload the same i.e treasury challan/receipt, Earnest money/Bid security in shape of CDR/FDR/BG pledged to Executive Engineer PWD (R&B) Const. Divn. No. II Jammu. The CDR/FDR/BG shall be valid for 45 Days beyond the bid validity period. The original instruments in respect of cost of documents, EMD and relevant documents of L1 to be submitted to the Executive Engineer PWD (R&B) Const. Divn. No. II Jammu at the time of allotment.
2. The electronic bidding system would not allow any late submission of bids after due date and time as per server time. Bidders may modify their bids by uploading their request for modification before the deadline for submission of bids. For this, the bidder need not to make any additional payment towards the cost of tender document. For bid modification and consequential re-submission, the bidder is not required to withdraw his bid submitted earlier. The last modified bid submitted by the bidder within the bid submission time shall be considered as the bid. For this purpose, modification/withdrawal by other means will not be accepted. In online system of bid submission, the modification and consequential- submission of bids is allowed any number of times. The bidders may withdraw his bid by uploading their request before the deadline for submission of bids; however, if the bid is withdrawn, the re-submission of the bid is not allowed. No bid shall be modified or withdrawn after the deadline of submission of bids.
