Subject: Conduct of the J&K Combined Competitive (Preliminary) Examination, 2022-Rejection thereof.

NOTICE

Whereas, vide Notification No.08-PSC(DR-P) of 2022 dated:19.04.2022 online applications were invited from domicile of the UT of Jammu & Kashmir, for J&K Combined Competitive (Preliminary) Examination-2022, in accordance with SRO-103 of 2018 dated 23.02.2018 & J&K Public Service Commission (Conduct of Examination) Rules, 2022; and

Whereas, in response 34,126 online applications were received; and

Whereas, upon scrutiny of the online application forms, some deficiencies were noticed which needed to be rectified by the candidates before their applications are considered; and

Whereas, the Commission vide Notice. 29.06.2022 advised **220 candidates**, who have submitted online form for the post of J&K Combined Competitive (Preliminary) Examination-2022 and were found deficient, to submit the requisite deficient documents within a prescribed time (i.e by or before 08.07.2022). In response to which, **only 30 candidates** have submitted their deficient documents within the stipulated time and **rest 190 candidates** shown in Annexure A of this notice have failed to submit the requisite deficient documents or have submitted the documents, issued after the cut-off date i.e 26.05.2022.

Now, therefore, it is hereby informed that the candidature of the **190 candidates**, whose names are indicated in **Annexure A** to this notice, is hereby rejected on the grounds mentioned against each. However, they may prefer to file an appeal before the Appellate Authority of the Commission by or before **25.07.2022 (Monday) 04.00 P.M.** at J&K Public Service Commission, Office Solina Srinagar/Resham Ghar Colony, Jammu, with a valid proof in support of their claim, after which, no appeal, whatsoever, shall be entertained.

☛ The candidature of all the candidates appearing in the J&K Combined Competitive (Preliminary) Examination-2022 scheduled to be held on 31.07.2022, shall be purely provisional.

☛ Claiming eligibility by misrepresentation, concealment of any material fact(s) or impersonation or fraud, his/her candidature shall be cancelled and he/she will be liable to disciplinary action by the Commission.

☛ The Commission reserves the right to cancel the candidature of any candidate found ineligible at any stage of Selection Process at which such ineligibility shall be detected.
