Vilakshan demands assembly seats for PoJK Displaced persons

JAMMU: Vilakshan Singh President of J&K National Panthers Party has demanded that the displaced persons from Pakistan occupied parts of Jammu & Kashmir should be given at least 10 assembly seats out of 24 seats reserved for the areas of J&K under the illegal occupation of Pakistan.

Vilakshan stated that under section 14 of J&K Reorganization Act 2019, 24 seats have been kept reserved for the areas of J&K under illegal occupation of Pakistan and it has been laid down that these seats would be kept vacant till the areas under illegal occupation of Pakistan cease to be so occupied. Singh said that in democracy representation in the assembly is to be provided to the people and not to the land, mountains and rivers. He said that people who have been displaced from PoJK are enti-

tled to elect their representatives in the assembly and their right to do so cannot be denied to them merely because the government is not able to get their areas vacated from illegal occupation of Pakistan.

Vilakshan said that successive governments have failed to address this genuine demand of PoJK displaced persons. He said that BJP government has also taken the stand similar to that taken by the Kashmir centric political parties in this regard and has not provided representation to displaced persons from PoJK in the assembly.

Singh demanded that J&K Reorganization Act 2019 should be amended and the displaced persons from PoJK should be given right to elect atleast 10 MLAs in the assembly so that they can get due representation in the assembly.
