Forced return & rehabilitation of Kashmiri Pandits unacceptable

It is said that 'Janani Janam Bhoomi Swarg Se Mahan Hai' and place of birth and motherland is sweet for all people and so Kargil land that Kashmir is, is very attractive for the uprooted Kashmiri Pandits. Majority of Kashmiri Pandits and all the package employees long for their return, rehabilitation and resettlement in Kashmir which is the place of their birth. Kashmiri Pandits want to return to Kashmir on their terms and conditions, but Government should not force them to return to Kashmir under the present conditions as the PM package employees and Jammu-based government employees posted across Kashmir are being targeted and killed by so-called crusaders of Jihad and ground conditions and the situation is not feasible and conducive for return and rehabilitation of the Kashmiri Pandits including PM package employees in Kashmir valley and therefore powers should not force the Kashmiri Pandits in general and the package employees in particular to return, live and work in Kashmir were their members were killed in the line of their duty and the package employees are warned not to venture in Kashmir and otherwise face serious consequences if they dare to enter the Kashmir valley. In such precarious atmosphere the government should not force the Kashmiri Pandits and the package employees to return to Kashmir. In fact the ground situation in Kashmir resembles the hay days of the terrorism of 1990 when the terrorism was at its zenith and many Kashmiri Pandits were killed and others were left with no option but to leave the valley for the safety, security and dignity of their life. The present conditions are similar to the conditions of the terrorism of 1990 and in the same manner the Pandit and other Hindu minorities as well as the package employees were killed to scare them so that they were forced to leave the valley for their safety and survival. The plan and policy of the return and rehabilitation of the Kashmiri Pandits which includes the return of the package employees as well is a pious policy but it should not be implemented in hurry and haste as doing it in haste will prove

counterproductive and defeat the very purpose of the return and rehabilitation policy. In the past thirty two years of the migration of the Kashmiri Pandits, the successive centre and state governments failed to rehabilitate even one family of the uprooted Kashmiri Pandits in Kashmir. It implies that the government is not serious about the return and rehabilitation of the Kashmiri Pandits including the package employees but only is using the Kashmiri Pandits as a vote catching device in the elections outside the Kashmir valley. It seems that the government is making use of the Kashmiri Pandits as a use and through policy and this has complicated the genuine return and resettlement of the Kashmiri Pandits in Kashmir. The government is doing experimentation with the Kashmiri Pandits as if they are the laboratory products and the government should stop to do experimentation with the exiled Kashmiri Pandits. The package employees most of them have fled Kashmir due to the targeted killings of their co-employees and because of the threat perception and an atmosphere of panic and fear and are camping in Jammu for the safety and survival of their lives. These unfortunate and hapless package employees are protesting for the last over two months in the office of Relief and Rehabilitation Commissioner Migrants canal road Jammu and at times are also protesting for their only and genuine demand of their relocation/shifting to Jammu division, but unfortunately the BJP led NDA government and the LG administration is paying a deaf ear towards the striking package employees, with the result the package employees are forced to continue their indefinite protest for the only demand of their relocation. It is very queer and unfortunate that the government has given incorrect figures and data in Raj Sabha on uprooted Kashmiri Pandits and it has said that no migration of Kashmiri Pandits has happened from the date of the abrogation of article-370 that is from 5th August 2019 and 118 civilians had been killed by the terrorists during the period. There statistics are a sheer concoction and has no relevance with the actual facts. The fact is that

the majority of package employees and some families of Kashmiri Pandits have migrated post abrogation of article 370. The MoS Home Nitayand Rai has in a written reply to a question of congress MP Digvijay Singh in Raj Sabha said that from August 5, 2019, till July 9, 2022, almost 128 security force personnel and 118 civilians were martyred by terrorists in Jammu and Kashmir. These statistics are true and it shows that there is no normalcy in the disturbed Jammu and Kashmir where people including Kashmiri Pandits and other minorities have been killed during the period mentioned by the MOS home and the fact is that the targeted killings of the Kashmiri Pandits and other minorities continue in Kashmir. The MoS Home has further said that 5500 Kashmiri Pandits were appointed post abrogation of article 370 but there is no truth in this data. The fact is that about 3,000 Kashmiri Pandit youth have joined duty before the 5th of August 2019 and some odd 1400 have been appointed post abrogation of Article 370. It is so sad that the government is painting a rosy picture of the situation in Kashmir while the ground reality is far from the assertions of the government about the so called normalcy. The normalcy balloon of the BJP led NDA government has punctured by the killings of the security forces and the civilians. So for as the return and rehabilitation of the Kashmiri Pandits including package employees is concerned, the government should hold talks with the Kashmiri Pandit leaders before embarking on the policy and plan of their return and rehabilitation. Thus the main stakeholders - the Kashmiri Pandit leaders should be consulted on the plan and policy of their return and rehabilitation. The plan and policy of the rehabilitation of the Kashmiri Pandits will be successful only when the leaders of the exiled community are consulted and their views are taken into consideration. Thus the return and rehabilitation of the Kashmiri Pandits in Kashmir should precede the much needed deliberations and discussions with the Kashmiri Pandits so that the plan and policy of the rehabilitation will be successful. The government should realize that the living of

Good governance dimensions changing in J&K

Good Governance is must for the development of any concerned society. The Jammu and Kashmir in the past 7 decades has lagged in the good governance realms, especially till the article 370 was functional. Article 370 had ensured that rotten structures remain in place in Jammu and Kashmir. The concept of accountability was nowhere in the good governance as nepotism and corruption was rampant. With the abrogation of article 370 the good governance has flourished in roots. The good governance is concerned with structure and processes for decision making, accountability, control and behaviour at top of an entity. Governance influences how an organisation's or the government's objectives are set and achieved, how risk is monitored and addressed and how performance is optimised. The statistics with reference to good governance in Jammu and Kashmir show results clearly. In this regard, Good Governance Index (GGI)-2021 indicated that Jammu and Kashmir has registered an increase of 3.7 percent in Good Governance Indicators over the 2019 to 2021 period. Over the past two years, the Administrative Reforms and Public Grievances, DARPAG has successfully collaborated with Government of Jammu & Kashmir in adoption of e-Office, capacity building programs for JKAS officers, as well as integration of JK-IGRAMS with District Portals. DARPAG also conducted three regional conferences on replication of good governance practices in Jammu and Kashmir.

The District Good Governance Index of Jammu & Kashmir was released virtually by the Union Home Minister, Amit Shah in presence of Union Minister Jitendra Singh and the Lieutenant Governor of Jammu and Kashmir, Manoj Sinha. The composite ranking of first ever District Good Governance Index (DGGI) Jammu district had managed to top the list followed by districts of Doda, Samba, Pulwama and Srinagar in Union Territory.

It was the egoism of Duryodhana that the great Mahabharata War was fought which had caused untold and unaccountable deaths and destruction. Lord Shri Krishna, Bhisham Pitamah and many others had counseled Duryodhana against the war but he remained adamant and became the cause of annihilation of the entire Kaurava clan. The rude and aggressive attitude of the Government officials had been before the abrogation of article 370 been a big challenge to ensuring the good governance.

Now, full focus has been to ensure that the Government officials ensure people friendly attitude towards the masses especially when they visit the government offices for their work. The corruption tag of Jammu and Kashmir had hit hard the reputation of every department in Jammu and Kashmir, the only thing before that abrogation of article 370 was that Jammu and Kashmir is among the top corrupt states of India. Cracks on illegal funding by the Government has ensured good governance, goes to credit of both the Centre and the Union Territory of J&K that they have taken concrete steps to weed out corruption as well as put an end to illegal receipt of money through 'Hawala' that inimical forces were sending across for destructive activities.

Good governance has been at the core of the NDA lead Government by Prime Minister Narendra Modi. As a matter of the fact, Good Governance Day (Su?san Divas) is

was established in India in 2014, to be observed annually on December 25, the birth anniversary of former Prime Minister Atal Bihari Vajpayee, with a view towards fostering awareness of accountability in government. Experts on ground are ensuring that in Jammu and Kashmir with reference to good governance the transparency is ensured to fullest that ensures people of Jammu and Kashmir understand and have access to the means and manner in which decisions are made, especially if they are directly affected by such decisions. Sustainable development goals are at the heart of ensuring good governance. In this context, aiming at localization of the Sustainable Development Goals (SDG) along with other states and Union Territories, J&K, after the District Indicator Framework (DIF), is now planning to put in place the SDG dashboard including the SDG Index to ensure monitoring of the implementation.

The Sustainable Development Goals (SDGs), also known as the Global Goals, were adopted by the United Nations in 2015 as a universal call to action to end poverty, protect the planet, and ensure that by 2030 all people enjoy peace and prosperity. The Government of India has taken SDG actively in ensuring good governance. In its report titled, 'The Indian Model of SDG Localization,' which deliberates on the sub-national action to meet the SDGs, the experiences from States and Union Territories in India, NITI Aayog, while highlighting the SDG monitoring, said that J&K has shortlisted 206 monitoring indicators covering 81 targets for UT level monitoring. The people are urging the government to continue focus on the good governance dimensions in Jammu and Kashmir. It is the thrust area of the Government in Jammu & Kashmir that the information on good governance must be provided in an understandable and accessible format, typically translated through media, which is healthy sign for future.

PM package employees' conundrum

Govt giving significant push to
hydroelectric power generation across J&K
Projects of more than 6,300 MW capacity in
pipeline to make J&K power surplus

J&K government is giving a significant push to generation of hydroelectric power with projects of more than 6,300 MW capacity in pipeline for making UT of J&K power surplus. To improve the current power capacity substantially, J&K has initiated a large-scale capacity augmentation programme. In 70 years, J&K was able to harness only 3,500 MW, and now generation capacity is set to be doubled in four years and tripled in seven years.

Since August 2019, 2451 MVA has been added to the total capacity as compared to the 8394 MVA capacity achieved in seven decades. J&K Government launched various initiatives to strengthen and improve power infrastructure in UT which had remained dilapidated for the last several decades.

The decade-long overdue up-gradation of power infrastructure which was ignored by successive regimes is being done in a sustained manner.

According to a senior official, the present administration is eliminating the legacy of delays and all the languishing projects hanging for long are being completed in a record time. Prime Minister, Narendra Modi during his recent visit to J&K laid the foundation stone of Ratle and Kwar Hydroelectric projects. The 850 MW Ratle Hydroelectric Project will be constructed on Chenab river in Kishtwar District at a cost of around Rs 5300 crore.

The 540 MW Kwar Hydroelectric Project will also be built on the Chenab river in Kishtwar District at a cost of over Rs 4500 crore. Both the projects will help meet the power requirements of the region. According to official figures 3100 MW of power projects worth Rs 22315 cr were revised, accelerated and Memorandum of understanding of 3284 MW of projects worth Rs 29600 cr were signed. Pakal Dul Hydroelectric Project in Jammu & Kashmir cleared by cabinet for Rs 8,112.12 crore investment will help in reducing power shortage in the northern region. "Investment of Rs 8,112.12 crore for construction of the (4x250 MW) Pakal Dul Hydroelectric Project has been approved," an official said.

The project would help in reducing the power shortage in the Northern region and partly to utilize storage provisions of the Indus Water Treaty. It would also help in the socio-economic upliftment of remote areas of J&K.

Under a new scheme 'Revamped Distribution Sector Scheme' (RDSS), projects worth Rs. 11767 crore are approved to reduce AT&C losses and ensure 24x7 power availability. In a historic move to realise the goal of making Jammu and Kashmir self-sufficient in power sector, Ratle Hydroelectric Power Corporation Limited (RHPC) and Megha Engineering and Infrastructure Limited (MEIL) inked a contract agreement for the turnkey execution of 850-MW Ratle hydel project within a stipulated timeframe.

J&K has undertaken large-scale capacity augmentation programme in the power sector resulting in huge leap in power transmission and distribution capacity.

The new power generation projects like Ratle, Pakal Dul, Kiru etc, will bridge a major gap in the UT's electricity requirements. Similarly, 540 MW Kwar project being built at a cost of Rs 4526 cr would be completed by November 2026. Notably, in a significant step towards boosting renewable energy projects in J&K, in the Union Budget 2022, an allocation of Rs. 476.44 crore has been made as grants towards equity for 800 MW Ratle Hydroelectric Project and Rs 130 crore as grants towards equity for 624 MW Kiru Hydroelectric Project. It will boost energy transition and fight against climate change.

The distribution capacity is now 16,754 MVA, while as in 2019 it was only 12,745 MVA. The length of HT line is 45,101 which were 41,204 Ckms before 2019, while as length of LT line has increased from 79,754 to 96,017 Ckms from 2019 till date.
