Cop assaulted by youth

BISHNAH: A cop was assaulted was by some youth in Bishnah on Monday.

As per details, Sarvotam Dubey, posted in Digiana police post, lodged a complaint with police that when he was on way to pick his children from school, some youth in a car, stopped his way and started beating him, as he had overtook their car. He further stated that accused also brandished gun and later fled from the spot. Police is investigating the matter.

KVK theft case solved; 2 arrested, stolen items recovered

KATHUA: Police on Monday solved a theft case by arresting 2 thieves and recovered stolen items i.e., (a smart LED TV, a Laptop along with 2 Inverter Batteries) from accused.

As per details, on July 5, 2022 on complaint of Dr Vishal Mahajan Sr. Scientific Officer of Krishi Vigyan Kendra (KVK) Kathua, that few unknown persons after breaking door of KVK Kathua,

decamped with a smart LED TV, a Laptop along with 2 inverter batteries, FIR No. 265/2022 under section 457/380 of IPC was registered at Police Station Kathua.

Acting on tip off, a party from Police Station Kathua led by Insp O P Chib SHO Kathua under overall supervision of SSP Kathua R C Kotwal and supervision of DySP Headquarters Shammi Kumar arrested two suspects. During sustained questioning, the suspects confessed their crime and on their disclosure all stolen items were recovered. The accused were identified as Deepak Kumar and Ankush Kumar. Further investigation of the case is going on.

3 arrested, 3 vehicles seized for illegal extraction, transportation of minerals

BUDGAM: Acting tough against elements involved in illegal extraction and transportation of minerals, Police on Monday arrested 3 persons and seized 3 vehicles involved in crime.

As per details, officers from Police Post Soibugh at a checkpoint established at Wadwan Crossing Budgam intercepted three tippers loaded with illegally extracted soil. The vehicles bearing registration numbers JK01T-5151, JK01P-1657 and JK02-3061 were seized and the drivers, identified as Shabeer Ahmad Mir, son of Abdul Ahad Mir, resident of Russu; Irfan Akram Mir, son of Mohammad Akram Mir, resident of Budgam and Mohammad Yaseen Dar, son of Ghulam Mohammad Dar, resident of Russu were arrested. They were shifted to police station where they remained in custody. Accordingly, FIR No. 243/2022 under relevant sections of law was registered in Police Station Budgam and investigation started.

Theft case solved; 3 arrested, stolen items recovered

UDHAMPUR: Police on Monday solved a theft case by arresting three thieves and recovered stolen items viz. silver ornaments (Chattars), idol of Lord Krishna and Rs 27,000 cash from accused.

As per details, acting on complaint of one Mool Raj, son of Thakur Dass, resident of Ladana, Ramnagar that some unknown miscreants, after breaking lock of a temple near his house, decamped with money Rs 1.10 lakh approximately along with silver ornaments and idols of Lord Krishna and Mata Vaishno Devi. FIR No. 43/2022 under section 457/380/IPC was registered at Police Station Ramnagar. Acting on complaint, a party from Police Station Ramnagar led by Insp Pushpinder Singh under supervision of SDPO Ramnagar Dr Bhishm Dubey, conducted raids at dif-

ferent suspected locations and interrogated number of suspects. During sustained questioning of suspects, one of them namely Liaqat Ali, son of Mohd Iqbal, resident of Doda broke down and confessed his crime. He was arrested and on his disclosure, his other associates were also arrested, who were identified as Mohd Aslam, son of Bir Mohd, resident of Suneta Udhampur and Yaqoob, son of Mohd Ismail, resident of Basantgarh. Police team also recovered stolen items viz 19 silver ornaments (Chattars), idols of Lord Krishna and Rs 27,000 cash from possession of accused persons. It is pertinent to mentioned that 3 more accused namely Mohd Showkat, son of Mohd Iqbal, resident of Doda; Mohd Zakir, son of Mohd Nooranii, resident of Sunetar and Mohd Zavar, son of Kadir, resident of Ladana are still absconding. The arrests and recovery was made under the overall supervision of SSP Udhampur Dr Vinod Kumar.

Narco-smuggler nabbed with heroin, poppy straw

POONCH: Police on Monday arrested a narcotic smuggler in Surankote area and recovered 10 gm Heroin (Chitta) & 100 gm poppy straw like substance from his possession.

As per details, a team of Surankote Sub division headed by SHO Police Station Surankote Rajveer Singh under supervision of DySP Surankote Tanweer Jeelani and on direction of SSP Poonch Rohit Basketra, during routine Naka checking TCP Surankote intercepted a truck (JK12 0472) and on checking recovered 10 gm Heroin (Chitta) & 100 gm poppy straw from it. An unknown person jumped out from truck and fled away taking advantage of darkness whereas driver of truck was apprehended, who was identified as Anjid Ali, son of Mohd Nahiem, resident of Dhundak Surankot. FIR No. 220/2022 under sections 8/15/21/22/27(A) of NDPS Act was registered against him at Police Station Surankote.

Woman among two arrested with heroin

BARI BRAHMANA: Continuing its drive against menace of drugs, police on Monday arrested two drug peddlers including a woman and recovered about 4.5 gm heroin (Chitta) like substance from their possession.

As per details, a party of Police Station Bari-Brahmana led by SHO Bari Brahmana, Insp Rakesh Sharma under the supervision of SDPO Bari Brahmana Shivali Kotwal, while performing patrolling duty, intercepted two suspects, including a woman near Sarore Adda Gujjar Basti, Bari-Brahmana. On checking, approximately 4 gm Heroin (Chitta) like substance wrapped in a white-coloured polythene along with Rs 1,000 cash were recovered from possession of woman while 0.5 gm Heroin was recovered from male. Both accused, identified as Manohar Lal alias Mintu, son of Shambu Lal, resident of Saroon, Katra, District Reasi and woman (name withheld), resident of Sarore Adda, Gujjar Basti Bari Brahmana, District Samba, were arrested and a case under relevant sections of law was registered.

FIR No 137/2022 under sections 8/21/22/27 NDPS Act was registered against them at Police Station Bari-Brahmana.

Drug peddler nabbed with poppy straw

DODA: Police on Monday nabbed a drug peddler from Prem Nagar, Thathri and



recovered poppy straw from his possession.

As per a spokesperson, a party headed by PSI Rahul Verma while on patrolling/Naka duty in Prem Nagar area, intercepted a suspect and recovered 8 gm opium and 405 gm Poppy straw from his possession. The accused, identified as Vinay Kumar, son of Nanak Chand, resident of Udhampur, was arrested and FIR No. 83/2022 under relevant sections of law was registered at Police Station Thathri. The arrest and recovery were made under supervision of Insp. Amrit Katoch SHO Police Station Thathri and Abdul Ghafoor SDPO Bhadarwah.



Excise sleuths conduct raids; destroy 190 Kg Lahan, 2 lts illicit liquor, working still

RAJOURI: Excise Department destroyed 190 Kg Lahan and 2 lts of illicit liquor and a working still during different raids carried out to arrest menace of illicit distillation and sale of illicit liquor in excise range Rajouri Poonch.

Death toll in Ramban accident rises to 6

BANIHAL/JAMMU: The death toll in the accident in Jammu and Kashmir's Ramban district has gone up to six, with two more people succumbing to their injuries in the hospital, officials said on Monday.

Naseema Begum, 42, and Naza Begum, 45, had sustained serious injuries and they died in hospitals in Srinagar, the officials said.

Two other injured women are under treatment at GMC Hospital in Anantnag, they added.

Four people were killed and four injured when their vehicle skidded off the road and rolled down into a gorge in Jammu and Kashmir's Ramban district on Sunday.

The SUV fell into the 1,000-feet-deep gorge on a link road in Higni - Badarkoot belt in Ramsod, killing two people - Haza Begum and Abdul Rasheed - on the spot. Zahida Begum and Mustaq Ahmed, who sustained injuries, died in hospital.

BSF SI shoots himself dead

JAMMU: A Border Security Force (BSF) sub-inspector allegedly shot himself dead at a post along the India-Pakistan international border here on Monday, officials said.

Ramdev Singh was found lying in a pool of blood and his personal assault weapon was found by his side when a junior rank soldier reached his room around 6.35 am.

He belonged to the 12th battalion and was commanding a platoon of the BSF. He is suspected to have shot himself dead from his service weapon, officials said.

A police and a BSF court of inquiry are being conducted to ascertain the cause of the death, they said.

Singh hailed from Rajasthan's Sikar district.
