## Four narco-smugglers nabbed with heroin

JAMMU: Continuing drive against drug trafficking and substance abuse, Police on Wednesday nabbed four drug peddlers and recovered 21.5 gm heroin at different Naka in R S Pura and Akhnoor.

As per details, during patrolling/Naka duty at Daljeet Chowk R S Pura, police noticed 3 persons coming from R S Pura and moving towards Kotli Shah Doula, who on seeing police tried to flee. On this, a team of Police Station R S Pura constituted by SDPO R S Pura Surinder Singh, led by SHO RS Pura Inspector Rajesh Sharma assisted by PSI Devanshu Dutt apprehended them swiftly and after search, recovered 19 gm heroin from their possession.

The trio was identified as Shamp Din alias Pappy, son of Makhan Din, resident of Baispur Tehsil Suchetgarh (7 gm heroin); Aslam Choudhary alias Babbu, son of Imam Hussain, resident of Chak Mohd Yar, Tehsil R S Pura (6 gm heroin) and Narinder Singh alias Munna, son of Jagdish Singh, resident of Satriyan Tehsil Suchetgarh (6 gm heroin). They were arrested and FIR No. 150/2022 under sections 8/21/22/29 of NDPS Act was registered at Police Station RS Pura. The whole operation was done under supervision of SP Ramnath Gupta.

Similarly, at another Naka, established by a team of Police Post Jourian constituted under supervision of SDPO Akhnoor Varun Jandial and led by SHO Akhnoor Inspri Hilal Azhar assisted by Incharge Police Post Jourian PSI Karnail Singh, police rounded up a suspect namely Mohd Shahid, son of Mohd Mirza, resident of Village Jada, Tehsil Arnas, District Reasi at present Batiara Tehsil Kamhachak and recovered 2.5 gm heroin from his possession. He was arrested and FIR No. 219/2022 under sections 8/21/22 of NDPS Act was registered at Police Station Akhnoor.

## 8 bovines rescued, truck seized

JAMMU: Acting tough against bovine smugglers and to curb bovine smuggling menace, Police on Wednesday rescued 8 bovines at Nada area from a vehicle (JK02AP 9106) in jurisdiction of Police Post Manwal. In this regard, FIR No. 180/2022 under sections 188 of IPC, 11 of PAC Act, 50/52/54/56 of Transportation of Animals Rules of 1978 was registered at Police Post Manwal and investigation started. The arrests and recoveries were made by SHO Jhajjar Kotli Inspri Vikram Sharma assisted by Incharge Police Post Manwal PSI Ayub Khan under overall supervision of SDPO Nagrota Pardeep Kumar.

## 4 vehicles seized for illegal mining

## Excavator, 3 dumpers seized for illegal mining; Rs 4 lakh penalty imposed on PRL Company

KATHUA: Continuing action against illegal miners in ongoing rainy season, District Mineral Officer Kathua seized machinery and vehicles of a Project & Infrastructure Limited (PRL) company involved in illegal mining at Sahar Khad on Wednesday.

The Project and Infrastructure Limited (PRL) company had illegal excavated 1430 MTS of Nallah muck from Sahar Khad, using a heavy excavator and three dumpers for further transportation of minor minerals to site of ongoing four lane widening project. The excavator NO-VCEC200DL00250163 and dumpers (JK08H-7824, JK08G-6836 and JK08D-3839), after seizure, were handed over to police party led by SHO O P Chib. Reportedly, approximately Rs 4 lakh penalty has been imposed on the company as per rules of Geology and Mining Department. The company engineers and representatives were also called on the spot and instructed for not lifting material from Nallah, without any valid permission. Instructions were issued to company for applying for Disposal permits (DPs) and Short-Term Permits (STPs) wherever required for lifting Muck, Sand, Bajri etc, DMO said.

The Deputy Commissioner Kathua Rahul Pandey and Director Geology and Mining, Om Parkash Bhagat were immediately apprised about illegal excavation of 120 dumpers of Nallah muck by the company. The company was also assured by DMO that all possible support shall be provided for supplying construction material for ongoing road projects but illegal mining and excavation in river and Khads shall not be allowed at any cost.

## Involved in duping Baramulla resident of Rs 36.35 lakh, 2 Nigerian fraudsters arrested from New Delhi

SRINAGAR: Cyber Police Kashmir Zone, in its recent action against fraudsters, has arrested 2 Nigerian fraudsters from New Delhi involved in duping a man from Baramulla of Rs 36.35 lakh in an online scam.

Police received a written application from a resident of Baramulla alleging therein that while surfing on Facebook, he came in contact with some unknown fake Facebook user 'T Jessica', who impersonated herself as a purchase manager of a renowned pharmaceutical company Abbott. He further said that the woman enticed complainant through Facebook messages that she has been promoted as Secretary in her company and eventually asked the complainant to start a business of (Kandu Nut/Palm Seeds/Sea Nuts). The complainant got convinced/motivated by her fake offers, orders, high returns and emails etc to purchase said products.

Accordingly, the aforesaid Facebook user forwarded contact details of a seller namely Jyoti T Kandu to the complainant. A business conversation started between the complainant and fraudster Jyoti for selling/buying of Kandu nuts. The complainant was assured by fraudster that the said nuts are valuing quite high in the pharmaceutical market owing to their medicinal benefits. The complainant, without knowing the plot behind the fraud, invested a hefty amount of Rs 36.35 lakh by transferring the amount in different bank accounts of fraudsters for purchasing 50 packets of Kandu Nuts.

On receiving consignment of 50 packets of Kandu nuts, the complainant received a fake call from Mumbai Custom office wherein complainant was directed to deposit more money in order to sell Kandu Nuts to pharmaceutical companies. This created doubt in mind of complainant. The complainant then tried to contact on provided details in order to verify the facts, however he did not get any response and felt cheated/duped by Facebook user. The complainant then approached Cyber Police Station Kashmir Zone Srinagar and lodged a complaint. Accordingly, FIR No. 23/2022 under relevant sections of law was registered in Cyber Police Station Srinagar and investigation was set into motion. During the course of investigation, it was found that the fraud has been done by fraudsters under a highly technically built setup and accordingly the digital footprints of the accused persons involved in commission of offence were tracked by analysis of bank accounts, that have been used for siphoning off money of complainant. Besides, CCTV footages and analysis of suspect phone numbers by employing high-end technical investigative skills was also carried out. Subsequently, 2 Nigerians were found involved in the offences and were tracked at Vashist Park, Sagerpur, New Delhi under Police Station Sagerpur. Accordingly, on directions of ADGP Kashmir Zone Vijay Kumar a special team of Cyber Police Station Srinagar proceeded to New Delhi and after strenuous efforts and with the assistance of Delhi Police, the team was successful in nabbing 2 Nigerians national culprits namely Isioma Steven, son of Aliku and Collins, son of Onwudengor; residents of Delta Agbor, Nigeria and presently staying at Vashist Park, Sagerpur, New Delhi.

The rented accommodation was raided and thoroughly searched, after which incriminating material including 14 cell phones of different make and models, a laptop, 14 SIM cards, a Wi-Fi router, a Wi-Fi dongle, 6 debit/credit cards and 45 packs of Kandu nuts/palm-nuts were recovered from their possession. Investigation in the instant case is going on in full swing. More recoveries and arrests are expected in coming days.

## DB seeks report regarding facilities being provided to inmates at orphanages

JAMMU: A Division Bench of Jammu & Kashmir comprising Chief Justice Pankaj Mital and Justice Javed Iqbal Wani directed respondents to give complete details regarding all facilities that are being provided to inmates within a period of one month. When the PIL came up for hearing, Dy AG filed status report dated 16.11.2021 pursuant to Court's order dated 17.08.2021. DB observed that report simply states that there are 98 Orphan Homes within the Union Territory and total number of inmates enrolled therein is 3,211. However, the actual number of inmates is 1,865. Apart from giving above statistics, the report was completely silent in respect of other facilities required in orphanage. The respondents ought to have submitted a holistic report containing complete details of hygienic conditions, washrooms, quality of food, medical facilities and vocational activities, if any, provided in those orphanages. DB expected that a better and a complete report in this regard shall be filed by respondents giving complete details regarding all facilities that are being provided to inmates, within a period of one month.

## 4 drug peddlers arrested; contraband recovered


As per details, a party of Police Station Vilgam at a checkpoint established at Champora crossing intercepted 3 persons in suspicious condition. On search, 80 grams Charas like substance was recovered from their possession. They have been identified as Waseem Ahmad Mochi son of Ab Razak resident of Kralpora Khargund, Mohd Sultan Hajam son of Gh Qadir resident of Sherkoot and Talib Ahmad Sheikh son of Farooq Ahmad resident of Amargad. They have been arrested and shifted to police station where they remained in custody.

Meanwhile in another action, a police party of Police Station Vilgam at a checkpoint established near Dolipora and arrested a drug peddler identified as Ajiaz Ahmad Mochi son of Ab Khalil resident of Taratpura. During checking, 70 gm Charas like substance was recovered from his possession. He was shifted to police station where he remained in custody. Accordingly, cases under relevant sections of law were registered in Police Station Vilgam and investigation has been initiated.

## Inter-state gang of carjackers busted; 4 arrested, 11 vehicles recovered

BUDGAM: Police on Wednesday busted gang of interstate carjackers by arresting 4 persons involved in commission of crime.



As per details, acting on specific information, Police Station Khasa hib Budgam busted a gang of inter-state carjackers/thieves and arrested 4 persons involved in the sale and purchase of stolen vehicles. The modus operandi of the arrested gang has been to smuggle the stolen vehicles from other states with fake and forged documents and selling the same to the locals at quite cheaper rates.

Accordingly, FIR No. 112/2022 under relevant sections of the law has been registered at Police Station Khansahib and investigation initiated. During the course of investigation, Police raided several locations and recovered 11 stolen vehicles having forged registration numbers and documents, which included 3 Maruti Swift cars, 2 Alto K-10 cars, 2 Alto 800 cars, a Maruti Baleno, a Hyundai Verna and a Hyundai Santro. The accused were identified as Arshid Ahmad Ganie resident of Katich Razgar, Muneer Ahmad Ganie resident of Khan Sahib, Mohd Shafi Dar resident of Razwan and Tanveer Ahmad Paray resident of Hawoora. Investigations are going on and further arrests are expected in the case.

## Army rescues trucker, helper after accident

As per details, at 7:00 PM, an oil tanker (RJ31GB1326) moving from Srinagar to Bhatinda slipped off the road and collided with side rails of road at KM 24 on Mughal road.
