Bhavesh Bhai Thakur, Senior Bajrang Dal functionary from Gujarat was also accompanying the Yatra.

Referring to Prime Minister Narendra Modi's invocation of "Azadi Ka Amrit Mahotsav" Dr Jitendra Singh said, the next 25 years are critical for India because these will be the years of ascent of India's ascent in the global arena.

Therefore, the current lot of IAS officers is privileged because they have the time on their side and also the opportunity to devote the next 25 years of active service to realise the dream of Century India, he said.

Reiterating that every training module for the cur-

## TAD issues selection list of Top 20 meritorious students

SRINAGAR: Tribal Affairs Department (TAD) has issued a selection list under Top 20 meritorious scheme on Friday. Earlier in the month the department launched the scheme which aims to felicitate the top 20 students who have passed matriculation examination during the session 2021-22. Desirous students were asked to apply under the scheme with relevant details for consideration.

Secretary, Tribal Affairs Department Dr. Shahid Iqbal Choudhary informed that a total number of 184 students were shortlisted by the department from hundreds of applications received through portal. After proper scrutiny and evaluation a total number of 22 tribal students have been selected under Top 20 scheme since there was tie among three students at 20th spot. The scheme is being implemented through the Education wing of the Tribal Research Institute.

The cut-off point in today's select list was declared as 96 % with 14 girl students figuring in the list of total 22 students, an official informed.

The selected students shall be felicitated in an impressive ceremony scheduled to be held soon. As per the guidelines of the scheme these students shall be provided a laptop worth Rs. 50,000/ and Scholarship upto Rs. 25,000/ shall be provided to each student.

Pertinent to mention here, the department has for the first time initiated an exercise to assess the state of education viz a viz tribal students, literacy levels prevalent among the tribal population, and based on such surveys development of a comprehensive education plan to address specific educational needs of the tribal students.

## Candidate for compassionate appointment has no right over a particular post: DB

JAMMU: A Division Bench of Jammu & Kashmir and Ladakh High Court comprising Justice Tashi Rabstan and Justice Wasim Sadiq Nargal, held that once a candidate had accepted compassionate appointment and joined on a respective post, he at a later stage, cannot claim that he ought to have been appointed on a higher post.

DB further said that an applicant has no right to claim compassionate appointment in a particular class or group. "It is not for conferring status on family. A candidate for compassionate appointment has no right to any particular post of choice. He can only claim to be considered. The compas-

sionate appointment is not a vested right or an alternate mode of employment. It has to be considered and granted under the relevant rules. The object of compassionate appointment is to enable the family of the deceased employee to tide over sudden financial crisis due to the death of a bread-earner which has left family without any means of livelihood. The basic intent to grant compassionate appointment is that on death of employee, his family is not deprived of means of livelihood. It is meant to provide minimum relief for meeting immediate hardship to save bereaved family from sudden financial crises due to death of a sole bread-earner," the Court observed. DB while dis-

missing a LPA, observed that Apex Court has specifically held that the norms prevailing on date of consideration of the application, should be basis for consideration of claim for compassionate appointment. In present case, a reference to the relevant rules, which were enforced during 2009 to 2013, clearly revealed that entitlement of a candidate to seek appointment on compassionate grounds was only to the post in the lowest rank of the non-gazetted service, subject to the fulfillment of the qualification criteria. Thus, case of writ petitioners do not fall within amended provisions of SRO-43, which were brought into effect vide SRO 177 dated June 20, 2014, the Court observed.

## Damages, water-logging due to rains proved failure of UT Admn, JMC: Sawhney

### Seeks resignation of Mayor, Deputy Mayor

JAMMU: To discuss issue of immense damages and water-logging caused in various parts of Jammu city and complete failure of JMC and J&K administration in handling the situation, former Minister J&K Yogesh Sawhney General Secretary PCC, while speaking during a Press Conference, accused Jammu Municipal Corporation of total failure this time in handling the situation, stating that the Corporation was not prepared in advance for something that happens every year and therefore a lot of damages were caused, which could have been prevented. "As it is a massive failure of Jammu Municipal Corporation, Congress demands resigna-

tion of Mayor and the Deputy Mayor from their posts," said Sawhney, urging LG to sack Mayor and Deputy Mayor.

During the press conference, the congress leader also briefly commented on Smriti Irani row stating that BJP Minister should first look in the mirror before saying anything against Congress President. He further conveyed condolences to bereaved families of two pilots, one of whom belonged to R S Pura and who lost their lives in IAF's MiG-21 crash at Barmer district, calling it a 'great loss and a most unfortunate incident'.

He further asked UT administration and JMC to take responsibility for the havoc caused in Jammu city

besides initiating compensatory and rehabilitation actions at the earliest. He also urged BJP government at the center to stop their 'Jumlas and Scams' like Smart city scheme, which he called as publicity stunts and not developmental mission, as proved during recent rains. Sawhney said that failure of BJP on all levels is quite clear and demanded immediate remedial steps for compensating the losses, which Jammu people have suffered.

Others senior leaders present on the occasion included Sahil Sharma Spokesperson JKPC, Dr Ramakant Khajuria Vice President DCC, Uttam Singh Chib Ex-Councilor JMC and Arif Malik.

## Amarnath Yatra: Chhari Mubarak reaches Sharika Bhawani temple

### Batch of 835 pilgrims leaves Jammu for cave shrine

SRINAGAR: Chhari-Mubarak -- the saffron-robed holy mace of Lord Shiva -- was Friday taken to the ancient Sharika-Bhawani Temple here for special prayers as part of the ongoing annual Amarnath Yatra.

In connection with annual Swami Amarnath Ji Yatra-2022, Chhari-Mubarak Swami Amarnath Ji was taken to Ancient Sharika-Bhawani Temple, Hari Parbat to pay obeisance to the Goddess on the occasion of Shravan Shukla Paksha Pratipada as per the age-old traditions, the custodian of the mace, Mahant Deependra Giri said.

Sizable number of Sadhus and devotees participated in the prayers that lasted for about 90 minutes, he said.

Goddess Sharika-Bhawani popularly known as 'Tripursundari' amongst the mystics, is believed to be Isht Devi (Presiding Deity) of the Srinagar city who manifested herself in a figure of Shila (Holy Rock) at Hari-Parbat.

Giri said the Chhari-Sthapana ceremony shall be performed on Sunday at Shri Amareshwar Temple Akhara Building Budshah Chowk here, while the traditional Chhari-Pujan shall be performed on the occasion of Nag-Panchami on August 2.

The traditional Pujan and rituals will be performed on the auspicious occasion of Shravan-Purnima on August 12, concluding the annual yatra.

Meanwhile, a batch of 835 Amarnath pilgrims, the smallest so far this year, left the Bhagwati Nagar base camp here this morning for the twin base camps in Kashmir, officials said.

The pilgrims left the Bhagwati Nagar Yatri Nivas in a convoy of 35 vehicles amid heavy security of the Central Reserve Police Force (CRPF) in the morning, they said.

The officials said 306 pilgrims heading for Baltal were the first to leave the Jammu camp in 16 vehicles, followed by

the second convoy of 19 vehicles carrying 529 pilgrims for Pahalgam.

The number of pilgrims visiting the cave shrine has fallen drastically in the last three days mostly due to bad weather conditions, they said. While 3,862 pilgrims left for the cave shrine from Jammu on Monday, 2,189, 1,147 and 1,602 devotees left for Amarnath from here on Tuesday, Wednesday and Thursday, respectively. Till Thursday, a total of over 2.70 lakh pilgrims had offered their prayers at the cave shrine, housing the naturally formed Ice-Shivlingam, the officials said. With this, a total of 141,358 pilgrims have left from the Bhagwati Nagar base camp for the Valley since June 29, the day the first batch of pilgrims was flagged off by Lt Governor Manoj Sinha.

A total of 36 people, mostly pilgrims, have died during the ongoing Amarnath Yatra. Additionally, 15 pilgrims died in the flash floods at the Amarnath cave shrine on July 1.
