Bail denied to husband in abetment to suicide case**STATE TIMES NEWS**

JAMMU: City Judge /JMIC Jammu Manjeet Rai has rejected bail application of one Naresh Kumar, son of Panch Ram, resident of Gole Gujral road, Talab Tillo, Jammu booked under FIR 199/2022 under section 306 of IPC registered at Police Station Domana.

The applicant, through his Adv S K Sharma, submitted that he is a labourer and has no criminal background besides commanding a good reputation in the society. He further pleaded that he has been implicated in a false and frivolous case. The applicant submitted that he has not committed any offence. Applicant further said that he shall abide by all terms and conditions of the Court, in case he is granted bail and further submitted that he is ready to undertake that he will neither jump over bail nor affect prosecution witness.

The prosecution through Arvind Rathore, APP submitted that accused, despite being a husband intended to push victim, his wife into such a position, which forced her to commit suicide seeing no other option left. As such, accused is not innocent and has been booked under section 306 of IPC. Prosecution further said that victim, a young woman and mother of three daughters, was forced to commit suicide as accused/ husband used to harass her alleging that she was characterless. Prosecution said that keeping in view gravity of accusation, nature of evidence available and severity of punishment, which extended to ten years imprisonment, the bail plea should be rejected. The City Judge/JMIC, after hearing both the sides, held that accused is alleged to have committed the offence under section 306 of IPC which is non-bailable and serious in nature, as such, the accused cannot claim bail as a matter of right and rejected the plea.
