

Div Com Jammu reviews Eid-ul-Adha arrangements

JAMMU: Divisional Commissioner Jammu, Ramesh Kumar on Saturday convened a meeting of concerned officers and civil society members to review the arrangements for Eid-ul-Adha festival.

Commissioner JMC, Rahul Yadav; SSP Jammu Chandan Kohli; Director FCS &CA, chief Engineers of PWD, JPDCL, Jal Shakti, besides senior officers of Sheep Husbandry, traffic, Health, Fire services, food safety, AUQAF, Imams, presidents of Masjid committees and civil society members were present in the meeting.

The Divisional Commissioner directed JPDCL and Jal Shakti Departments to ensure uninterrupted power and water supply on Eid-ul-

Adha, while civic authorities were asked to maintain cleanliness in and around

the Eidgah and mosques.

He directed enforcement departments to keep check on the rates and quality of essential commodities and book those indulging in overpricing and other unfair trade practices. "Conduct intensive market checking and enforce display of rate lists notified by the government for information of the general public" he directed the concerned authorities.

The Health department was directed to make available health care services at the venues of congregation-

al prayers and during the festival to meet any emergency.

The Div Com exhorted upon the police and traffic department to put in place adequate security arrangements around the mosques and ensure traffic management to avoid any inconvenience to the visitors.

The Div Com stressed on maintaining close coordination among different departments and Auqaf and Masjid Committees for smooth celebration of the festival.

The JMC was asked to

ensure better sanitation and functioning of the street lights, while PWD was asked to start filling of potholes, if any, on the city roads and approach roads to the mosques.

Meanwhile, the Divisional Commissioner reviewed the arrangements being put in place for celebration of Eid-ul-Adha in all the districts of the division.

The Deputy Commissioners along with SSPs of Jammu division participated in the meeting through video conferencing.

The Div Com instructed DCs to ensure that all necessary arrangements are in place for smooth celebration of Eid-ul-Adha at district and tehsil levels. He also asked the Director Food Civil Supplies and Consumer Affairs to ensure adequate stock of essentials in the districts during the festival.

For and on behalf of the Hon'ble Lieutenant Governor, UT of J&K, e-tenders are invited from registered, reputed and resourceful Contractors/Firms registered with Jammu & Kashmir Govt./Central Govt. Organizations for the following works:

Name of the Work: -Plantation works in different (already fenced) units under Rehabilitation of Degraded Forests (RDFs)/Village Wood Lots (VWLs)/Strip component by way of planting of different species of plants raised in Nurseries as Polybagged Plants (Conifer/Broadleaved) or as Naked Root Plants (like Poplar, Robinia etc.) in the pits of standard size along with other associated operations as per site conditions like construction of water harvesting structures around/alongside each plant, ramming of soil etc. including extraction and carriage/lifting of plants from nurseries by mechanical transport (loading & unloading included) & head load carriage up to the site of the work.

Basic Information about the items of works to be executed:

- Planting work is absolutely a weather dependent and season linked activity which must be taken up within the suitable weather conditions. If the planting is not done within the suitable time period, it may have serious effect on the survival and growth of plants. Therefore, Contractor will have to be careful and ensure that work of pitting, plant procurement and planting is completed within stipulated time period as any delay can lead to adverse effect on the quality of work and overall survival. Contractor, thus, will have to ensure that work is completed within a span of one month from the date of allotment of work and delay whatsoever shall be avoided by all means by the Contractor. Any violation in this regard would warrant action for violation of terms and conditions of the contract.
- Bidder is advised to visit and examine the site, its surroundings and familiarize himself with the existing facilities and working environment, and collect all other supporting information which he may require for preparing and submitting the bid and entering into the Contract with SFD.
- Plantations shall be carried out in already fenced units.
- The plantation Sites/pockets inside the unit shall be identified by the staff of the department in the company of the contractor/ his representative & thereafter pitting work will be started.
- Before carrying out plantation work, cleaning of unwanted bushes from the plantation sites would be taken wherever required.
- Planting shall be carried out in pits of sizes 45x45x45cm.
- The plantation is an activity which involves knowledge of various technical aspects and thus shall be carried out by the labour under the close supervision of the staff of the department.
- The sapling will be of two types:-
 - Bagged Plants which are raised in poly bags & transported in baskets, carefully.
 - Naked Root plants which are without poly bags and are extracted and transported in small bundles.
- In certain cases, underground rhizome, seeds/fruit are also used for sowing activities as part of afforestation work.
- The plants & other planting material like seeds, fruits, rhizomes shall be made available by the field staff of the department from departmental nurseries/ SFRI Nurseries located at different locations. However he carriage and extraction charges will be born by the contractor/successful bidder.
- The plants shall be transported through mechanical/headload to the plantation sites as mentioned in the Particulars of Work. The carriage and extraction charges will be born by the contractor/successful bidder.
- Utmost care shall be taken while transporting/loading/unloading of plants to avoid injury/damage.
- Before, plantation, the labour engaged shall be demonstrated by the field staff of the department for carrying out plantation and exercising various DOS and DON'Ts for successful execution of works.
- The contractor will use only those plants which are healthy and viable and thus he is supposed to carry out this activity as per the guide lines / directions of the field staff of the department.
- Insecticides/pesticides shall be used in areas prone to termite/insect/fungal attacks.
- The undersized pits which are dug at wrong locations like under a tree/on rocky soil shall be rejected by the concerned staff & no payment for this type of work will be made.
- While planting bagged plants, the poly bags shall be cut with the help of a blade and plant with ball of earth shall be placed inside the pit with utmost care, so that the ball of earth shall not be broken/ disturbed.
- Proper ramming shall be done after planting and a stick shall be fixed with each plant, so that it remains erect.
- A small bund of soil shall be made along the side of slope to retain the rain water for the plant.
- After completion, the work shall be inspected by the Officials of the Social Forestry Department (not below the rank of Range-Officer) accompanied by the contractor / Members of the concerned VPPC and accordingly the bills shall be prepared after a satisfactory level of performance is certified.

- The planting stocks (saplings raised in poly bags/naked root plant) shall be transported from the nursery, adopting due care and precaution in loading, unloading, transportation, upto the planting locations.
- The sapling shall be planted in pits, properly rammed & supported with stick of appropriate size wherever needed to maintain erectness of the sapling after its transplanting
- The plants will be provided from departmental/SFRI Nurseries Jammu/Srinagar. The carriage and extraction charges will be born by the contractor.
