**CRIME REPORT****Sadhu attacks other with sharp-edged weapon****STATE TIMES NEWS**

**KATRA:** A Sadhu attacked another Sadhu with a sharp-edged weapon over a minor issue in Katra on Monday.

As per details, a complaint was lodged at Police Station Bus stand by legal heirs of a girl stating that she went missing




