Executive Engineer, IT&C Division, JPDCCL, Jammu (hereinafter referred to as "the Employer") for and on behalf of Managing Director, Jammu Power Distribution Corporation Limited invites e-bids from experienced Contractors/Companies/Firms for "Renovation of Data Recovery Centre building by way of aluminum partition at Gladni Narwal JPDCCL Jammu".

**1. SCOPE OF CONTRACT:-**

With the addition of IT infrastructure corresponding to smart metering, the support staff of the vendor has been stationed at DRC, Gladni, Jammu. In order to make sitting arrangement for the support staff and associated equipment/hardware, renovation of Data Recovery Centre building by way of aluminum partition is required. Hence, this tender has been framed.
