Bike lifters' gang busted; 3 arrested, 6 two-wheelers recovered**STATE TIMES NEWS**

KATHUA: Police on Friday busted a gang of bike lifters by arresting three accused and recovered 6 two-wheelers on their disclosure. As per details, a complaint was filed by one Vishal Kumar, son of Bhishamber Dass, resident of Kanthal Bani at Police Station Bani regarding theft of his motorcycle (JK08J).

On this, FIR No 47/2022 under sections 379, 34 of IPC was registered and a team, under supervision of SDPO Basohli, Shazia A Mir was constituted. The team led by SHO Bani Insp Shahnawaz Giri, after putting in strenuous efforts, arrested three accused who were identified as Mohd Arif, son of Matasab Ali; Amir Khan, son of Mohd Sheen; both residents of Surjan Tehsil Bani, Kathua and Tanveer Ahmed, son of Nazir Ahmed, resident of Bani Kathua. During questioning, accused confessed their involvement in crime and on their disclosure six stolen two-wheelers were recovered from their possession, which included Discover chassis no. MD2A64CZ8FBR0957; Pulsar chassis no. MD2A12DZXC4074; Passion Pro chassis no. MBLAA10A6EGA01141; Discover 125 chassis no. MD2A15DBZ5FWJ34738; Pulsar 180 JK08J7024 Chassis no. MD2A12DY3KCM18296 and Motorev3 Super Splendor 125, bearing registration no. P83D1159 and Chassis no 07JAEEF16738. The modus operandi of the thieves was that they used to steal two-wheelers from different areas and thereafter sell them for meager amounts.

Narco smuggler nabbed with Ganja**STATE TIMES NEWS**

JAMMU: Continuing its drive against drug trafficking and substance abuse, police on Friday arrested a narco smuggler near Sec-3, Model Town Gangyal and recovered 900 gm Ganja from his possession. As per details, a team from Police Station Gangyal led by SHO Gangyal Inspector Joginder Singh Chib assisted by ASI Jamal Din, while on Naka duty near Modern town area, rounded up a suspect carrying a plastic bag.

On search 900 gm Ganja was recovered from his possession. The accused, identified as Rajesh Kumar, son of Kanaiya Prashad, resident of UP, at present Model town Gangyal was arrested and FIR No 76/22 under sections 8/20 of NDPS Act was registered at Police Station Gangyal. The overall arrest and recoveries were made under supervision of SDPO South Sachit Sharma.

SHRADHANJALI


Shri D P Sharma, son of Late Shri B P Sharma was born on July 4, 1943 at Jammu. He had two brothers and two sisters.

2 drug peddlers arrested, contraband recovered**STATE TIMES NEWS**

SRINAGAR: Continuing its efforts to eradicate menace of drugs, police on Friday arrested two drug peddlers in Baramulla & Awantipora and recovered contraband substance from their possession.

As per details, a party from Police Station Kreeri and Police Post Wagora under the supervision of SDPO Kreeri Dr. Khalid Ashraf arrested a woman drug peddler during routine Naka checking at Wagoora, Baramulla. During search, 250 gm Charas like substance was recovered from her possession. She was shifted to police station where she remained in custody. She was accompanied by her spouse, but he managed to flee from spot due to darkness, however efforts are on to nab him. Accordingly, a case under relevant sections of law was registered in Police Station Kreeri and investigation set into motion.

Moreover in Awantipora, acting on specific information, a police party led by SHO Police Station Awantipora under supervision of SDPO Awantipora Mumtaz Ali Bhatti intercepted a vehicle (Tata Mobile) bearing registration number JK01AQ-2989 driven by one Mohd Amin Wani, son of Abdul Gani Wani, resident of Takiya Ahmadshah, Bandipora. During checking, officers recovered 5.1 Kg Charas like substance from the vehicle. The accused driver was arrested and shifted to police station where he remained in custody. Vehicle used in the commission of crime was also seized. Accordingly, FIR No. 157/2022 under relevant sections of law was registered at Police Station Awantipora and investigation initiated.

Man arrested on suspicion basis**STATE TIMES NEWS**

SAMBAL: Alert Jawans of 158 battalion of Army and Police on Friday evening nabbed a man on suspicion basis near Nonath Ashram, who was roaming around a Langar set-up for Amarnath pilgrims.

The person was identified as Praveen Choudhary, son of Din Mohammad, resident of Sumbal, Samba. As per reports, he was doing Reiki around Langar and when security forces signaled him to stop, he tried to flee from but was caught by alert personnel. During questioning, he failed to give satisfactory answer, after
