

He breathed his last on 3rd July, 2023 due to cardiac arrest. He is survived by his wife, son, daughter and a grandson.





**District level workshop on U- WIN & IMI 5.0 held**

**DODA:** A one day district level workshop cum training of staff to scale up the U- WIN and Intensified Mission Indradhanush (IMI) 5.0 was today organized by the Family Welfare Department in the District Training Centre Khellani Doda.

The workshop cum training was held under the supervision of Dy Chief Medical Officer, Dr Om Kumar Bhagat and was attended by District Immunization Officer, Dr Versha Sharma; Block Medical Officers (All), Medical Officers, DAC, DMEIO Doda, VCCM; DMO NHM, BACs, LHVs, JHIs, Ext. Educators, Incharge BVSS, DEOs and Vaccinators of the District.

The Dy. CMO, in his keynote address, said that the Government of India has launched special campaigns to ensure health and safety for all citizens by promoting universal & equitable access to basic and essential services.

He said MOHFW's plan was to build a third pillar based on existing eVIN and CoWIN platform for digitalizing the routine immunization services in the country through the U-

WIN portal, a digital solution to facilitate tracking of every pregnant woman, new born child and adolescent for vaccination.

DIO Doda, Dr. Versha Sharma while addressing the gathering said that though this new platform U-WIN, citizens will be able to check nearly ongoing routine immunization sessions and book appointment, where beneficiaries would be able to plan & book slot for vaccination in advance as well as avail on spot registration and vaccination services. Meanwhile training on Intensified Mission Indradhanush (IMI) 5.0 was given to the participants about IMI which will commence in J&K in three rounds starting from 7th August 2023.

The participants were educated about IMI 5.0, which is a vaccination programme aimed to cover the left out childrens and pregnant womens.

State Trainer UNDP, Shiv Kumar was the Master Trainer who imparted the training to the participants about U-WIN and IMI 5.0 and presented a detailed presentation on different modules of U-WIN.

**Mir visits affected areas, seeks appropriate compensation to affected people**

**SRINAGAR:** Congress on Sunday expressed Serious concern over the losses caused to residential houses and paddy fields due to cloud burst and incessant rains during past three days in J&K and sought appropriate compensation in favour of affected people.

Former President of J&K Pradesh Congress Ghulam Ahmad Mir on Sunday urged the Govt to evaluate the losses for compensation in favour of affected people, on priority basis. Ghulam Ahmad Mir during his day long tour visited Khahdar, Kapan, Trajan, Thaman and Chowgund in Block Shahabad Bala of Dooru segment of South Kashmir to take stock of the people's grievances especially the current losses caused due to cloud bursts and incessant rains to residential houses, Paddy fields and other crops in these affected areas. He also met a series of local delegations who apprised him about the level of losses they have suffered due to cloud bursts in their respective areas and sought immediate help from the Govt.

Mir expressed dismay over the losses and urged upon the Govt to dispatch a team of experts to affected areas to evaluate the damages for release of compensation to affected people, on priority basis.

Former JKPCC President further expressed serious concern over the losses in different areas in Jammu and elsewhere in Kashmir while demanding that the process of compensation must be started at the earliest to ensure respite to affected people.
