"It is submitted that the defining characteristic of the security situation in the region, which has a direct bearing on the day-to-day life of common citizens is 'street violence' which was a methodical and regular phenomenon. The street violence, engineered and orchestrated by terrorists and secessionist networks has now become thing of the past. The organized stone pelting incidents connected with terrorism-separatist agenda, which were as high as 1,767 in the year 2018 has come down to zero in the year 2023 till date," the Centre said in its 20-page affidavit.

It added that bandhs' and stone pelting had resulted in closure of schools, colleges and universities, trade, industries and businesses on a regular basis intermittently, leading to severe loss of income especially of the poor and those who worked in unorganized sec-

"In the year 2018, there were 52 incidents of organized Bandh/Hartal', which have come down to zero in the year 2023 till date. In addition, resolute anti-terror actions have resulted in dismantling of the terror eco-system which is reflected in a significant

drop in terrorist recruitment from 199 in the year 2018 to 12 in the year 2023 till date. The Centre said work on transit accommodation for Kashmiri Pandits for their safe return to the valley is in the advanced stage and is expected to be majorly completed in the next one year.

Highlighting numerous schemes launched by the Centre for the development of the entire region, the government said life has returned to normalcy in the region after over three decades of turmoil.

"It is submitted that schools, colleges, universities, hospitals and other public institutions are functioning efficiently without any strikes or any kind of disturbances during the last three years. The earlier practice of daily hartals, strikes, stone pelting and bandhs are things of the past now," it added.

Emphasising that certain sections of the society, including displaced persons from Pakistan Occupied Jammu and Kashmir and children of women married outside J&K, were earlier deprived of their basic rights prior to the August 5,2019 decision, the government said all the residents of the region are enjoying all rights which are available to citizens in other parts of the country. It said with the constitutional changes and enactments of the Jammu and Kashmir Reorganisation Act, 2019, seats have been reserved for the persons belonging to Scheduled Tribe, which has resulted in grant of reservation in Legislature to them similar to the reservation available to such community in Legislative Assemblies of other States/Union territories in the country.

"It is submitted that with the improved security scenario, the Union territory has also witnessed highest ever footfall of tourists viz. 1.88 crore tourists visited Jammu & Kashmir only during January 1, 2022 to December 31, 2022 which is significantly contributing to the growth of the economy and has a direct impact on the income of common man", the Centre highlighted.

The yatra has been suspended due to extensive damage caused to a section of the Jammu-Srinagar Highway in Ramban, with more than 7,000 stranded pilgrims in Jammu, primarily at the Bhagwati Nagar base camp, and an additional 5,000 stranded at the Chanderkot base camp in Ramban district.

Authorities said incessant rains on Saturday and Sunday caused unprecedented damage to the highway, especially a stretch in Ramban district, forcing its closure.

"Our spirits are high. We are willing to wait for ten more days if needed, but we refuse to return home without performing darshan of the ice-lingam of Lord Shiva at Amarnath," said Pramodh Gupta, a devotee from Punjab told PTI here.

Gupta added that despite facing challenges with accommodation and other their group of 29 is eagerly waiting for the administration's approval to resume their journey to Kashmir. Shobha Devi from Meerut echoed similar sentiments and expressed dissatisfaction with the facilities due to the heavy influx of pilgrims from outside the country. "We are facing various problems with accommodation. There is water shortage here and the administration should address the issue," she said.

However, Shobha added that she and her group would only return home after completing their pilgrimage. "We will leave only after completing the yatra to Amarnath. Barfani Baba will help us fulfill our wish," she affirmed.

"Weather conditions will not deter us from going to Amarnath. We pray to Lord Shiva to improve the weather so that we can start the yatra and have Bholey Baba's darshan,' said Meenakshi Verma, a devotee from Punjab.

Sunita Saini from Punjab's Jalandhar, who has been stranded in Jammu for the past five days, said, "We are waiting for the weather to clear up and the highway to reopen. We are optimistic about leaving for Amarnath."

There is a huge rush for accommodation in Jammu as most of 33 lodging places and the base camp is full to its capacity. Even the parking area of Jammu base camp is full with buses carrying pilgrims who are cooking food there. Around 200 to 300 sadhus are also camping at the base camp's Ram temple for the past one week.

DoB tampering: Pre...examination in the year 1981, as she had not then attained the eligible age of 17 years as on December 31, 1981.

It further transpires that she got her date of birth corrected from JK BOSE in the year 1981, whereby she got her new date of birth certificate, carrying date of birth as April 8, 1964. Based on this corrected date of birth certificate, she became eligible to appear in the MBBS entrance examination and she did appear and qualified the same and got selected for the said course. When she got admission in the GMC, Jammu for the MBBS course, she mentioned her age in the admission form as April 8, 1964. Same she has filled up in her own hand and signature on October 20, 1981. Later, after completing her MBBS course, she got appointed as Assistant Surgeon in the year 1988. At the time of her appointment, she then submitted Matric diploma, carrying her date of birth as April 8, 1965, as her age proof. Same has got mentioned on the first page of the service book, carrying her signature thereon which stands confirmed by the authority who attested the particulars on the first page, who was the then Chief Medical Officer, Health and Family Welfare, Jammu.

With this date of birth, she then continued her service career. Even in her declaration form submitted in the University of Jammu in the year 201617, she has mentioned her date of birth as April 8, 1965. So the allegation that she carried two date of birth certificates, which she has used conveniently at two different occasions for obtaining two different benefits -- the certificate based on 1964 date of birth she managed from JKBOSE and used for appearing in MBBS entrance examination and admission in the said course. But, when got appointed as Assistant Surgeon, then, with some different intentions, presented age proof based on the Matric Diploma carrying date of birth as 1965. The said controversy, relating to date of birth of the applicant, came to fore in 2021, when Crime Branch, Jammu, received a complaint in this regard from a person, namely, Manu Gupta, resident of Channi Himmat, Jammu. Pursuant to said complaint, a preliminary verification (PV) was initiated in the same year by the Crime Branch, Jammu. Finally, the allegations in the PV were found correct which led to the registration of an FIR57/2023 on July 1, 2023 against the accused.

Search warrant got issued by the Additional Judge, Anti Corruption, Court, Jammu, whereby searches were conducted in the office and the house of the accused. Some documentary evidence has been recovered which form part of the CD file

Special Judge Anticorruption Jammu Tahir Khurshid Raina observed that during the course of full length arguments on the instant application, I found a candid admission of facts by the counsel for the applicant that accused appeared in MBBS entrance examination in the year 1981 on the basis of the corrected date of birth as 08-04--1964 and based on it, she also got admission in MBBS course in GMC, Jammu. However, she mistakenly supplied her matriculation diploma at the time of appointment, carrying date of birth as 08-041965, an error at her part without any guilty intention.

So, prima facie, Court do not find any divergence of opinion on the allegations attributed to her by the prosecution that there are two date of births being carried by the applicant which she has used at two different stages of her career. However, after getting her appointment, she continued with her date of birth as 08-04-1965. Even in the year 2016, she in her declaration, submitted to Jammu University mention her date of birth as 08-04-1965. Not only to this context, but even in her reply to the questionnaire, put to her by the Crime Branch, Jammu, in the year, 2021, when the PV was going on, therein also she has categorically stated her date of birth as 08-04-1965. So based on these facts as revealed in the report and the CD file, there is no two opinion with regard to existence of two different date of births, conveniently used by the accused on two different occasions--one for getting admission in MBBS and second when got appointed as Assistant Surgeon. So the offence of fraud, forgery and misconduct under Prevention of Corruption Act, as pleaded by the APP, are prima facie made out.

In that context, the element of humiliation and unnecessary targeting of the accused. based on some fake and false complaint is absolutely ruled out and any such argument pleaded by the counsel for accused does not sustain at all.

Now, in this context, whether the offence alleged is a high gravity offence, one of the factor to be considered while deciding the anticipatory bail application. Fact remains that gravity of the offence is not to be gauged only in context of the punishment prescribed. Though, it is on a higher degree for the said offences, but in my appreciation, notwithstanding to the degree of punishment, it is more to be seen in context of the status and position of the person who is alleged to have committed the same, Court said.

Court further said that a doctor by profession, who happened to be earlier a teacher in the Medical College and presently at a high pedestal in the hierarchy is consciously continuing her alleged fraud, with two date of births certificates, using conveniently at different occasions, makes the alleged offence of high gravity. She, being the role model should not have even thought in her imagination which is alleged to have been done by her. Even she carries two pan cards, two driving licences with two different date of births. Even in LIC policies, her date of birth mentioned is 1964. So this is the conduct of the accused who is holding the coveted position of Principal Government Medical College. This speaks of her antecedents, another factor to be considered by the court while dealing with her prayer for grant of Pre-arrest bail.

During preliminary verification, a questionnaire was sent to her by the Crime Branch, Jammu on 09-05-2021, to know from her as what were the documents she submitted with the application form for admission in the MBBS, also copies of the said documents were sought from her

In her reply, she stated that she did not remember and the documents must have been attached with the form. However, it was astonishing to note that when the investigating agency raided at her residence, there it found the original admission file of her can rying no age proof attached with it. How come she was having the custody of the original admission file of her which dates back to 1981, supposed to be in the concerned admission section of the college. Why only the age proof is missing from it when it is the foundational document on the basis of which she claimed her eligibility and later got admission in the MBBS course. So obviously, she by misusing her position as Principal, managed to get the old file and then either has destroyed the document or is in her custody. Apart, keeping the admission file with her, carrying no age proof with it, simply speaks that she was not sure about the genuinety of her age proof as 08-04-1964, on the basis of which she has got eligibility to appear in MBBS entrance examination and later admission in MBBS course in the year 1981. Astonishingly, after getting appointment, she continuously sticked to her original date of birth as 08-04-1965. This is an important issue which is very pertinently raised by the prosecution to be considered by the court while deciding the instant application.

Her complete refusal to Crime Branch to respond on this issue as it is a 40 year old matter and on the other hand managed to get admission file from the section, which now carries no age proof of her, sufficiently sustains the doubt about the genuinety of second date of birth certificate carrying the date of birth as 08-04-1964. It is the said document on which the edifice of her whole career rests, genuinety of which apparently has of course been put into doubt by none else but by her own conduct, hence a fact inevitably needs to be investigated meticulously.

In addition, by refusing to respond fairly to Crime Branch and keeping the admission file in her custody speaks of her influence, potential and tendency to tamper with the evidence, who instead of cooperating with the investigating agency as a bonafide public servant even fled away and was not available at her office or home when the investigating agency raided at both the places.

With these observations, the Court observed that at the outset, the order granting or refusing bail must reflect a fine balance between the two conflicting interests i.e, sanctity of individual liberty and the demand of effective, perfect and fair investigation by the police. When seen in context of facts, as put in the preceding paras, Court don't find any justification left to this court to sustain the plea of pre-arrest bail to be granted to the accused. Consequently, the interim bail, granted vide order dated 06-07-2023 is not being extended further.

NH closed for...

The highway was closed for vehicular traffic on Saturday following incessant rains that triggered multiple landslides and also severely damaged a portion of the road near Panthiyal Tunnel and Chamba-Seeri in Ramban district, leaving thousands of vehicles

"Barring the Chamba-Seeri stretch where a 60-metre strip of road was washed away, the highway is almost clear of all hurdles and is traffic-worthy," a traffic department

He said the National Highway Authority of India (NHAI) is working round-the-clock at Chamba-Seeri and is working on an alternate alignment to ensure early restoration of the road.

"The restoration work will take some time. The stranded vehicles will be cleared on priority once the road is made motorable," the official said.

However, no fresh traffic will be allowed either from Jammu or Srinagar till the clear ance of the stranded vehicles, he added.

A police spokesperson advised people to avoid travelling on the highway till the time confirmation is issued by the administration. "Incessant rains, over the last few days in various parts of Jammu and Kashmir, have caused unprecedented damage to NH-44, especially the stretch in Ramban district, forcing its closure for traffic," the pokesperson said. He said drivers of heavy motor vehicles are advised to take Mughal Road for the journey from Jammu to Srinagar and vice-versa. "The administration is making its best possible efforts to ensure the restoration of traffic on the national highway at the earliest," the spokesperson said. According to traffic officials, the Mughal Road -- an alternate link connecting the twin border districts of Poonch and Rajouri in Jammu with the south Kashmir Shopian district -- was through for both-way traffic.
