# Public Notice

While scrutinizing commercial passenger vehicles for different outstanding to be paid by the registered owners of the vehicles on account of Token Tax, Renewal of Fitness and Renewal of Permit fee besides renewal of all the documents including insurance of the vehicles and Pollution Under Control Certificates, it has been found in the VAHAN portal software that vehicles owners have not paid their requisite fees prior to June, 2023 on account of Token Tax/Fitness fee/ Permit fee for renewal of documents, which are mandatory as per various provisions of Motor Vehicle Act and rules thereunder.
