CRIME REPORT

Notorious criminal arrested with sharp edged weapon

RS PURA: Police on Friday arrested a notorious criminal with one sharp edged weapon.
As per details, a team of Police Station R S Pura led by SDPO RS Pura Nikhil Gogna assisted by SHO RS Pura Inspr Pawan Kumar and ASI Jung Bahadur while on Naka duty at GB resort near canal, Khana Chak received the information regarding a notorious criminal coming in a vehicle (JK02BA-2174). On this police teams stopped the vehicle for frisking. During search one sharp edged weapon was recovered from the accused later identified as Sandeep Kumar alias Chotu, son of Tarsem Lal, resident of Chak Askam Tehsil R.S Pura District Jammu. He was arrested and FIR No.102/2023 under section 4/25 Arms Act was registered at Police Station RS Pura.



23 vehicles involved in illegal mining seized

JAMMU/POONCH: In a quest to stern the menace of illegal mining, a multi-pronged strategy was devised by Jammu Police in which police teams of Police Stations Nagrota, Miran Sahib, Akhnoor, Police Posts Rehari, Chatha and Phallian Mandal acted stringently on the specific inputs and raided at a location in their respective area and seized 14 vehicles involved in illegal mining.
The seized vehicles include 04 vehicles i.e Two tractor trollies without Registration No, one Dumper bearing Registration number JK21J0857 and one tipper bearing Registration no. JK02CX3431 seized by Nagrota Police; One Tractor bearing Registration no JK02AX1018, by Miran Sahib Police; One Tipper (JK02CC 9723) by Akhnoor Police; 2 vehicles i.e One Dumper bearing Registration number

JK02C7295 and one tipper bearing Registration No by Rehari Police; 2 vehicles i.e One Excavator without Registration No and one Dumper bearing Registration no. JK02BB-8101, by Chatha Police and 4 vehicles i.e One JCB without Registration No and Three Tractor Trolley without Registration Nos by Phallian Mandal Police.

The recoveries were made by SHO Nagrota Inspr Vishav Pratap Singh, SHO Miran Sahib Inspr Bopinder Singh, SHO Akhnoor Inspr Zaheer Mushtaq, In-Charge Police Posts Rehari PSI Anil Kumar and Chatha-PSI Harjinder Paul Singh, Phallian Mandal-PSI Ajesh Singh Jamwal in their respective jurisdiction.

Meanwhile, on the direction of Deputy Commissioner Poonch, Yasin M Choudhary, Department of Mining, in the presence of DMO Poonch, Javid Iqbal, seized nine vehicles involved in illegal mining and lifting of raw material without a valid e-challan in different parts of Poonch district.

The vehicles were seized three from Kalai, two from Drungli, three from Jhullas, and one Chandimarh, and were later handed over to the police for safe custody. Additionally, the Department of Mining also dismantled a path used by the mining mafia for illegal mining.

Three missing person traced; reunited with families

JAMMU: Police on Friday traced three missing person and reunited them with their families.

As per details, Two different complaints were lodged at Police Station Akhnoor, by the legal heirs of one girl and one lady, stating that they got missing from their respective home. In this regard two missing reports on June 24, 2023 of missing girl and on July 10, 2023 of missing lady respectively were registered and investigation got started.

On this, a team of Police Station Akhnoor formed under the supervision of SDPO Akhnoor Mohan Lal and led by SHO Akhnoor Inspr. Zaheer Mushtaq did hectic efforts and traced both the missing lady and missing girl.

Similarly, another complaint was lodged at Police Post Chowk Chabutra by the legal heirs of a girl stating that she got missing from her home.

In this regard a missing report was registered on March 8, 2023 and investigation started. On this, a team of Police Post Chowk Chabutra formed under the supervision of SDPO North Sunil Kumar Kesar led by SHO Paeca Danga Inspr Sushil Kumar assisted by In-Charge Police Post Chowk Chabutra PSI Anil Kumar did strenuous efforts and finally traced the missing girl from Bhogaon, Mainpuri, UP.

Subsequently family of all the missing persons were informed and the traced person's were handed over to their family members after completing all the legal formalities.

2 drug peddlers arrested; contraband recovered
